Elyson continues to grow in NW Harris County

The Elyson master planned community near the intersection of FM 529 and The Grand Parkway continues to grow in 2021 according to Newland Communities Representative Heather Gustafson. Gustafson said in a statement released on behalf of the company that expansion on the north side of FM 529 has begun.

“This growth will include a new model home village with 12 fully furnished model homes, a new welcome center, and a greenspace where visitors can relax and discuss their home buying plans. This will open in March,” Gustafson said.

Observers welcome quiet opening to TX Legislature

At the Texas State Capitol, a variety of legislative agendas took center stage at the start of the 87th session, which will run 140 days. Gov. Greg Abbott’s goals include ensuring Texans have access to high-quality healthcare, improving public safety, getting Texans back to work and promoting economic recovery.

Many other state organizations announced their agendas, too:

- The Texas Farm Bureau outlined 11 priorities, starting with protecting property owners’ rights under eminent domain. Other priorities include protecting landowners and agricultural producers’ rights to surface water and groundwater; adding measures to control feral hogs; and supporting efforts

to install broadband and cellular infrastructure in rural communities.

- Raise Your Hand Texas wants public dollars to remain in public schools. Some policy recommendations include protecting investments made in 2019’s House Bill 3, including funding for full-day pre-kindergarten; ensuring federal stimulus dollars are used to increase public education; continuing to invest in students to reach the national average in per-student funding; and opposing taxpayer subsidies to private schools and vendors, such as tax credit scholarships, education savings accounts, vouchers for students in special education and virtual vouchers.
- The Texas Alliance of Energy Producers will be working with lawmakers to avoid proposals

MIS2ION COMPLETE! KATY DOMINATES CEDAR HILL TO WIN NINTH STATE CHAMPIONSHIP

ARLINGTON — Through the COVID-19 issues that affected everything from how they held team meetings to how much they tackled during practices, through two significant season-ending injuries, and through game postponements and cancellations, the Katy Tigers pushed and pushed. “Perseverance,” coach Gary Joseph said. “MIS2ION MINDSET,” players termed it. Only a state title would justify the four-month emotional and physical roller-coaster.

So the No. 9 state-ranked Tigers went out and justified their 2020 season in the Class 6A Division II state final on Saturday, Jan. 16, at AT&T Stadium, manhandling No. 8 Cedar Hill in a start-to-finish laughter courtesy of a 51-14 win, capturing the program’s ninth state title and giving Joseph his fifth as head coach.

“It’s very special,” Joseph said. “It’s one of those years you’ll always remember because of what we went through

to get to this point. I’m extremely proud. It is a very special time.”

Boasting a record 15 state championship game appearances, Katy’s nine titles rank second to only Aledo, a 5A, Division II program that has 10 titles.

“It’s a credit to these kids and what they went through, fighting the coronavirus and the pandemic, and being there not knowing each and every day when they’ll get to play or who they’ll get to play,” Joseph said. “It’s a great lesson in perseverance and resilience.”

To beat an athletic and physically gifted Cedar Hill (12-2) team, which won Region II, Region III champ Katy (14-1) had to keep dual-threat senior quarterback and Tennessee signee Kaidon Salter in the pocket. The Tigers’ secondary had to play the best it has all season against a group of dynamic, fast Longhorns receivers. Katy, offensively,

had to run the ball and control the tempo to keep possession away from Cedar Hill.

Check. Check. Check. Salter only ran for 46 yards, almost half of his season average, and two late third quarter touchdowns after Katy had a 34-0 lead. The season-long 60-percent passer completed just 12 of 24 throws for 112 yards and two interceptions.

“There were some plays where he got to the

outside, but ... we just knew he’d get frustrated after a while,” senior defensive end Cal Varner III said. “After stuff started to go downhill, it fell back on him and he wasn’t leading his team anymore. He kind of let them go.”

Katy ran the ball 47 times for 313 yards and three touchdowns and dominated time of possession, 29:06 to 18:54.

Commissioners discuss WCSO budget, floodplains at meeting

Newly-sworn-in Waller County Sheriff Troy Guidry requested an additional two deputies allotted for court security when the new Waller County Justice Center comes online fully once COVID-19 allows the courts to open for full, in-person operations. Commissioners also discussed revisions to flood damage prevention policies for the county.

Guidry said he and his team had worked with former Interim Sheriff Joe Hester who took over the department after the passing of the late Sheriff Glenn Smith late last summer. After the restructuring, Guidry said he needed to add four court security positions to ensure that the new Waller County Justice Center is fully staffed and secured for the courts that will be housed in the new facility as well as ensuring that four staff were available for the county courthouse.

“The fact is we’re going to need four full-time deputies – armed people – at that new building and it’s mainly for the judges’ security,” Guidry said. “We sat down with (the judges) and they’d like at least two people in their courtroom(s), armed during their court sessions.”

Guidry said the cost to hire a deputy is about \$50,000 a year plus benefits which county staff

estimate at about \$12,000 a year. So, with the two existing staff and two new staff being requested, that would come out to a total of about \$288,000. However, Guidry said, the department would work to identify ways to curb expenses in other areas by eliminating expenses. One way to do that, he said, would be to utilize inmate labor to keep the grounds in order by having them perform tasks such as mowing,

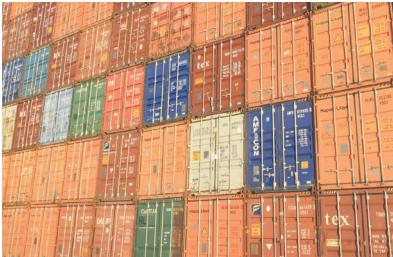
weed eating and picking up trash that accumulates at the new facility.

“Now what we don’t want to do – we already have a low number on the patrol side,” Guidry said. “We don’t want to take away from the citizens who haven’t violated somebody’s rights to come out here and stop patrolling to come to work the courthouse.”

Guidry said shifting staff off

patrol is what has happened in the past, but with the new facility, he wants to avoid doing that and to properly staff the facility with the appropriate sorts of deputies and bailiffs. He added that it takes about three months after a deputy is hired to fully orient them into the county through supplemental training that is county-specific.

Port Houston annual volume nears record

Port Houston’s annual container activity rose in December which pushed the volume of cargo close to matching the level set in 2019 which was a record year, according to a statement released by the port.

“We are proud to keep the supply chain moving and help move goods to consumers. People need the items that arrive through our docks, like medical supplies and food, as well as e-commerce goods for their home,” said Port Houston Executive Director Roger Guenther.

December 2020 was the second-busiest month ever for loaded imports with more than 126,000 twenty-foot equivalent units – or TEUs – of loaded imports moved through the port, a 26% increase from December 2019. Total TEUs for 2020 reached 2,989,347 TEUs as compared to 2019’s 2,990,175 TEUs.

Guenther said he is optimistic that the rebound in container volumes at Port Houston will continue and projections for 2021 indicate additional growth.

As a result of the anticipated growth, Port Houston is continuing to expand and investing in infrastructure and its labor force, the statement said.

Total cargo was down 4% for the year overall in 2020 due to decreased demand for oil industry-related hardware such as steel piping. However, grain and bulk cargoes were up in 2020 as compared to 2019, but overall steel and automotive good transport was down.

Port Houston is the sixth largest container port in the U.S. and handles more than two-thirds of all containers in the Gulf of Mexico.

“Given the challenging 2020 we all had, we are grateful to our entire team for continuing to provide world-class service to our customers so Houstonians and others in the region get the essentials they need.”

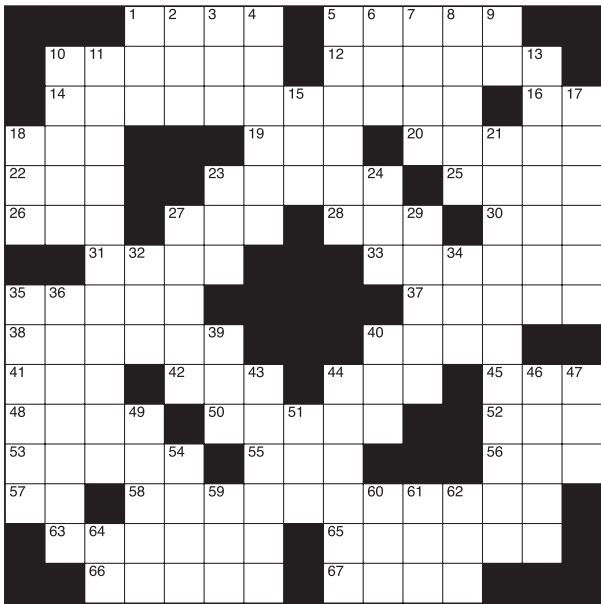

Coral Jan “Skipper” Scroggins of Katy, Texas passed away on January 12, 2021, at the age of 94. Coincidentally, January 12 was her father’s birthday. She was preceded in death by her parents Robbie Louise and Percy Harold Yolland, son Van Edward Scroggins in 1976, daughter-in-law Dorothy Jordens Scroggins Mahler in 1983 and husband Van E. Scroggins in 1999.

She is survived by her daughter Robbie Lynn Scroggins Yarbrough of Katy; grandchildren Kyle Yarbrough and wife Amanda of Leander; Rebecca Yarbrough Abbate and husband Christian of Katy; Jana Yarbrough Luke and husband Joshua of Bellville; Stacie Scroggins Schnabel and husband Darren of Argyle; and Jorden Mahler and wife Stephanie of New Braunfels. She is also survived by great-grandchildren Collier Yarbrough; Jacob and Joshua Abbate; Adleigh and Rylee Lukeke; Hailey, Jenna and Reed Schnabel; and Ella and Easton Mahler.

Skipper was born on November 11, 1926 in Houston, Texas. Her father worked for Humble Pipeline Co., and in 1928, her family moved to Ingleside, Texas when he was transferred. At the age of 16, Skipper graduated from Ingleside High School. It was interesting to hear stories about her antics and adventures growing up as an only child on a Humble Pipeline Tank Farm and during the early years of WWII.

After high school graduation, Skipper attended the University of Texas in Austin. During this time, her father was transferred back to Houston. Skipper graduated with a degree in

Business Administration in 1947, and she moved to live with her parents in Webster and drove to her job at Humble Pipeline in downtown Houston where she worked for exactly one year to the day before she quit to get married. Her parents encouraged her to stop working earlier as she was stressed with wedding activities, but she wanted to reach her 1-year work anniversary so she would receive her paid vacation.

Skipper’s and Van’s families became friends in Webster before the two of them ever met—she was away at college and he was in the Army Air Corp as a pilot in the Pacific Theater during WWII. Once they were introduced when he returned from overseas, they began dating and became engaged. On March 6, 1948, they married in Saint Paul’s Methodist Church in Houston, and six weeks later, they moved to Katy after purchasing the local feed store from the late Ruby and L.D. Robinson. Soon the name was changed to Katy Feed & Supply, and Skipper helped run the store until the business closed in 1981. She was also Van’s support system when in the fall of 1948 he began soliciting

aerial application work for the Katy area rice farmers, which grew and developed into Katy Dusting Company. In addition, Skipper and Van owned and ran Sigma Chemical Company until 1981, and they had the local Mobil Distributorship from 1968 until 1983. They also became very involved in cattle ranching.

Skipper was an active member of First United Methodist Church in Katy, especially in her young adult years. She served on numerous committees and taught Sunday School and VBS. In addition, she was a very involved mother while her children were in school. She was a room mother for 16 consecutive years, and she also substitute taught in a variety of positions and grades. Van Edward’s and Robbie’s friends knew the door was always open to them at the Scroggins’ home, and it was the location of many parties and get-togethers both small and large for kids and adults.

Skipper was also a member of various local organizations and clubs. She remained a member of the Twentieth Century Club from 1948 until her death and held several offices, was a charter member and was active with the Katy Hospital Volunteers for many years, and served as a director and president of the Katy Social Services Board.

Skipper and Van had their first child Van Edward in 1950, and he married Dorothy Jordens in 1971. Their first grandchild Stacie Michelle was born in 1974. Van Edward died tragically in an airplane accident in April 1976, and “Dot” passed away in 1983 from cancer. Robbie Lynn was born in 1953, and she and her husband had three

children—Kyle, Becca and Jana. Skipper considered herself blessed to be “Me-Maw” to her grandchildren and great-grandchildren. She attended every event and activity they were involved in as often as she could, despite the fact in later years it was more difficult for her. Many funny stories and memories have been retold and relived over the years, and “MeMaw” is the main character in them! One of my most important resolutions is to finish reading the Bible all the way through. (Hey, that wasn't supposed to be funny.) This is actually



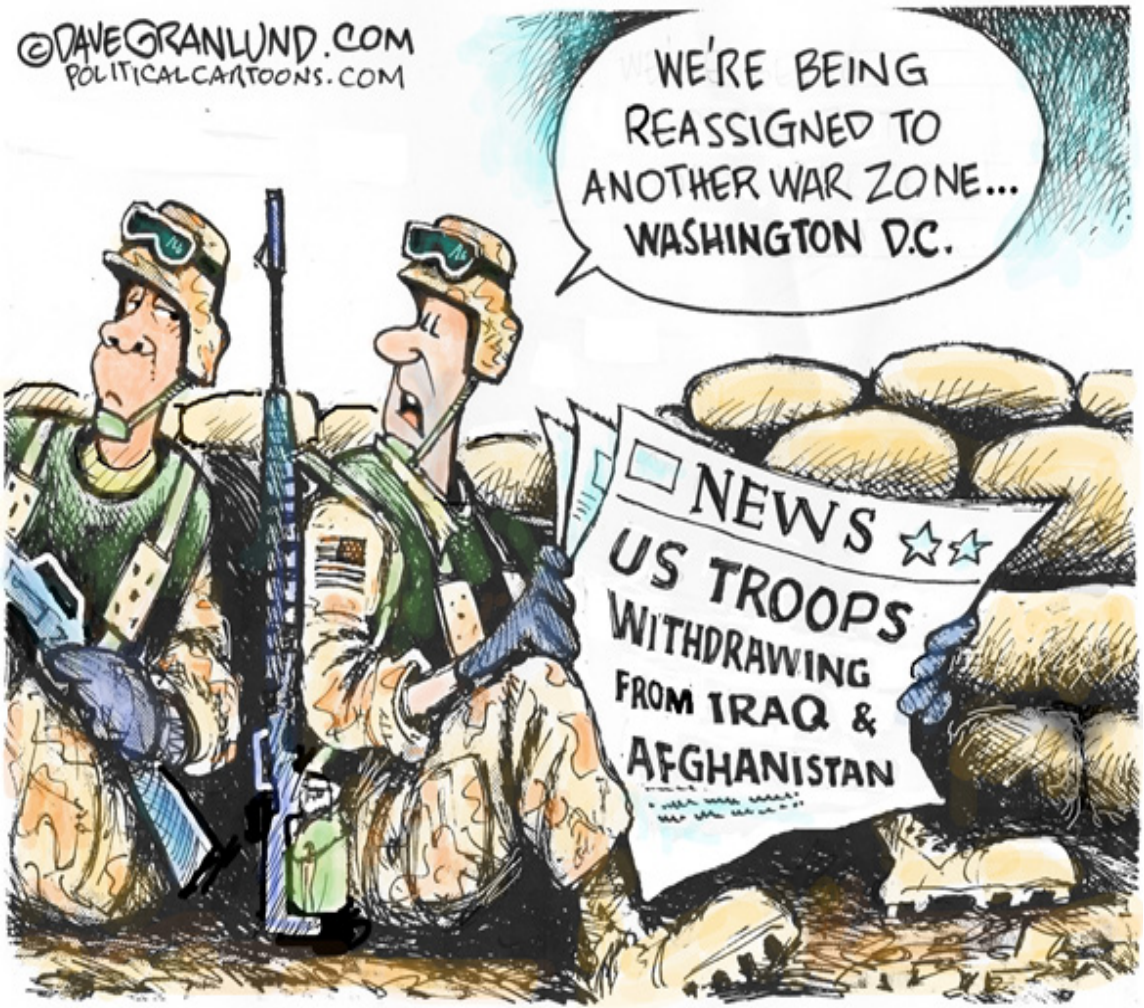

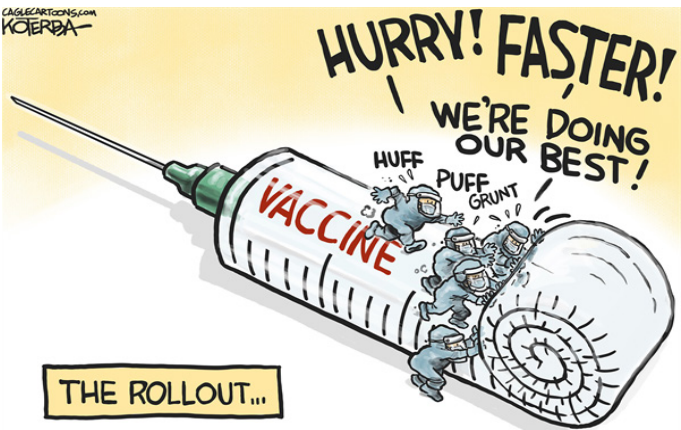
The writer says that acknowledging white privilege is racist. I imagine this is because it may

Also coming to the development this year is Timber Grove Park, a new amenity in the community which will be located between Elyson Boulevard and Porter Road in the northern portion of the community. The park will be adjacent to Elyson’s new model home village which will also open this year and showcase a dozen fully furnished model homes for potential residents to tour. The park itself will have multiple water features and walking trails for residents to utilize, according to the development’s website.

In August 2020, Peter McElwain Elementary, a Katy ISD campus, opened in the southern portion of Elyson. The elementary is named for Peter McElwain, who served as an architect for Katy ISD for many years. The campus features hallways with alcoves for study groups as well as group learning spaces outside of traditional classrooms.

“I can’t tell you how proud and honored I feel that the school is named that this particular school is named after me,” McElwain said during interviews on the first day of school.

The development’s first preschool, Kiddie Academy, opened in 2019.

Builders in Elyson include Taylor Morrison, Westin Homes, Lennar Homes, Pulte Homes, Chesmar Homes, Beazer Homes, Perry Homes, Highland Homes, Taylor Homes, Taylor Morrison and Village Builders. Homes range in price from the \$240,000 range to \$700,000 or more. Homesites range from 40-65 feet wide, Gustafson said.

“Housing affordability is a growing concern nationally and even in Houston, which is still one of the nation’s most affordable housing markets

but has seen prices increase as the costs of building materials and labor rise,” Gustafson said. “By introducing traditional detached homes on smaller homesites, along with innovative products, Elyson is working to help keep the American dream of homeownership alive for a majority of homebuyers.”

In late 2020, Elyson added duplex homes by Beazer Homes with two model homes available to trou. These homes are priced from the mid-\$200,000 range and are designed to appeal to first-time homebuyers and those looking for low maintenance homes.

By the end of November 2020, more than 450 new homes had been sold at Elyson, a 30% increase over sales in 2019. An update on sales in December was not provided in

time for publication.

The Shops at Elyson has opened as part of the community along FM 529 at the intersection with Peek Road. So far, the shopping center hosts Elyson Family Dental, the Elyson Animal Hospital, Marcos Pizza and Cunningham cleaners with more on the way.

In September, Elyson welcomed its 1,000th resident, James Clark, who had been a renter all of his life, but wanted to buy a home as he approached retirement. As an avid cyclist, Clark found Elyson attractive, according to a Newland Communities press release.

“I like the idea of riding my bike on a trail and not having to mingle with traffic,” James says. “Elyson is a very pretty community, with ponds and parks to enjoy as I ride.”

Commissioners tabled the item for now while Guidry works with county accounting staff to see where budget savings can be recognized to pay for the new positions. Guidry has previously said he would be looking for volunteer deputies to help supplement existing staff which is one avenue that may help in finding funding for this supplemental staffing. He added during the meeting that reducing overtime would assist with the issue and that a possible agreement with Austin County could bring in unexpected revenue and selling unneeded, outdated equipment as well as improved programs for vehicle maintenance which will save the county money among other money-saving avenues.

Court is tentatively expected to reopen in June or July of this year and Guidry said he would like to have the officers fully trained prior to that happening.

“I really didn’t want to come to (commissioners court) and ask for this (staff increase), but I don’t think that we can – outside of pulling from patrol – at this stage, there’s really no other option to do it,” Guidry said.

The issue was ultimately tabled while funding adjustments are investigated.

Hester, now an administrative lieutenant with WCSO, followed Guidry on the agenda to set up an agreement with Texana, a non-profit out of the Rosenberg area, to provide mental health services for the jail. The organization has been providing mental health services as required by state law, but costs have become untenable, Hester said.

The new agreement will be more expensive than the flat fee the non-profit had been providing to WCSO.

Hester said WCSO had looked at what other counties were paying through telehealth options, but saw that sort of service costing more than the agreement with Texana.

A mental health agreement for about \$35,000 for non-inmate-related health care evaluations with

Other actions taken by the Waller County Commissioners Court included:

- Approved payroll and accounts payable issuances.
- Approved a request by the county engineer for the final plat of the Kingsand Heights subdivision, section four, a roughly 27-acre piece of land which will include 97 lots, 6 blocks and 9 reserves in Waller County Precinct 4. The new subdivision is located on the south side of I-10 on the east side of Igloo Road.
- Approved a request from the county engineer to approve a utility permit for the San Bernard Electric Coop to place a power pole in the right-of-way of Joseph Road on the north end of the county.
- Approved a request by the 506th District Court judge for fixed asset transfers to the County Court at Law.
- Authorized County Judge Trey Duhon to sign one resale deed for private tax resale of properties currently held in trust by Waller County in accordance with the Texas Tax Code.
- Approved additional copy machines for the new Sheriff’s Office and Jail. Lt. Joe Hester of WCSO said that the size of the new building required additional machines. The new machines will cost about \$870 per month with the first 15,000 black and white pages included, though color copies increased that rate. County staff felt the increase in cost could be justified by other savings programs at WCSO.
- Approved an amendment to the contract with Incode Public Safety in the amount of about \$7,500, which provides software for the county’s public safety programs.

Texana was approved along with the agreement to provide inmate mental health services. The contracts were agreed; however, each has a clause that allows for a 30-day option to cancel if better options become available.

County Auditor Alan Younts said it was possible that a small line item can be approved and then the county could look at possible grants to fund the services as well.

to raise taxes, impose or raise fees or shift regulatory costs to industry or mineral interest holders. The alliance plans to participate in the Coalition for Critical Infrastructure to support solutions to landowners' eminent domain concerns.

"(This session) will be different, but what has not changed is the importance of making sure the voices of farm and ranch families are heard at the Capitol," Farm Bureau President Russell Boening said.

Raise Your Hand Texas officials said lawmakers can keep promises to education despite tight budgeting.

"Even during this difficult budget cycle, the state has options to continue investing in and fully funding public education," Raise Your Hand Texas wrote in a statement.

Legislators and special interest groups have announced their agendas for the 87th Texas Legislative Session. Highlights include improving internet access for rural communities and improving education – all with a budget made tight by falling revenues caused by the COVID-19 pandemic.

Jason Modglin, energy alliance president, encouraged lawmakers in search of revenue to consider whether all energy sources are paying what oil and gas producers do.

"Renewable energy projects in the state do not pay a severance tax to the state like we must do," Modglin wrote in Shalemag.com. "Those arguing Texas and

the U.S. should fully transition to renewable energy sources have offered no plan for how they will fund schools, roads and water infrastructure in the same way oil and gas severance taxes do. For example, electric vehicles are currently not required to pay for the use of roads like gasoline and diesel vehicles must."

CONNECTING RURAL TEXAS

Regular readers of "Capitol Highlights" know of readers' high interest in improving access to high-speed internet for rural Texans. Connected Nation Texas asked lawmakers to offer thoughts on the need.

"Many of the counties I represent do not have a hospital or even a doctor, and broadband can help bridge the healthcare gap these rural residents face," said Sen. Charles Perry, R- Lubbock.

Connected Nation Texas doesn't lobby for legislation, but state program director Jennifer Harris said she anticipated many lawmakers would offer solutions this session.

Sen. Robert Nichols, R-Jacksonville, and Rep. Trent Ashby, R-Lufkin, announced their intent to file legislation to expand access. They said their bill would "affirm the state's commitment to closing the digital divide for Texans."

"The coronavirus pandemic has underscored the need for reliable access to the internet and exposed the breadth of ways in which connectivity impacts daily life," Ashby said in a statement. "It's my hope that passage of this bill will ensure our state is serious about working to make 21st century investments in favor of economic development, education, healthcare, public safety and the many other industries which benefit from connectivity."

The upcoming legislation includes:

- Creation of a broadband development office within the Texas Comptroller of Public Accounts.
- A broadband development program funded by the newly established broadband development account.
- Establishment of a broadband development map to be updated regularly and published by the office.
- The development within a year of a statewide broadband plan.



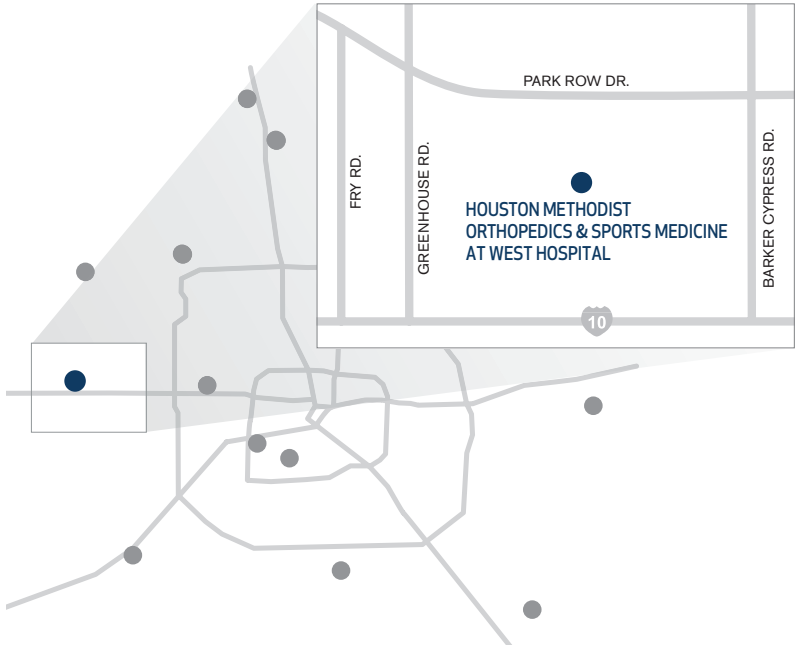

Lazic, Anderson, sophomores shine for Katy champs

ARLINGTON — Katy was proficient in all three phases of the game during its 51-14 Class 6A-Division II state championship win over Cedar Hill on Jan. 16 at AT&T Stadium. Whether it was offense, defense or special teams, the Tigers were on top of their game.

Offensively, Katy totaled 390 yards and averaged seven yards per play. Defensively, the Tigers held the Longhorns to nine first downs and just 2-of-10 conversions on third down. And on special teams, senior kicker Nemanja Lazic tied a University Interscholastic League state record.

Lazic's 48-yard field goal with 3:31 left in the second quarter tied the longest field goal make in a state final, regardless of classification. Lazic shares the record with another Tiger, Kris Perez. Perez hit a 48-yarder in Katy's 2015 state final win over Lake Travis.

"It feels amazing setting a record like that," Lazic said. "I didn't even know it tied a state record until someone from the stands told me going back into the

locker room. But all credit goes to the eight guys blocking for me, my long snapper Aiden Wendt and my holder Hamilton McMartin. They make the job a whole lot easier and they deserve the same amount of credit as me."

Lazic made all three of his field goals in the state final, from 48, 21 and 38 yards.

"Kicking in a stadium like that is something special," Lazic said. "I just think about how it's the same length of the field and the same goal posts, so my routine shouldn't change. That's what makes me relax playing in a stadium like that."

Dr. Bing beloved by Katy ISD athletics

Dr. Mark Bing loved his faith and family. He had a passion for trains, biking and Diet Coke. He adored Katy ISD athletics, most of all Katy High School.

But above all, he lived to help.

“He was all in about serving people,” said Charlie Stevens, formerly the Katy ISD assistant athletic director over sports medicine who is now a consultant with the district. “He was a go-to. He was always doing whatever, whenever, to serve the community of Katy.”

“Selfless” is the first word people use when describing Dr. Bing, who died Jan. 9 from the effects of Fragile X Tremor and Ataxia Syndrome (FXTAS). Dr. Bing (1951-2021) was most notably the Katy High football team physician, taking over the role from his father, Dr. Lyndon Bing, in the early 1980s. He is in the Texas High School Football Hall

of Fame and the Katy ISD Hall of Honor.

The stories of Dr. Bing’s unselfishness and passion for his community and Katy ISD are tales of legend.

When he found out high school wrestling student-athletes and coaches were using home remedies to treat skin infections to avoid high medical costs, Dr. Bing offered to treat them for free. Every Wednesday at 5 p.m., he showed up at Taylor High and treated any kid from any school in the district that had a skin issue.

If a student-athlete didn’t have enough money to buy gloves or

shoes, Dr. Bing purchased the necessary equipment and donated it to the football program on behalf of that kid.

Dr. Bing offered physicals for student-athletes at discounted rates. He sponsored state championship rings, received decades later, for Katy High’s 1959 football team. He served the district’s wrestling program as a physician and official. His support in the Greater Houston Cycling foundation aided the Alkek Velodrome’s youth cycling program for decades.

Tigers top Cougars as playoff race heats up

Like every other high school boys basketball team in the country, Katy High has dealt with its share of adversity because of COVID-19. Tuesday’s game against Cinco Ranch was the first time the Tigers had every coach and player healthy since before the Christmas break.

Katy showed what it is capable of at full strength, toppling Cinco Ranch, 76-52, at Cinco Ranch High to improve its standing within an intense District 19-6A playoff race.

Seven Lakes is undefeated in district play at 7-0. Katy (4-4 19-6A) is one of five teams competing for other three playoff spots, joining Taylor (5-3), Mayde Creek (4-4), Tompkins (4-4) and Cinco Ranch (3-4).

The Tigers led the Cougars from start to finish on Tuesday, leading by eight points after the first quarter, 23 at halftime, and 32 after the third quarter.

“It was a really big win for us,” said junior guard Dayvaughn Froe, who paced Katy with 17 points, seven assists, five rebounds and five steals. “Now we see what we can do. We see our potential. If we keep playing hard like that, we can beat anybody.”

The Tigers lost to the Cougars, 62-56, in their first district meeting on Dec. 22. In that game, Katy held a double-digit lead twice, led by nine in the third quarter, and led by seven in the

fourth. But the Tigers couldn’t stop the Cougars, who scored on four consecutive possessions in the final quarter to rally for the win.

Expectedly, defense was at the forefront of the Tigers’ cause in the second meeting. Katy limited Cinco Ranch to 20 total points through the first three quarters and forced 14 turnovers.

No Cougar scored in double-figures. Sophomore guard Derek Kollmansberger led Cinco Ranch with nine points, six coming in the fourth quarter.

“We made a determined team effort to defend, and not

just in spots and not just by certain individuals,” coach Danny Russell said. “It was five guys defending for the entirety of the game, and that creates transition opportunities we hadn’t been getting and it builds a lot of pride. The defensive end is where your heart shows, and I think we’re starting to show our heart.”

Senior guard Ryan Johnson, who had three steals and a block, said the mindset was to come into the game with intensity and set the tone.

“We had to pressure the ball more and we had to box out and get on the glass,” Johnson said.

Offensively, Katy scored at least 15 points in every quarter. The Tigers were buoyed by sharp shooting from 3-point range, draining seven of 12 3s in the first half and eight of 18 overall.

Froe and senior Connor Champion each made three triples.

“Sometimes the ball goes in, sometimes it doesn’t, sometimes it’s shot selection,” said Russell, who added his team has shot well from 3 all season long. “But at the end of the day, you can defend regardless of the situation. When we buy into that, it makes the game a lot easier in other areas, and shooting is one of them.”

Five Tigers scored in double-figures. Froe and Champion each had 17, senior Christian Lopez had 16 off the bench, Johnson added 14 and senior Trent Evans finished with 12. Champion and Lopez produced their efforts off the bench.

Russell even credited the players who didn’t play for keeping the team engaged and inspired throughout the game. It’s been a rough few weeks for Katy with coaches and players in and out of action, but the Tigers are grateful everyone is healthy as the race for the postseason heats up.

“Anything can get thrown at you this season,” Froe said. “It’s different than anything else we’ve dealt with before. We’ve struggled, but once we all come together like we did, we can deal with anything and push through.”

Bankston, Panthers honored as all-district selections

Paetow’s football season did not end how it desired, with its area round playoff game canceled because of COVID-19 cases within the Panthers program, but its success this season was rewarded when the District 10-5A, Division I selections were released earlier this month. Competing in one of the toughest

districts in the state in Class 5A, Division I, the Panthers went 5-1 in district play and finished third behind champion Manvel (4-0) and Richmond Foster (4-1). Hightower (2-2) finished fourth.

Paetow senior running back Damon Bankston earned Offensive Most Valuable Player. Bankston rushed for 747 yards and eight touchdowns in six district games.

Terry senior quarterback Kellen Stewart was named the district’s MVP and Foster senior defensive tackle Tyler Onyedim was named Defensive MVP. “He was a great friend,” Katy High head football coach/athletic coordinator Gary Joseph said. “The biggest thing we miss about him is his presence every day. Anybody that’s that unselfish ... He would do anything for anybody. We knew we could call Dr. Bing.”

Justin Landers, formerly the longtime Katy High athletic trainer and now Katy ISD’s assistant athletic director over sports medicine following Stevens’ retirement last summer, is an alumnus of the Katy High Class of 1995. He was a student trainer under Dr. Bing in the early 1990s.

“Even as a student, as I worked through the program, he was there to teach me,” Landers said. “He allowed me to stand side by side and cut stitches with him. He told me stories about the history of Katy High School. All of that stuck with me. His fondness and excitement for Katy football and the city of Katy was just so abundant.

“The guy gave me advice on how to become a better person to how to deal with medical situations to how to help coaches. ‘Justin, you always do the right thing and you treat the person how you would treat your kids and you would want to be treated. Coaches can be frustrated about the situation, but in the end, you’ve won the heart of that kid and you did what was right.’ It’s something I still use today.”

Landers’ favorite memory of Dr. Bing comes from the 1992 season, when the Tigers played Jersey Village for the city football title. Landers and Dr. Bing talked excitedly the whole game, discussing plays and which way runs were going and who would make the big defensive play.

Landers took pride in being Dr. Bing’s “eyes and ears” at practices during the week so he could relay to him the game-plan.

After the 10-9 win over Jersey Village, the two embraced.

“We were like little kids, jumping up and down, hugging each other,” Landers said. “It was pretty emotional, something I remember fondly. Even as an adult, in 2012 winning the state title, I can remember doing the same thing, jumping up and down with him, hugging him. Pretty special.”

Stevens recalled working a junior varsity wrestling tournament at Katy High on a Saturday about six years ago. Skin checks were a requirement for ringworm, et cetera, and one of the officials wanted to flag an athlete. Landers,

then the Katy High athletic trainer, phoned Dr. Bing to intercede.

After each expressed concern about what was taking Dr. Bing so long to arrive—he lived just two miles from the school—Stevens and Landers learned Dr. Bing, who once flew home from a family vacation to attend to a playoff game in 2001, had been downtown at church when he received their call, left hurriedly, and even received a speeding ticket along the way.

“I learned that sometimes when you were going to ask him for a favor, you asked what he was doing before asking,” Stevens said. “He would drop everything he

was doing to come help you.”

Dr. Bing cared so deeply about Katy ISD athletics that anyone who wanted to be a partner in his practice had to agree to cover high school athletic events, unpaid and on their own personal time. Dr. William DeSimone, Dr. Rick Adams, Dr. Andy Shen, and Dr. Paul Bing, Mark’s brother, have carried on the accessible and giving culture established by Dr. Bing with the district in light of his passing.

Dr. Bing, who helped the development of the Katy Medical Complex into what is now Memorial Hermann Katy Rehabilitation Hospital, played an important

role in Katy ISD expanding its sports medicine initiatives. Now the hospital is able to get referrals on behalf of Katy ISD for surgeries and other needs for student-athletes, and the district is able to utilize the hospital’s resources and personnel expertise.

When a doctor was needed as oversight for an AED (Automated External Defibrillators) program for the school district, Dr. Bing volunteered. When a doctor was needed to sign off on an EMT program the district was doing, he volunteered for that as well.

Not long before he got sick, Dr. Bing’s desire was to work for the Katy ISD athletic department, cover athletic events and be the Katy High team doctor without having a practice. That’s what he wanted. He had gotten it set up to where he was going to just cover nursing homes for his practice, but that’s when his health started to turn.

“It was like, ‘Shoot,’” Stevens said. “It was but for a fleeting moment that he’d gotten to where he wanted.”

Dr. Bing married his loving wife, Kelly Beck Bing, in 1987. He is survived by her and his five children: Elizabeth Cools and husband Joshua Cools, Ethan Bing and wife Claudia Wei, Natalie Morgan and husband Cody Morgan, Mariel Godeaux and husband John Godeaux, and Elliot Bing; along with five grandchildren and two more grandbabies on the way.

Dr. Bing was the eldest son of Dr. Lyndon Bing and Dorothy Bing and brother of Sarah Turner, Rebecca Quantz, Martha Culbreth, and Dr. Paul Bing.

It is Lyndon and Dorothy whom Landers credits for Dr. Bing’s affinity for serving others.

“His dad had a life-of-service attitude. His mom took care of the family and had a life of service to the church,” Landers said. “I think that’s why he ended up serving people, because he didn’t know anything else.”

“It’s not earth science what they’re doing offensively,” Cedar Hill coach Carlos Lynn said. “It’s a grind mentality, and they do it well. It’s hard to simulate. I don’t know if our kids have ever seen (an offense) under center. It’s tough. They executed well. They brought their ‘A’ game. They played at a high level and they were the benefits of that.”

Katy’s defense scored as many points as Cedar Hill’s offense. Junior defensive back Hamilton McMartin had a 55-yard fumble recovery for a score. Varner added a dramatic pick-6 in the fourth quarter.

Senior defensive back Dalton Johnson and McMartin each had 3 1/2 tackles to lead Katy. Johnson also forced a fumble. Senior linebacker Shepherd Bowling had a gorgeous diving interception of Salter in the first half. Katy scored 21 points off turnovers.

“They’re so disciplined,” Lynn said of Katy’s defense. “They’re not going to beat themselves. They play a style of football where everybody knows how to fit and where they’re going to be. We did a poor job of trying to take advantage of some of those things. They tackle well, they were opportunistic. Those things can be a disaster for an offense.”

The Tigers outgained the Longhorns in total yards, 390-246.

Sophomore running back Seth Davis was named Offensive Player of the Game after rushing for 123 yards and a touchdown on 14 carries. Varner was named Defensive Player of the Game, with two tackles for a loss, a sack and the interception he returned 15 yards for a touchdown with

10:17 left in the fourth quarter that drew the attention of a future NFL Hall of Famer.

“Hell of a play @CalVarnerIII,” Texans star J.J. Watt tweeted. “Texas high school football built different.”

It was Varner’s first career interception.

“I saw the running back going out for a swing pass,” he said. “I played it to the tackle and just came off at the right time. He threw it right at me. I knew if I dropped it, I’d have everybody making fun of me, so I had to take that back.

“I think it took all their momentum away, all their hope. Once I got that pick, their quarterback just sat there on the ground and I saw they were defeated.”

This year’s Tigers were identical to the 2008 title team. That season was the last time Katy lost a district game and did not win the district title until this season, when streaks of 75 consecutive district wins and 11 consecutive district championships were snapped. But, like that 2008 team, this Katy team rallied to win a state championship, using a selfless, team-oriented mentality to keep going. It was truly a team, in every sense of the word. The Tigers were the headliners, not individuals.

Katy outscored its five playoff opponents 274-66, eliminating two state-ranked teams (Shadow Creek and Cedar Hill) along the way.

“It was tough,” Varner said. “We had players go down, like (junior defensive end) Malick (Sylla) and (senior tight end) Fernando (Garza). We had coaches get corona, players get corona. We had practices pushed back, games pushed back. But we persevered.

“Everybody was on board, everybody kept pushing. That’s what made this team special.”

ONE FOR NIC

After watching his older brothers, Rodney and Ryder, win state championships as Tigers, junior receiver Nic Anderson “felt like I had to win one.”

“I had to bring one home to the family, complete the set,” Anderson said.

Rodney, the oldest of the trio, won a state title in 2012 as a sophomore running back. Ryder was a junior defensive end on the 2015 title team.

Nic can now add himself to the family’s legacy of champions after the Tigers’ win over Cedar Hill last weekend. Anderson had a catch for 30 yards in the state final, and for the season finished with 30 catches for 480 yards and five touchdowns.

“It’s unreal,” Anderson said. “My family knows how hard my team and I have worked, and I know they’re so proud to see it finally pay off.”

He added, laughing, “I still have a year left to get one more ring than my brothers, so that’s my goal.”

Anderson said his older brothers told him to play his best, have fun and remember the moment of playing for a state title. He improved this season getting better at concentrating on the ball and focusing on runs after the catch. He worked tirelessly on route running to make sure he was consistent every time.

“They’re each their own person,” coach Gary Joseph said of the Andersons. “Nic is the quietest of them all. Rodney wasn’t a rah-rah guy. Ryder liked to hear himself talk. There’s certainly a difference in them. Nic is one of those kids that’s matured later. Rodney was pretty mature enough to play as a freshman here. Nic is just now starting to mature. His strength has gotten so much better, his speed has gotten better. They mature differently.”

Anderson said he will never forget this season.

“I think of all we had to sacrifice as a team to get what we strived for,” he said. “I mean, we literally gave up holidays to reach our goal.”

MORE IN STORE

The Tigers have a bright future. Sophomore running back Seth Davis was Offensive Player of the Game for the state final. Quarterback Caleb Koger was a sophomore as well.

Davis rushed for 123 yards and a touchdown on 14 carries in the championship game. His older half-brother, starting senior running back Jalen Davis, rushed for 109 yards and a touchdown on 23 carries.

“I think I’ve learned a lot from him, and he’s learned a lot from me,” Jalen Davis said. “I love him more than anything, and I’m blessed to share the backfield with him for this team. I’m extremely proud people are taking notice of my little brother. We’ve always worked hard and have always been competitive at a young age. It’s paying off.”

Koger persevered through an early quarterback competition and a rough outing in the Tigers’ only loss of the season to Tompkins on Nov. 5, when he completed just half of his 14 passes for 81 yards and two interceptions.

But since that loss, Koger has played brilliantly, throwing for 14 touchdowns and no interceptions over the final eight games of the season. In the state final, Koger, who masterfully executed play-fakes to thwart the Cedar Hill defense, completed five of nine passes for 92 yards and a touchdown.

“I told you after the loss that that game was probably a bit too big for him at the time, but he grew up and his teammates allowed him to grow up,” Joseph said. “They never wavered in their support of him and they knew he was going to be the guy to get us to this point. He’s got a great future in front of him as long as he keeps working and improving. The best is yet to come.”

A VISIT FROM ANDY

Dallas Cowboys quarterback and former Katy High star Andy Dalton visited the team the morning of the state championship game to offer a pregame speech.

“He told us about how he came from the ‘B’ team to freshman team and didn’t start until his senior year,” senior defensive back Dalton Johnson said. “It lets everybody know that it’s all worth it to go through this. He lost state, but he had a great time at Katy. Fortunately, we were able to win. I love this team and this class. It’s worth it.”

Dalton was a third-team all-state selection his senior year in 2005, when he threw for 2,877 yards and 42 touchdowns in leading Katy to the state finals.

Johnson said the players were inspired by Dalton’s talk. It was proof that what they had to go through this year, all the protocols and restrictions because of COVID-19, were worth it.

“Most of us are used to socializing, but we knew what it took to get here, and we wanted it bad enough,” Johnson said. “We stayed within the team or family, even over breaks. Coaches got corona, players got corona. Overcoming that, we knew what we had to do. The bond we created because of that led us to this state championship even more, I would believe.”

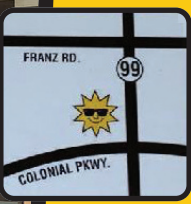
