KISD talks "parental authority," gender policies

Amid media attention from major broadcast news outlets across the city, the Katy ISD Board of Trustees discussed potential policy changes for district personnel, including "Parental Authority and Gender Fluidity Matters," possible changes to the evaluation criteria for the superintendent and possible changes to the board's own code of ethics.

Board president Victor Perez opened the discussion on "Parental Authority and Gender Fluidity" with an overview,

stating that the "parental authority" policy was needed to give guidance to teachers that would require employees to inform parents if a student asks to be identified as transgender, use different pronouns or change their name.

A written copy of the proposed policy was not made available to the media; district personnel responded that the policy could not be released since it was only in draft form.

Perez said in his opening remarks that the topic of gender was being

Waller Co. to place mobility bond on Nov. 7 ballot

By a unanimous vote in its August 16th meeting, the Waller County Commissioners Court voted to place a \$280 million bond package on the November 7th ballot for voters to consider.

County Judge Trey Duhon encouraged residents who are seeking more information about the bond package to review the workshops and presentations previously made to commissioners court, which are available online at www.co.waller.tx.us.

Duhon also announced that the county would hold a series of town halls - including meetings in each of the county's four precincts - between now and the November election. He also said that there would probably be another workshop in commissioners court on the mobility bond, which will also be recorded and made available online on the county's website.

"Now, it is up to the voters," said Duhon.

the morning bell ran across the district, more than 94,000 students were welcomed back to their designated campuses.

The district also opened two brand-new campuses, Faldyn Elementary and Youngblood Elementary, located in the growing northwest quadrant. Faldyn Elementary is at 25615 Clay Road, Katy, while Young-



discussed nationally and while there were no local issues currently prompting the creation of such a policy, it was necessary for the protection of girls sports from competition from biological males, the protection of bathroom safety and for the management of the use of pronouns inconsistent with the biological sex of the child.

He said that the board also wanted to address that schools are not teaching or providing instructional materials which teach gender fluidity. He said that the policy would provide future guidelines to give guidance to district teachers and staff, to protect children and to ensure that the parental role was "paramount."

"Parents need to have full knowledge at all times about what is going on with their child," said Perez. Perez said that the policy emphasized communication and collaboration.

Two trustees – board veterans Rebecca Fox and Dawn Champagne – expressed their concerns about the policy, stating that the requirement for teachers to report conversations about gender identification issues to the parents of students would erode the trust between teachers and students. Champagne also said that disclosure of such information to parents could lead to safety issues for the student in some cases. Additionally, Champagne said that the burden of implementing the policy would fall on teachers, who already have enough to handle. Each of the two trustees further stated that she had not received any complaints from parents or teacher about the district's current policy, or lack thereof, to handle these issues.

"This is a solution in search of a problem," said Fox, who has served on the board for over 18 years. "What is the problem we are trying to solve?"

Board member Mary Ellen Cuzela responded that "This is called leadership" and that Katy ISD needed to "get ahead of the problem" in order to prevent situation like those which she said were occurring in states like Michigan where there were incidences of multiple rapes of young girls by transgender students who were using the girls' bathrooms. She did not cite the source of her data.

Board president Victor Perez thanked the board members for the "robust" discussion.

Other potential policy changes discussed during the work study meeting included:

- A possible change to the board's code

of ethics which would drop the requirement that the board's decisions be "fact based" rather than based on opinion

- Possible changes to the criteria used to evaluate the performance of the superintendent

Trustee Lance Redmon challenged the "red-lining" of these items, stating the board members should use facts to make decisions rather than relying on personal opinion; Perez responded that opinions of board members always influence their decisions, in addition to the facts under consideration. Redmon also questioned the changes to the criteria for the superintendent, stating that any employee needs to know in advance what criteria will be used to grade their performance during an evaluation period.

At the meeting, district general counsel Justin Graham also presented an option for trustees to consider in regard to the district's compliance with HB 3, which, in the wake of the gun violence at Uvalde and other campuses, requires an armed security officer at each campus by September 1st. Graham said that the district did not currently have these officer positions staffed – needing about 40 to 50 more officers -- and would not be able to meet the deadline.

The "good cause" exception request would be based on two factors: the lack of staff to fill the security officer positions and the financial impact of the requirement. Graham said that the district received a slight increase in the state allotment as well as \$15,000 per campus from the state for security upgrades but those funds must cover all security upgrades (such as the addition of entry vestibules to campus buildings) in addition to the hiring and equipping of peace officers. The best plan moving forward, said Graham, would be to hire Level 3 guards who would be trained and armed and stationed at each campus. A spokesperson for the Katy ISD police department said that this could be done by September 15th, although acquiring the necessary equipment for the officers could take up to 90 days. The board did not vote on this resolution but may consider it at their next regular meeting.

blood Elementary is located at 25600 Longenbaugh Road, Katy. Three existing campuses -- Katy Elementary at 5726 George Bush Avenue in Katy, Winborn Elementary at 22555 Prince George Lane in Katy and Schmalz Elementary at 18605 Green Land Way, Houston -- underwent renovations this summer, making the start of the school year even more exciting for some students.





Indigent Health Care Compensation Expenditures

The Waller County spent \$179,967 from July 1, 2022 to June 30, 2023 on indigent health care compensation expenditures in the increased minimum eligibility standards, less the amount of state assistance. For the current tax year, the amount of increase above last year's enhanced indigent health care expenditures is \$24,680. This increased the no-new-revenue maintenance and operations rate by \$0.000251/\$100.

TWC robotics grants inspire students to pursue STEM occupations

AUSTIN - Texas Workforce Commission (TWC) awarded more than \$2.3 million in grants for Youth Robotics programs, allowing more than 10,000 Texas high school students to participate in various events that lead to the world championship. This year, four applicants received awards: FIRST in Texas, Urban STEM, Collegiate Education, and BEST of Texas Robotics.

"Learning by doing is a tried-and-true educational strategy. These grants provide experiential learning opportunities for thousands of Texas students," said TWC Chairman Bryan Daniel. "The STEM skills students can gain from youth robotics competitions will provide them a great entry point into the Texas workforce."

The Youth Robotics Initiative encourages interest in science, technology, engineering, and mathematics (STEM) by expanding participation in robotics programs for high school students by developing new teams for robotics education competitions and supporting existing competitive teams. Additionally, this program removes barriers to participation for students from schools in underserved urban and rural communities. Each grantee also has teams comprised of students with disabilities.

"Texas employers are seeking the skills gained in youth robotics programs—from engineering and programming to soft skills like ingenuity and teamwork," said TWC Commissioner Representing Employers Aaron Demerson. "This is another example of how TWC provides early opportunities for youth to explore STEM and high-demand occupations sought by Texas employers."

The four grants total \$2,335,830 and will enable 10,634 students to participate in youth robotics this

upcoming year. The grantees include:

- Foundation For Inspiration & Recognition of Science & Technology in Texas (FIRST in Texas) received \$700,000 to serve 5,800 high school students in more than 350 teams—30 of those teams will be comprised of students with disabilities.

- Urban Science Technology Engineering Mathematics (Urban STEM) was awarded \$277,440 to serve 575 students in 25 teams—two of those teams will be comprised of students with disabilities.

- Collegiate Education was awarded \$699,290 for 140 students to participate in 36 teams—one team will be comprised of students with disabilities.

- BEST of Texas Robotics received \$659,100 to allow 4,119 students on 80 teams in their program—20 of those teams will be comprised of students with disabilities.

"Youth Robotics programs prepare high school students for a rewarding career in STEM-related industries across Texas," said TWC Commissioner Representing Labor Alberto Treviño III. "These grants create pathways by removing barriers for future Texans as we continue to focus on highly specialized training that will prepare the workforce for the future."

Teams that advance to the State Championship for each program will have the opportunity to move on to the World Championship arena. Robotics competitions bring together the excitement of sports, science, and technology.

Parent heads back to school alongside kids

HOUSTON — Children are not the only ones heading back to school this August. Many parents are also packing their backpacks and lunch bags and heading to campus.

One parent at Houston Community College-Coleman College for Health Sciences shares a common reason to complete their education.

Four weeks after graduating from the Dental Assisting program at HCC Coleman College, a mother of three is already heading back to campus.

"Even though I'm now a certified dental assistant, I was accepted into the Dental Hygiene program. Now I'm starting my first year of the program," said Maren Jensen of Katy, Texas.

The 35-year-old will once again begin her hour-long commute to the Texas Medical Center five days a week for the next two years. She will also continue working weekends and occasional weeknights as a barista until she graduates in May 2025.

Balancing work, study and family life can be exhausting and stressful at times, but Jensen is ready to be uncomfortable.

"I have to wake up at 5:45 just so I

can get on the highway at 6:15," Jensen said. "It takes me about an hour to get to school in the morning, and, depending when I get out, it can take an hour or hour-and-a-half before I get home, but it's all just part of the price you pay when you pursue a degree."

"There's a lot of sacrifice upfront," Jensen added, "but I'll have so many opportunities that weren't there before because of the education and skills I gain as a dental hygienist."

Everyone in Jensen's circle helps her while she attends college.

Jensen's fiancé drops off her 13-year-old daughter, 8-year-old daughter and 7-year-old son at school every weekday. Her friends and co-workers provide carpool support for her children after school. Her family also shares household responsibilities.

"A lot of household stuff, like

the cooking, cleaning and laundry, gets divided up by kids and fiancé," Jensen said. "I'm very grateful for the support system I have. This is how I'm able to find time to study. I shut myself in my bedroom, and that's become my study area at home."

Jensen's children do not divert her from her education. They, in fact, keep her on course.

"My kids are my biggest cheerleaders and my main motivation for going back to school," Jensen said. "What motivates me is knowing all my hard work will pay off one day, and I'll be able to share it with them."

Jensen, who overcame a difficult divorce five years ago, believes her college journey is teaching her children a life lesson.

"I really want my kids to see that whatever happens in life, you can always start over. You can always rebuild," she said.

ages more hiring of minority coaches around the league.

Edwards got the chance for multiple weeks in training camp and on top of that got chosen to participate with the Ravens, an organization he was ecstatic to work under — especially with a well run staff all the way from the general managers office to the position coaches.

“As an offensive coach, being able to sit in those rooms, listen to those conversations and see how they teach and go about things from a schematic standpoint, it was everything I could have ever asked for.” Edwards said. “Being able to implement some of those things they did and bring it down and help the kids at Paetow just makes

me a better coach, and will hopefully lead to our offense being even better. What I’m so excited about it.”

But the most important thing he took from his time with the Ravens came from watching longtime head coach John Harbaugh.

“The way he goes about his job and the way he manages things was the most insightful thing for me,” Edwards said. “He surrounds himself and hires good people — you can see how confident he is in them and that allows him to just manage everything. Those guys focus in and really work hard with the dudes and Harbaugh oversees the practice but trusts his coaches to do the job they were hired to do. Structurally and

organizationally I was just so impressed with everything there with the Ravens.”

The biggest thing for Edwards was taking what he learned and applying it to his current position, helping the Panthers be the best they can be. He has been working on that since he has gotten back and Edwards can’t wait for the team to show their progress when they get to the regular season.

“I’m so excited about it,” Edwards said. “We got talent here all over the place, both up front and at the skill positions and we have some really good pieces. We think this can be a really good offense we just have to keep at it and keep improving every day. That’s what it’s all about.”

NOTICE OF TAXPAYERS' RIGHT TO ELECTION TO REDUCE TAX RATE

UH earns highest preseason rank in its history

The University of Houston Volleyball team starts its season ranked at No. 19 in the American Volleyball Coaches Association/Taraflex Poll, the organization announced. The placement is Houston's highest preseason ranking in program history, with its other ranking being at No. 25 in 1993.

Head Coach David Rehr's squad will be tested early, starting its season in the Fertitta Center with a ranked matchup against No. 22 USC at 8 p.m., Aug. 25. The team's schedule also includes meetings against other currently ranked foes, including No.1 Texas

(Oct. 14, Oct. 15 in the Fertitta Center), No. 10 Kentucky (Sept. 8 in West Lafayette, Ind.), No. 15 Baylor (Nov. 22 in Waco, Texas) and No. 17 BYU (Sept. 20 in Provo, Utah), and four teams that are receiving votes (Kansas, UCF, TCU and Iowa State). The Cougars also have the potential to face off against No. 16 Purdue on Sept. 9. Houston visits #23 Rice for an exhibition match on Saturday at 5 p.m.

The Cougars are one of four Big 12 Conference teams to be ranked in the preseason poll and one of two conference newcomers. In total, eight Big 12 teams received votes in the poll. Houston was selected to finish sixth in the con-

ference by the league's coaches.

Houston returns both of its All-Americans from last season in senior libero Kate Georgiades, who also received preseason All-Big 12 honors, and graduate outside hitter Abbie Jackson. The pair are complemented by returning starters Rachel Tullos, Kellen Morin and Morgan Janda, as well as incoming transfers Katie Corelli (Ole Miss), Nena Mbonu (Louisville) and preseason All-Big 12 honoree Kenna Sauer (Texas Tech).

The Cougars finished last season at No. 17 in the AVCA poll, their highest final ranking in team history, joining another No. 17 placement in 1994.
