## **Board discusses expansion of book restrictions**

Designs presented for renovations to Katy High, Cimarron Elementary and **Nottingham Country Elementary**

Katy Independent School District's board of trustees met on Monday, August 19 for a work-study meeting in the boardroom at

6301 S. Stadium Drive in Katy. Fourteen speakers signed up to speak during public comments but only 11 of those spoke - all on one single agenda item - potential revisions to "EFB local," a local board policy which concerns library materials.

The proposed revision to the policy is the insertion of this text: "No materials in elementary and junior high libraries shall contain material adopting, promoting or supporting gender fluidity as defined in Local Policy FA. Material in any high school library collection that adopts, supports or promotes gender fluidity requires parental

opt-in for student access." A second new section of the policy - dealing with on-campus book fairs - was drafted as follows: "All vendors selected by the District shall adhere to the District's library guidelines and Board Policy. This includes vendors and fundraisers selected for book fairs or the distribution of literature."

The 11 speakers were almost evenly divided in favor of and against the proposed change, with six opposed and five in favor. LGBTQ+ activist and Katy native Cameron Samuels, who has organized nationally recognized efforts against book banning,

was present at the meeting but did not speak during public comments.

The board discussed the issue as the last agenda item of the evening, but the matter was a discussion item only and was not voted on in this meeting. Trustee Dawn Champagne asked why the policy was needed, stating that the matter was already covered under board policy FA local and that an additional revision would be redundant. Board president Victor Perez

## **Briones** holds 'virtual listening tour' session for **Precinct 4**

Harris County Precinct 4 Commissioner Lesley Briones and her staff conducted a "virtual listening tour" session via a Zoom call for residents of the precinct on August 15. Briones held 12 in-person listening sessions throughout the precinct last year, including two at the Katy campus of Houston Community College, 22910 Colonial Parkway. She will hold four inperson sessions in 2024, with the next on September 14 in Tomball, and one additional virtual session.

Briones reiterated her department's priorities as "good government," infrastructure, education and opportunities, public health and justice and safety. In the area of justice and safety, one of Briones' policy advisers provided a summary of the "Advancing Justice" package recently presented at commissioners court. The package will upgrade outdated technology in the courtrooms - some of which is more than ten years old -- and invest in critical courtroom needs and is designed to improve court appearance rates through expanding texts and other reminders to defendants as well as

#### FREEMAN HIGH SCHOOL AND NELSON JUNIOR HIGH OPEN



Freeman High School, which opened at 7800 Katy Hockley Rd. in Katy on August 14, is the tenth high school in Katy ISD and will serve the burgeoning population of the northwest quadrant of the district, relieving enrollment pressures on Paetow High School and Katy High School. The school is named for the Freeman family, deeply ingrained in Katy's history, who have been prominent in civic leadership, with members serving as mayor, city council members, and contributing to the volunteer fire department and school board. Beyond civic engagement, the Freeman's have a longstanding connection to agriculture and education, dating back to the late 19th century. The school's mascot will be the Golden Eagles. Freeman's principal is Gina Cobb.



Nelson Junior High School — the 18th and latest Katy ISD middle school – is also named for early Katy settlers. The Nelson family history spans across five generations in the Katy area, with family members having graduated from Katy ISD, served on the Board of Trustees, and been deeply involved in various district programs such as FFA. The Nelson's connection to the land that Nelson Junior High is built on is unique, since the family purchased the land generations ago from a beloved Katy ISD schoolteacher. Kara Morgan is the principal for the school, whose mascot is the Hawks. The campus is located at 25747 Longenbaugh Road in Katy, adjacent to Freeman High School and Youngblood Elementary.

using the Community Assistance Referral Program. Case management will be streamlined through optimizing case management systems. The "Advancing Justice" plan will continue to reduce the court backlog through expansion of the court staff and associate judge program. Mental health services are also included in the plan.

In the area of "good government," Briones noted that the precinct's website is now available in 12 languages. She provided an update for "listening tours" for 2024 and announced that public town halls on the county budget, first done last year would continue this year with additional sessions planned in August. The county will vote on the budget on September 10 prior to the start of the county's fiscal year on October 1.

Projects for health include a seven-point plan to save and strengthen HART (Holistic Assistance Response Team), a program that frees up time for law enforcement officers. Briones has championed the needs of nursing mothers, establishing three lactation pods in the county courthouse and updating Harris County policies for nursing employees. Through ACCESS Harris, the precinct has worked on programs for violence

prevention, Black maternal health, Latino chronic disease, and a diabetes prevention program.

On education and economic opportunities, Briones spoke of the improvement in the awarding of Harris County contracts to M/WBEs from under nine per cent to over 27 percent currently, noting that there were educational programs underway to educate small businesses on how to do business with the county. She also described the precinct's \$10.9 million program for apprenticeships, a \$6.2 million program focusing on domestic violence and a \$4.2 million national partnership for naturalization services in Harris

Briones said that she had doubled the size of the precinct's infrastructure team, and that the team has over 100 projects currently underway. Infrastructure projects in the Katy area included the East Katy Mobility project and "Sidewalks 4 Precinct 4," a \$20 million initiative which will build 50 miles of sidewalk, including some in the Mayde Creek area. Briones also announced that the "Places 4 People" project had partnered with other area entities such as cities, school districts and MUDs, to launch \$170 million for 32 projects in its first year, with \$88 million

coming from the county and \$82 million contributed by partner organizations. On September 14, the final workshop for the "All in 4 East Katy Community Plan" will be held from 2 to 4 p.m. at the Steve Radack Community Center at 18650 Clay Road in Houston.

Storm recovery efforts were also detailed. Following Hurricane Beryl, the precinct opened most community centers to serve as cooling centers; two centers also served as distribution centers, providing food, water and ice to over 6,100 residents. Road and bridge crews cleared over 25,000 cubic yards of debris, more than 1,840 truckloads. The precinct responded to over 3,000 service requests from area residents.

In the "question and answer" portion of the meeting, the first questions were for the FEMA representative regarding specialized equipment for the disabled, the FEMA application process and the filing of false claims. Other questions concerned the free classes offered at the precinct's community centers, what the precinct is doing for residents of the precinct who live in the City of Houston rather than in the unincorporated areas, and the priorities for renovating county parks.

said the revision to the policy was needed since FA local only deals with classroom instructional materials while EFB local deals specifically with library materials. Both Champagne and board member Rebecca Fox questioned Perez about the release of the board agenda item on social media over the weekend by Perez' wife, Karen. Perez said that the matter was a misunderstanding and that he thought that the agenda had been made public on Friday. Board members discussed how books are removed from KISD libraries and how the proposed new policy would be enforced with vendors and other procedural issues. Fox asked, "Are we done with this yet?" and said that she has heard lots of feedback on the book issue and that it is dividing the community, calling it "a hornet's nest, it's political" and "it's making people angry on both sides." Perez disagreed that it was a political matter. Fox called for the board to focus on academics and to include academic programs and updates as part of each board meeting agenda, suggesting that the first program cover the Miller Career Center.

The board also heard from KISD CFO Chris Smith on the proposed tax rate and the budget for the coming 2024-2025 school year. Smith said that the tax rate would hold steady at \$0.7271 cents for general/M&O and \$0.39 for I&S (interest and sinking). Smith also said that planning for the next budget cycle would begin as early as October and would include closely monitoring all expenditures; planning for growth in staffing and operations; and the opening of two new campuses (elementary schools 47 and 48). Smith said that while the State legislature will be going into session in January, that would not bring budgetary relief to the district since any changes in state funding would likely not be approved until May and would not take effect before July. "We have to plan under


current law," he said.

Lisa Kassman, KISD executive director of facilities, planning, and construction, together with representatives from VLK Architects, presented design plans for the renovations planned at Katy High School, 6331 Highway Blvd. in Katy, for the band and orchestra building and the vocational hall. The band building was originally built in 1952 and "it's time," said the VLK representative. Improvements to the building will include the addition of a loading dock, an exterior restroom for the convenience of tennis athletes who practice nearby, improved instrument storage, new large and small practice rooms and a new mud room. A new display case will hold trophies and historical artifacts. A new 64-space parking lot will accommodate parking spaces removed during construction. Completion date for the project is December 2025.

The V-hall, which houses engineering, architecture, digital art, and medical prep classes, will increase from 12 to 16 classrooms and will have an improved maker space and a suite of computer labs. It is slated for completion in July 2025

Cimarron Elementary at 1100 S. Peek in Katy and Nottingham Elementary at 20500 Kingsland Blvd. in Katy will be renovated to include improved security measures at the front entrances, lobbies and administrative offices and will include public restrooms accessible from the lobby. The Nottingham Country Elementary project will also include remodeling of the school's "open concept" library, installing glass walls in order to provide greater security with the ability to lock down the area if necessary, and to reduce noise levels in the area. The projects are scheduled for completion in July 2025.

The next meeting of the board – a regular board meeting – will be August 26.



"We have to be confident



"When you go against these types of teams, you can't have those little mistakes that you may get away with against a lesser team and that's what we had to learn this week," said Cinco Ranch head coach Danielle Wells. 

## Four from Katy ISD named to Touchdown Club of Houston preseason team

Four Katy ISD football players were named to the Touchdown Club of Houston High School Preseason Team, as the school district was well represented at the event.

Jordan's Andrew Marsh and Chad Gasper were named to the team on the offensive side, while Katy's Adam Carter earned honors as a punter and Paetow's Deyjhon Pettaway was named to the team on the defensive side.

All four were recognized at the Touchdown Club of Houston dinner on Aug. 14 at the Bayou City Event Center, 9402 Knight Road in Houston.

Marsh comes off a huge junior season where he caught 65 passes for 1,158 yards and 15 touchdowns, averaging over 100 yards per game receiving. Gasper carried the ball 99 times in eight games and had 11 touchdowns on the ground while adding 195 yards and a touchdown receiving. The duo helped Jordan clinch its first ever playoff berth.

Carter was one of the top punters in the state last year, averaging 42.44 yards per punt as a junior with three punts that went over 60 yards and five punts over 50 yards, earning All-State honors in the process. Carter was a big part of Katy's district title team both as a

defensive lineman and a punter. Pettaway was one of the top defensive backs in the entire state last year and was the leader of a Paetow defense that was one of the strongest in the area. He did not allow a touchdown in coverage last year while registering 80 tackles, four pass breakups and an interception.

The Touchdown Club is the Houston chapter of the National Football Foundation. Founded in 1947 with leadership from General Douglas MacArthur, legendary Army coach Earl "Red" Blaik and immortal journalist Grantland Rice, the National Football Foundation & College Hall of Fame, a non-profit educational organization, organizes programs designed to use the importance of high school football in developing scholarship, citizenship and athletic achievement for young people.

## **UH's Donovan Smith named** to Manning Award Watch List

University of Houston senior Donovan Smith has been recognized among college football's top quarterbacks entering the 2024 season with his inclusion on the Manning Award Preseason Watch List, presented by the Allstate Sugar Bowl, announced Thursday.

This season's preseason list recognized 29 quarterbacks. The winner will again be selected by a voting panel, which includes national media and each of the Mannings, after the postseason.

Smith, a Las Vegas native, has been among the nation's elite dual-threat

quarterbacks during his career. Smith is one of six active Power 4 quarterbacks with 15+ rush touchdowns and 40+ passing touchdowns since 2021. His six games with a 75% completion rate (min. 15 attempts) since 2021 rank fifth nationally among active Power 4 QBs and his 15 deep-pass TDs (20+ yards) since 2021 rank second among current Big 12 Conference signal callers.

In 2023, Smith completed 256 of 397 passes for 2,801 yards and 22 touchdowns. His 64.5 completion % ranked third in the Big 12. In 2023, Smith became one of four UH quarterbacks (Case Keenum, Clayton Tune and Greg Ward

Jr.) in last 20 years with 250+ completions, 2,500+ passing yards, 20+ passing touchdowns and 5+ rushing scores in a single season.

The Manning Award was created by the Allstate Sugar Bowl in honor of the college football accomplishments of Archie, Peyton and Eli Manning. It is the only quarterback award that includes the candidates' postseason performances in its balloting.

The Big 12 and SEC led the way with six selections, followed by the ACC with five. In its first 20 years, the Manning Award has recognized the top names in college football.

## Rice's Banks named to Lombardi Award Watch List

Rice tackle Brant Banks is one of 90 of the nation's top linemen and linebackers who have been named to the initial watch list for the 51st Lombardi Award which was released by the Lombardi Award Committee on Thursday.

Banks is entering his second season as a starter on the Rice offensive line, having started all 13 games in 2022 at guard before moving to right tackle this season. He led the offensive line with 845 offensive snaps last year and comes into this season as a preseason secondteam All-AAC selection by both Athlon Sports and Phil Steele.

He prepped at Houston's Westbury Christian before signing with Nebraska in 2019. He played in 26 games in his career with the Huskers, including all 12 in 2022 before coming to Rice as a grad transfer.

The Lombardi Award™ was established in 1970, in memory of legendary coach Vince Lombardi. It is presented to outstanding linemen who best epitomize his values of leadership, courage, performance, and discipline on and off the field. Furthermore, the watchlist includes players who are consistently showing the values of strength, agility, and football acumen in their respective positions.

The 2024 award dinner will take place on December 11, 2024, and net proceeds from gala sponsorship and table sales are dedicated to supporting cancer research and families and patients battling cancer.

practice and film so to come out here and put a good performance together was great," said senior quarterback Justin Thierheimer. "There's still some things we have to work on and we are going to keep perfecting it, but this was great. We just have to keep getting ready for that first game."

Tompkins got some good experience from the scrimmage on both sides. The second-string offense grew more comfortable the further into the scrimmage it got and the defense refined its coverages and communications. While it wasn't perfect by any means, both sides continued to grow and learn as we get closer to the

"I really liked how focused our defense was - we really had the communication that we needed and got lined up correct," said Tompkins head coach Todd McVey. "We had one snafu on a communication but you have to understand that not everything will be perfect the first time out and they practice too — they're going to make plays. It's about how you respond after that and I thought we did a good job of doing that. The kids learned from it and got better."

One of the biggest bright spots from the scrimmage was the work that three of Tompkins running backs did. Ronnie Quinn, Robert Bernard and Phoenix Smith all made big plays and continue to look like a trio that could be counted on this season.

"It keeps them all hungry and having that healthy competition while keeping them healthy as well is great," McVey said. "The guys are working and pushing each other and they all ran well today. Having fresh bodies is huge — you can never have too much depth at a position so it's good to see all three of them stepping up."

Tompkins will have another scrimmage this week before they enter the season, and they hope to build on things and continue to grow. The goal is to get one percent better every day and they continue to hold them-

selves to that standard. "Everyone just has to keep doing their job," Thierheimer said. "We have a game plan every week and everyone has to do certain things. As long as we stick to that and keep working, we are going to have a good year. We just have to hold each other accountable and keep doing it all season."
