Things got trickier in the third set as Ridge Point fought to keep its season alive. Kone and Goertz were both huge parts of the win. Kone did a tremendous job of controlling the middle and making plays when her number was called, while Goertz was tremendous in serve receive and put away a number of kills for the Cougars. But it wasn't just those two. It was a complete team effort and one that the entire team was a part of.

an) who comes in and helps with our setter and even more than that, our backcourt, no matter who is back there, they all have good ball control and get the ball to someone that can hit it," said Cinco Ranch head coach Danielle Wells. "We just have so many girls who will all go out there and get the job done when asked. And Rahima did a tremendous job against their power outside hitters in the middle."

Cinco Ranch advances to play Fulshear in the regional final in what will be one of the Cougars' biggest tests

of the year. But for these players, it isn't anything new and they know they have the talent to get the job done.

We have to come out and play our best volleyball, it is going to be a really good match," Wells said. "We just have to stay in our serve-receive and be smart. We don't have to be perfect, we just have to be smart with our decisions. We did a great job of that tonight and we just have to do that again against Fulshear."
