

ARE YOU VOTE READY?

Early Voting Runs Oct. 13-30, 2020

Williamson County Elections officials want all registered voters to be "vote ready" for the November 3 election. This means reviewing your ballot, making a plan for when and where to vote, and bringing your ID.

Sample ballots are available now on the Elections website at https://apps.wilco.org/elections/default.aspx. Voters can mark their paper sample ballot to take into the polling location. Mobile phones cannot be brought out and used to review or check information while in the polling location.

Early voting begins Tuesday, Oct. 13, and runs through Friday, Oct. 30. Polls are open from 7 a.m. to 7 p.m., except on Sundays when they are open from 1 p.m. to 6 p.m. Early voting locations are listed on the website at https://www.wilco.org/Departments/Elections/Voting-in-Person/Early-Voting and below.

On Election Day, Tuesday, November 3, polling locations are open from 7 a.m. to 7 p.m. Any Williamson County registered voter can vote at any of Williamson County's 57 Vote Center locations. A list of election day Vote Centers can be found here: https://www.wilco.org/Departments/Elections/Voting-in-Person/Election-Day and below.

Remember to bring one of the seven acceptable forms of photo ID with you when you go to vote. See Voter ID FAQs.

For those who have requested Ballot by Mail, the Williamson County Elections Department has begun mailing out those ballots. The deadline to apply is Friday, Oct. 23, 2020. To apply, go to https://www.wilco.org/Departments/ Elections/Voting-By-Mail. Ballots may be returned by mail, contract carrier or voters may hand deliver only their own marked mail ballot to the Elections Department, 301 S.E. Inner Loop, Georgetown, Texas, during regular business hours and extended hours during Early Voting and on Election Day. Photo ID laws are applicable to all voters that hand deliver their ballots and voters hand delivering a mail ballot must also sign a roster. Ballots may be hand-delivered as soon as it has been received and voted. Voters can track the status of their ballot at https://www.wilco.org/BBMstatus.

Safety protocols will be followed in all voting locations. Poll workers will be required to wear a face covering, and voters are strongly encouraged to wear them as well. Distancing of equipment and those standing in line will be used to avoid people standing closer than 6 feet to one another. Hand sanitizer will be available to use. MAYOR



JIM RICHARDSON

My name is Jim Richardson. I have worked for a fortune 500 company for over 38 years doing electrical engineering and project management. My family and I have lived in Cedar Park for over 22 years. I served as our HOA President for 7 years and am a Republican precinct chair for Pct 287.

How will you make City Council meetings less divisive?

I do not agree with my opponent politicizing issues he disagrees with. Our city needs a Council that can function effectively under good experienced leadership to do its job, and not waste valuable time. We need to turn down the politics in Cedar Park and focus on making great decisions for our residents. Every Council member deserves to be treated with respect and to be heard.

What is the biggest priority for Cedar Park's growth?

The biggest priority for Cedar Park is balancing the needs of our citizens with the desires of our developers as we build out the rest of the undeveloped land in the city. Growth must be managed effectively. Also, traffic needs to be better managed to facilitate the flow of traffic instead of restricting it. We need a plan for another east west thoroughfare that would run all the way to IH35 to relieve congestion on 1431.

What is the biggest priority for post-COVID-19 recovery in the

Our local businesses are suffering as this pandemic continues. I will focus on creative ways to help

them. One possibility would be taking a hard look at possible local tax breaks for them during this crisis.

In your opinion, what is the most important issue in this race?

It is critical to stop Austin from creeping into Cedar Park and negatively influencing our wonderful city by bringing its progressive, liberal agendas here. Unlike Austin, I will never defund the police and will fully fund ALL of our first responders. I will work to keep Cedar Park the healthy, vibrant community we all know and love.

How are you the candidate best suited to address these questions?

The current mayor has wasted the City Councils' time on political divisiveness and criticism of other Council members. I will not waste the Councils' valuable time on political posturing and punitive political measures. Instead, I will keep the focus on handling the important business of running the city as we look to the future.

Why should we vote for you?

I have the capabilities and leadership qualities that Cedar Park is in dire need of. I will take the political infighting out of the business of the City Council and will work with all Council members to facilitate good, citizen-oriented decisions and get the important work done efficiently and with civility.



CORBIN VAN ARSDALE (I)

I'm a 5th-generation Texan. Stephanie and I have five children. I'm the current Mayor, and a former council member and state legislator. I'm president of a statewide business association. I graduated from UT-Austin with degrees in Finance and Law—and lettered in baseball. I've lived in Cedar Park ten years.

How will you make City Council meetings less divisive?

By changing our ordinances and charter to create consequences for those council members who publicly and personally attack or threaten residents, staff, and fellow council members. This outrageous behavior we've experienced the last year from two of our council members has been a first for me since I've been on council. It was frustrating not to be able to enforce consequences because our charter doesn't address those types of things. I look forward to changing that. In an effort to decrease the divisiveness, I will also continue to do more of what I've been doing by simply remaining calm and focused on what's best for Cedar Park. Getting caught up in divisive attention grabs is never the best thing for our city.

What is the biggest priority for Cedar Park's growth?

Cedar Park has little land left. So every development creates two issues: (a) how will it diversify the property tax base for our current residents, and (b) how will it create friction with current, surrounding developments? We will handle each of these through our Planning & Zoning process and our council's Future Land Use Petition Process by openly communicating with our residents.

What is the biggest priority for post-COVID-19 recovery in the City?

We must do everything we can to help our local businesses survive. COVID-19 is the most challenging thing I've had to handle in public service. It's uncertain, it's demanding, it's unprecedented, and it constantly divides our residents—who have deeply personal and individualized opinions and beliefs about every decision being made about it. It obviously impacts our revenues, which in turn impact our ability to provide services. But our businesses are our lifeblood. We have helped them, and we must continue to do so.

In your opinion, what is the most important issue in this race?

The Cedar Park city elections really aren't that complicated. If you vote for the extremists, the

council will be controlled by one political party's extremist wing led by Council Member Tim Kellythe most divisive representation this city has ever seen. Or you can vote for our city council to be controlled by the residents of Cedar Park. I believe in our residents—their efforts to unify our city in this crazy year have been heart-warming. During COVID, I have witnessed our residents come together to help each other, and I know this represents the majority of our city. I feel strongly about all residents having a voice. We represent the people. We should not be controlled by any political party, not by any one individual, and certainly not by fringe extremists. This is an important election, where precisely this issue will be decided for Cedar Park. Our city is voting for UNITY—or it's voting for DIVISION. It's really that simple.

How are you the candidate best suited to address these ques-

In the seven years I've served on the council, including currently as Mayor, I've always listened to all of our residents—not just those that live where I do or who think exactly like I do. I don't pander to political parties, and I don't try to tell the other council members what to do. I reject the extremists in both parties. That's what a mayor is supposed to do. My opponent has done the exact opposite of this.

Why should we vote for you?

I've been serving our city the last 10 years – as Mayor, as a council member, and as a board member - working hard to help build Cedar Park into what it is today. Our Cedar Park community is consistently ranked as one of the best and safest places to live in Texas and in the US. People are moving here. Employers are moving here. Our staff loves working here. And with COVID uncertainties and complexities still very much being worked through, this is not the time to put someone with zero city experience into the mayor position. Listening, knowledge, discipline, stamina, non-partisanship, and a steady hand are what our city needs right now as mayor.

PLACE TWO



MEL KIRKLAND

I have lived in Forest Oaks in Cedar Park since 2005. I have own a business that provides project development and implementation services for the landscaping industry. I also volunteer for the city and several charities in the community. Starting in late 2005 with the Tourism Advisory Board, the Community Development Corporation (4B), and the City Charter Review Board. I currently serve on the City Council, and serve as the Mayor Pro-Tem, and am a member of the Economic Development Subcommittee, the Brushy Creek Regional Utility Board, and Capitol Area Council of Gov'ts. I am also the council liaison of Library Foundation Board, the past President of the Forest Oaks HOA, and a volunteer with LEEF. Reveal Resource Center, Heroes Night Out, the 100Club, the Labybird Wildflower Center, NPSOT, and TNLA.

How will you make City Council meetings less divisive?

Unfortunately there isn't a lot you can do to keep someone that is insistent upon creating division on our dais or in our community tamed. But I can choose how I respond. If I respond recklessly it will only escalate the negative attention it brings to our community. So I have try to do the opposite. I have ignored the personal attacks and do my best to turn negative comments into positive messages for our community. I stick to what is true and do what I can to deescalate the rhetoric because I feel like that is what our residents deserve. I do hope that we are able to put some consequences for councilmen that choose to attack our residents into our charter in the very near future, but until then I will keep fighting to keep the negativity and toxic behavior the best way I know how. Cedar Park is better than that and as a leader in this community, it is my

job to make sure I'm representing all of the residents positively to counter the negativity.

What is the biggest priority for Cedar Park's growth?

We need to represent, support and protect our citizens while allowing all to enjoy the Cedar Park experience. The biggest issue for Cedar Park is continuing to grow and diversifying our economy by bringing good quality employers to Cedar Park. Business growth adds jobs and taxes. The taxes generated allows city government to lower the tax rate for homeowners.

What is the biggest priority for post-COVID-19 recovery in the City?

The city doesn't make the rules, we follow the guidance provided by the Governor's office and our two county judges. The biggest priority is making sure that we can open up responsibly. We must work with our business community to help bring awareness about the services provided by our local business owners, help them network with other

business and pursue policies and marketing strategies that promote consumer activities.

In your opinion, what is the most important issue in this race?

The most important issue we are facing is who will represented. We have people on council who do not support or represent all of the residents. They believe they should only have to resent those that voted for them. They prefer state and national issues over the needs of the residents and business. When I am re-elected I will request several changes to our city charter that clarifies the terms under which a council member serves and place consequences for poor actions.

How are you the candidate best suited to address these questions?

I believe that my experience and personality gives me the ability to work with others. Nothing can progress forward by itself. I have a proven track record of working through complex city issues and finding the best solutions for our citizens.

Why should we vote for you?

Having conversations about our GREAT community is one of my favorite things to do. Making myself available in the community and listening to all before making decisions that affect them is one of my top priorities. You should vote for me because I always put the interest of residents and business before anything else. How will you make City Council meetings less divisive?

My opponent has been the leader of the divisiveness. He has wasted countless amounts of tax-payer money and countless hours of wasted city council meetings on a personal vendetta against other councilors. Eric Boyce, 14-year Cedar Park resident, local business owner; served on Economic Development Board, Planning & Zoning Commission, LEEF Board, Chamber Legislative Committee, Chamber Small Business Assistance program, Volunteer @ Reveal Resource Center.

How will you make City Council meetings less divisive?

Start with an inherently collegial and open-minded approach, focus conversation solely on what represents the best interests of the city, and address divisions and differences of opinion with humility, direct dialogue and critical conversation using approaches learned during my Leadership Austin Essential program. I will also attempt to diffuse adverse citizen communication by promoting ongoing email/phone access, scheduled office hours, quarterly council town hall meetings, as well as online chat sessions, presence at HOA meetings, chamber events and at other city activities.

What is the biggest priority for Cedar Park's growth?

The priority is threefold...(1) The impact of rising home values on housing affordability, property taxes and in managing city budgets; 2) Scaling infrastructure and improving mobility amidst our continuing growth; 3) Execution on existing community development projects as well as active business attraction and retention efforts to help diversify the tax base and keep property tax rates low.

I believe in data-driven analysis coupled with active dialogue with stakeholders to address the expansion of the city's infrastructure, address safety, mobility and livability for our citizens, as well as supporting economic development.

What is the biggest priority for post-COVID-19 recovery in the City?

Small businesses, which employ many citizens, have been greatly impacted by COVID-19. First, I will be motivated to help existing businesses retain primary jobs, access resources and connections for support and future growth. Furthermore, the burdens on local non-profit organizations have increased, and I believe my role can help generate both helpful connections and positive communication.









What are you willing to do to make sure that racial issues within the district are addressed and resolved?

If this question were posed to me as a school board member then I would endeavor to have a conversation with all of the involved parties to better define the words "issue" and "resolved". Some issues, such as access to programs or support systems can be handled through better policies. However, it is my experience that many issues are personal, and resolutions are varied and specific. Policies tend to be rather impersonal and generic, making them insufficient tools

when it comes to actually resolving issues. The method of resolution and restoration I prefer is much more time-intensive, but that is what I am willing to do, spend the time necessary to fully understand the people expressing these issues and work towards an actual resolution based on the specific situation.

In your opinion, what is the most important issue in this race?

As with question 3, it is almost impossible to have a "most important" issue when you have so much interdependence that must happen for a school district to achieve success. I believe one of the most pressing needs in front of us is supporting teachers in this era of virtual/in-person school, especially our secondary teachers. Some of that support could be financial, which brings attention to our \$40m+ budget deficit. Solving the budget does not necessarily support our teachers, but it is easy to see how the two are related. And the entire reason we exist as an organization is the education of children, which is at stake due to both of the above. So students, teachers, and sustainable budget are the most important issue in this race.

How are you the candidate best suited to address these questions?

I have spent the last 10 years working with leaders in the community across multiple Central Texas communities, bringing focus to the values and issues that they share rather than the opinions where they differ. This work of creative compromise where we all move a little closer to the results that we truly want is experience that will transfer to the work of a School Trustee. I believe that when it comes to the future of our children we all share much more in common than in opposition. I will work to bring our community together, so that we spend our energy engaging the issues before us, not the people beside us.

WILLIAMSON COUNTY CANDIDATES

COUNTY SHERIFF



ROBERT CHODY (R-I)

I am a husband, father, & veteran. I came here in 1996 to the Austin PD. I graduated from the FBI National Academy and the Law Enforcement Management Institute of Texas. I now proudly serve as Williamson County Sheriff.

What policing reforms will you work for within the department?

In the current climate and use of force concerns, the Sheriff's Department has registered to be part of the FBI's Use-of-Force reporting system. This is not mandated. We are in the final stages of recognition by the CALEA program that demonstrates the agency's practice of best policy and procedures available. This is a national program that at the time of entry, only 4 Sheriff's Offices in Texas were affiliated.

Will you consider implementing a civil service program for sheriff's office employees?

As an APD officer, I was afforded the protection of civil service. The county civil service programs fall under different rules and laws. I do not oppose it.

Please expand on your answer (why or why not?).

I do not oppose Civil Service in the Sheriff's Office but I see the pros and cons to the community. A problematic officer may be terminated, but under Civil Service protections, they would be rehired, though that is rare.

In your opinion, what is the most important issue in this race?

The idea of defunding the police is in the news. Austin has taken the lead. And my opponent is support-

ed by an organization that has led the efforts of APD's defunding. That is a serious conflict for a person running for the top law enforcement position in the county.

How are you the candidate best suited to address these questions?

My opponent had a chance to solve these problems when he was a top officer in the Department. But most people see that the Department was a mess at that time, and we have had tremendous success recovering from those days.

Why should we vote for you?

My opponent served in the previous administration so it is easy to compare our work:

Better Response Times: Before I came to office, and under my opponent's leadership, he had response times between 21-28 minutes. That is far worse than the national average. As of last year, we had pushed priority response times down to just over 11 minutes. And we are still improving.

New Cold Case unit: Already, two victims have been identified – one from 40 years ago and another from 30 years ago. We have over 24 volunteer cold case experts who work daily at no cost to the taxpayer.

New Drone Program at No Cost to Taxpayers: More than 20 drones in our fleet (some with night vision) to find lost citizens, or to view crime scenes from above.

Increased K-9 coverage: We bought more trained K-9s so that we now have 24-hour coverage which was not available in the prior administration.



MIKE GLEASON (D)

My name is Mike Gleason, I have been in Williamson County Since 1991, and prior to that in North Austin since 1967. I currently live with my family in the unincorporated area of Williamson County in Cedar Park. I started with the Williamson County Sheriff's Office in 1993 as a Correctional Officer in the Jail. I then promoted through the ranks until I retired as Assistant Chief Deputy.

What policing reforms will you work for within the department?

The policing reforms I will work toward in the Sheriff's Office is better training. Currently the Training Facility is out of Compliance by the Texas Commission on Law Enforcement. The vast number of vacancies at the Sheriff's Office has caused the current administration to "fast track" the Cadets and place them on the street before they are ready, thus incurring the numerous Use of Force and Fail to train lawsuits in the County. I will also reinstate The nationally recognized and award winning Crisis Intervention Team. This team was disbanded by the current Sheriff and no continuous Mental Health Services are available to the citizens.

Will you consider implementing a civil service program for sheriff's office employees?

Yes.

Please expand on your answer (why or why not?).

I will implement a program to give employees job protection, due process, and a fail and equitable promotional process. This may or may not be done solely with Civil Service but with a combination of Meet and Confer, Collective Bargaining and the such, whichever provides the best avenue for our employees. Due process and protection for our employees, they come to work everyday wondering if it will be their last, due to the cronyism and the dismissal of some 250 plus employees to date.

How are you the candidate best suited to address these questions?

I am the best candidate because I have decades more criminal law experience than my opponent. I worked and commanded every Bureau of the Sheriff's Office, my opponent has not.

Why should we vote for you?

I have the credentials and historical working knowledge of the Sheriff's Office, and I am not currently under Felony Criminal Indictment.

COUNTY ATTORNEY



DEE HOBBS (R-I)

I have lived in the county for 41 years. I graduated Hutto High School, University of Texas at Austin, and Baylor School of Law. I have worked in the county attorney's office since September 2001 and was first elected in 2012, took office in 2013.

What is the central function of the county attorney.

Everything except advising the commissioners court or prosecuting adult felonies. The duties include: advise elected officials, represents CPS/APS, mental health commitments/guardianships, PIA requests, all juvenile offenders, all Justice Court cases, truancy, adult misdemeanor offenses, protective orders, run diversion programs, veterans court, and DWI/Drug Court.

What lee way do you believe you have to do what you believe is your job?

The job must be done in accordance with the Constitution, Federal and State laws, the oath, and rules of ethics. The only "leeway" is the level of customer service and professionalism with which you choose to perform those duties. I see the above requirements as unwavering.

Can the relationship between the County Attorney's office and the Commissioners Court be repaired?

The commissioners wanted to employ their own attorneys prior to my administration. That will not change regardless of who is elected. However, the court does rely on us for assistance and we assist. Overall, the commissioners' court is less than 2% of what this job entails.

In your opinion, what is the most important issue in this race?

Which candidate can do the ACTUAL job of County Attorney. Covid-19 has placed many the office is to serve in greater danger than ever before. Those dealing with mental health and depression, children and senior adults in abusive or neglectful situations, and individuals suffering in domestic violence situations.

How are you the candidate best suited to address these questions?

I have a proven track record of innovative ways to address issues handled by the County Attorney's Office and have helped those most vulnerable. I focus on those that I serve and I am the only candidate even addressing what the office actually does for the community.

Why should we vote for you?

I am passionate about the job. I am honest with the voters on what the job is, how I do the job, what I see as the biggest needs for the community, and I have explained HOW I plan on continuing to improve the community.



STAN O. SPRINGERLY (D)

I graduated from SMU Law in 1999, worked with the Smith County District Attorney, and am now an assistant counsel to the Williamson County Commissioners Court since 2014. My wife and I have two daughters and reside in Cedar Park.

What is the central function of the county attorney?

The county attorney oversees a vast array of cases in the legal system, including misdemeanors, family protective orders and CPS matters, mental health commitments, juvenile law, and generally advising all officials while representing the county.

What lee way do you believe you have to do what you believe is your ioh?

Although there is prosecutorial discretion to accept cases, it is paramount that the county attorney follows the law and ethics, especially the U.S. Constitution and Bill of Rights. While the county attorney may work with budget writers to recommend overall policy goals, the county attorney is not a policymaker.

Can the relationship between the County Attorney's office and the Commissioners Court be repaired?

I am the best-positioned candidate to repair this relationship and move the county forward since I currently work with commissioners and have over my government law career effectively served with members from both major political parties in a non-partisan way.

In your opinion, what is the most important issue in this race?

Integrity and the removal of political kingdom building from the office is the primary issue. While there are many relevant examples, including my opponent's lawsuit against the very commissioners court he is supposed to represent over a budget dispute, the most egregious is the fact that Mr. Hobbs gave the highest staff salary plus benefits to an Austin trial lawyer who maintained a fulltime private practice and is now indicted in the tampering with evidence case involving the tragic death of Javier Ambler.

How are you the candidate best suited to address these questions?

I have an understanding of government law while my opponent is primarily a criminal lawyer. I am prepared to manage the county attorney's office based on my experience as the former appointed county attorney in Tyler, Texas where I advised all department heads and elected officials over both civil and criminal law matters. I have managed legal divisions such as family law and mental health and advised the juvenile board and counsel of judges in a growing county like Smith County. I also have the diplomatic skills and temperament to restore effective management, reduce turnover rates, and work with others to accomplish goals.

Why should we vote for you?

I have extensive experience in the legal field for 30 years (10 as a paralegal/law clerk and 20 as an attorney) and I find public service rewarding. Everything I have done has prepared me for this job. As a local resident and taxpayer, I want to use my experience and skillset to improve our local government and help the county through its growing pains. Ultimately, however, it is about providing a better world for my daughters and restoring checks and balances in the county attorney's office.

CONSTABLE, PRECINCT 2



JEFF ANDERSON (R)

I am married, have 4 children, and 6 grandchildren. I have lived in Leander since 1990. We have been members of Victory Baptist Church in Cedar Park for 25 years. I am retired from the Travis County Sheriff's Office and the US Air Force Reserves. I am a small business owner, and a licensed real estate agent.

What is the most important function of the constable?

The most important function of the constable is to serve legal documents as required by the civil court system. Examples of a citation include intent to sue, eviction of tenants who do not pay their rent, or subpoenas issued by the court. Though most of a constable's duties involve civil cases, they also work with the criminal court system.

Should a constable spend time in traffic control and enforcement? Why or why not?

Yes and no. The most important function of the constable is to serve legal documents. Yet, while the Constables Office is not involved in civil process they should be active in serving the community. Traffic enforcement plays a key role protecting the lives of drivers, and

compliance with the Texas Transportation Code.

In your opinion, what is the most important issue in this race?

A crucial issue in this race rests within the court system – specifically in the high number of defendants that fail to show up for scheduled court appearances. When this happens, it not only disrupts the court docket, but it also contributes to additional court actions such as failure to appear or contempt of court proceedings. The Constable's Office will assist the court system by helping the court locate persons whose presence in court is required. Our county is growing quickly. I will work to ensure that more personnel are added to the Office as the county grows to alleviate court related issues.

How are you the candidate best suited to address these questions?

My strongest qualification is my breadth of leadership experience. I have 29 years of Law Enforcement experience and spent 27 years in the US Air Force Reserves. I am a graduate of Sam Houston States Leadership Command College - Law Enforcement Management Institute of Texas. I am a graduate of FBI - Law Enforcement Executive Development. MIKE GUEVARA (R)

I am a follower of Jesus Christ.
Born in Dallas to a Dallas Police Officer and a nurse with the Dallas Independent School District. Received my BA from Mid America Nazarene University and JD from The University of Texas School of Law. Represented Texas cities for over 20 years. Current Council member in Cedar Park. Lived in Cedar Park for 20 years this coming January.

What policing reforms will you vote for?

In my representation of Texas municipalities I have written and revised multiple police policies including policies regarding use of force. The policies are not biased toward any race, ethnicity, gender, or religion. Resources are often the key to effective policing. A perfect example is the recent hostage situation in Cedar Park. The Cedar Park Police Department, with the assistance from many other local law enforcement agencies, peacefully resolved a potentially deadly situation. Many smaller agencies lack the resources larger cities like Cedar Park have for training. I would like to see de-escalation training increased with the state using its resources to help county and municipal departments obtain such training.

What does the Texas Legislature need to do to help Williamson County recover from COVID-19?

Williamson County has not seen the economic hardship that many other areas of the state have experienced. The key to economic recovery and continued growth is for the state government to support the free market system that has built Texas as the 10th biggest economy in the world. Business owners and entrepreneurs hold the key to recovery, not the government. We call it, the Texas Miracle.

What will you support to bring economic development to Williamson County?

Local governments have many tools that help support economic development. I will work to make sure that those tools are still available to cities and counties. As an attorney representing municipalities, I have worked on numerous economic development agreements through economic development corporations, municipal development corporations, Local Government Code Ch. 380 agreements, **Tax Increment Reinvestment Zones** and Public Improvement Districts. In your opinion, what is the most important issue in this race?

Community Safety. Our neighbor to the southeast partially defunded their police department. We have all seen for ourselves or heard from our neighbors what it is like to go to downtown Austin right now. Billboards warning people as they enter Austin. A small part of Austin is in House District 136. As a Council member, I was contacted by several constituents who were immediately concerned about the border area between Cedar Park and

Austin. In Cedar Park our Council unanimously voted to increase our police department budget and add an officer. We are nation of laws. Without them we have no nation, no states, no counties, and no cities. I have also worked with police departments all over the state and have reviewed thousands of videos of officers in the course of their duties. My opponent has provided funding to an organization that has "Imagine a World Without Police" on their website with "Defund APD" under that statement. Part of Austin is in House District 136. He assisted an organization who has lobbied for the defunding of law enforcement in a city in his district. Are Cedar Park, Leander, Round Rock and Williamson County next?

Why should we vote for you?

I follow the Biblical principles on which this country was formed and support both the United States and Texas Constitutions. I have over twenty years of experience working with and for municipal governments as attorney and two and a half years on the Cedar Park City Council. This experience has allowed me to work with and through many state agencies. I have worked with elected and appointed officials from the federal government and state, county, and municipal governments from both political parties. I have a working knowledge of many aspects of our laws as they influence governments. In 1999 during the 76th Legislative Session, I served on the legislative staff for Domingo Garcia, a Democratic representative out of Dallas. I have helped municipalities adopt budgets even to the point of helping draft the budgets and calculating tax rates. Assisted municipalities in interpreting local, state, and federal laws. Represented clients before governmental entities such as the EPA, TCEQ, PUC and Texas Railroad Commission. JOHN BUCY (D-I)

I'm a small business owner, former Chair of the Williamson County Democratic Party, and new father serving my first term in the Texas Legislature. I was proud to be recognized as Hill Country News' Best (Local) Elected Official and House Democratic Caucus Freshman of the Year in 2019.

What policing reforms will you vote for?

We must transform policing to eliminate disparities while upholding accountability and safety. As a public servant, I believe in bringing law enforcement, activists, and community members together to work toward cultural and policy outcomes that achieve meaningful change. We cannot reduce complex issues to campaign one-liners to score political points, but must have the hard conversations to ensure everyone in our community feels safe and is treated fairly. I support regular mandatory training on critical topics such as racial bias, responding to mental health crises, and harm reduction practices. I believe we should also ban carotid restraints, and limit use of force and lethal force, while requiring a clear ladder of de-escalation and a duty to intervene.

What does the Texas Legislature need to do to help Williamson County recover from COVID-19?

COVID-19 has further exposed many of the problems facing our community and exacerbated disparities in our society. We must expand Medicaid to shore up our healthcare infrastructure and increase the use of telemedicine, invest in broadband access, and support our schools. Similarly, the Texas Workforce Commission needs urgent attention and increased capacity to make sure Texans are getting the help and support they need. In addition, we must ensure the budget is not balanced on the backs of Texas families and small businesses by preventing any cuts to the supports and services that they are relying on during the pandemic.

What will you support to bring economic development to Williamson County?

Working in conjunction with local leaders, I passed legislation to keep more of our Hotel Occupancy Tax revenue dollars in Cedar Park to invest in economic development and tourism. I want to expand this legislation to Leander. I will continue to prioritize bringing good jobs and economic opportunity to our region by working with local and regional leaders and the business community. I also believe we need to leverage CARES Act and other federal funding to invest in infrastructure and provide more relief to small and local businesses. Similarly, Medicaid expansion would create jobs and economic opportunity in Williamson County as well as decrease the costs of uncompensated care.

In your opinion, what is the most important issue in this race?

The most important issues are strong public schools, access to healthcare, and providing relief for families and small businesses to offset the impacts of COVID-19. We need to protect our historic gains on teacher pay and public school funding, which is the most effective way to lower property taxes, while increasing services for special education and mental health. We also must expand Medicaid and lower prescription drug costs, and provide better unemployment benefits and increased support for small businesses.

How are you the candidate best suited to address these questions?

I was elected in 2018 and promised to focus on supporting public schools, access to healthcare, and lowering property taxes. At the Capitol I kept my promises to my constituents, leading the charge on expanding Medicaid and playing a pivotal role in passing education funding and needed property tax relief. I created Community Advisory Boards to engage more people in the legislative process and get more feedback on policy matters. When COVID-19 began, I partnered with a local food bank and organized dozens of volunteers to conduct outreach and regularly deliver food and supplies to seniors and people with disabilities in HD 136. What needs to be included in the next COVID-19 relief package?

Do not possess and cannot reasonably obtain one of these IDs? Fill out a declaration at the polls describing a reasonable impediment to obtaining it, and show a copy or original of one of the following supporting forms of ID:

- A government document that shows your name and an address, including your voter registration certificate;
- Current utility bill;
- · Bank statement;
- Government check;
- · Paycheck; or
- (a) A certified domestic (from a U.S. state or territory) birth certificate or (b) a document

confirming birth admissible in a court of law which establishes your identity (which may include a foreign birth document).

* With the exception of the U.S. Citizenship Certificate, for voters aged 18-69, the acceptable form of photo identification must be current or have expired no more than 4 years before being presented for voter qualification at the polling place. A person 70 years of age or older may use a form of acceptable photo identification that has expired if the identification is otherwise valid.

Exemptions: Voters with a disability may apply with the county voter registrar for a permanent exemption to showing acceptable photo ID or following the Reasonable Impediment Declaration procedure at the polls. Voters with a religious objection to being photographed or voters who do not present an acceptable form of photo identification or follow the Reasonable Impediment Declaration procedure at the polls because of certain natural disasters may

apply for a temporary exemption to showing an acceptable form of photo identification or following the Reasonable Impediment Declaration procedure at the polls. Please contact your voter registrar for more details.


