## Unemployment remains idle

Kemper County's unemployment rate stayed about the same in February, going up one-tenth of a point to 7.3 percent when compared to the previous month according to numbers from the Mississippi Employment Security Commission.

Kemper County's labor force in February stood at 3,430 people. Of that, 250 people were out of work.

Mississippi's not seasonally adjusted unemployment rate for February 2021 was 6.1 percent, decreasing one-tenth of a percentage point from the previous month's rate of 6.2 percent.

When compared to the February 2020 rate of 5.3 percent, the rate increased eight-tenths of a percentage point.

The number of unemployed decreased 900 over the month, while the employed total increased 8,400 from the prior month.

The nation's not seasonally adjusted unemployment rate for February 2021 stood at 6.6 percent decreased two-tenths of a percentage point over the month but increased 2.8 percentage points over the year.

Mississippi's not seasonally adjusted non-farm employment decreased 800 over the month and was 46,700 lower than one year ago.

The Leisure & Hospitality sector recorded the largest monthly employment decrease; while, the Manufacturing sector had the largest monthly employment gain.

For the month of February 2021, 32 counties in Mississippi posted unemployment rates less than or equal to the state's rate of 6.1 percent. Rankin County posted the lowest unemployment rate for the month of February at 3.9 percent followed by Lafayette County at 4.3 percent. Jefferson County had the highest unemployment rate for February at 15.5 percent followed by Humphreys County at 14.1 percent

## Lady Lions advance to semifinals of Region 23 tournament

The drive is alive for the East Mississippi Community Lions as they knocked off Itawamba 63-40 Monday night and advanced to the semifinals of the Region 23 basketball tournament.

East Mississippi has now won eight-of-its-last-nine-games. The Lady Lions were to play Coahoma in the semifinals at Mississippi College. The winner takes on the winner of the Jones-LSU Eunice game for the championship.

Coach Sharon Thompson's Lady Lions now stand at 12-4.

East Mississippi made it to the final four of the tournament last week with their 69-49 home victory over Co-Lin.

Ja'Mia Hollings scored a game-high 24 points to help lead the sixth-seeded East Mississippi over the Lady Wolves.

The EMCC women owned the advantage from the opening tip against Co-Lin, jumping out to a 19-9 lead after the first quarter of play. The Lady Lions stretched the margin to 19 points (28-9) during the opening minutes of the second quarter on consecutive three-pointers by Jenessa Souza, Hollings and Amiyah Staples. With six made treys in the opening half, EMCC owned a 32-18 halftime advantage.

The reigning conference champions maintained their comfortable



double-digit cushion throughout the second stanza, including a margin of 19 points or more during the entire fourth quarter.

## Vaccines available throughout the state

COVID-19 vaccinations for Mississippians are available at no cost from drive-through sites around the state, and from some local healthcare providers.

As of Monday, the Mississippi Health Department reported that Kemper County has had 949 reported cases of COVID-19 since March 2020, an increase of five cases since last Monday. The number of deaths due to COVID-19 in the county remains at 25.

Statewide, the rate of the number of new reported cases increased across the state this past week by 1,463. There have been 306,158 cases reported in Mississippi since March 2020, and 7,051 reported deaths, an increase of 54 since last week.

Vaccination offers excellent protection against illness, hospitalization and death from COVID-19. All persons aged 16 or older who live or work in Mississippi are eligible for vaccination.

Free vaccinations are available at MSDH drive-through sites statewide.

Local health clinics, physicians, pharmacies and providers also offer COVID-19 vaccination.

Check the Mississippi Department of Health website to learn more about finding a vaccination site and making an appointment.

All persons 65 and older, and anyone 16 or older with a serious chronic medical condition are urged to be vaccinated against COVID-19.

The more you are apart from others, the more you are protected from COVID-19 transmission. The virus spreads easily between those eating together, talking together, or attending events.

Avoid non-essential trips outside your home.

If you are 65 or older, or in poor health, avoiding exposure to others is especially important.

Keep at least 6 feet apart from others when you are outside your home.

Avoid crowds, social gatherings and community events. Don't gather with those outside your household members. If you eat out or visit stores, restaurants or bars, keep your trips short and wear a cloth face

## EMCC claims second women's rodeo team title in weeks

MONTICELLO, Ark. — For the second time in three weeks, East Mississippi Community College claimed a women's rodeo team title along with a second-place men's team showing this past weekend at the Weevil Stampede hosted by the University of Arkansas at Monticello. The three-day rodeo concluded with Saturday's championship round at the Drew County Fairgrounds.

The EMCC women bettered their previous program record of 480 team points set last month in Meridian by scoring 545 team points at UAM to secure their ninth region event team title since

the school's inaugural rodeo season in 2010-11. EMCC has now won three women's team titles during the current Ozark Region rodeo season, winning the spring season opener in Meridian and also prevailing last October at the Southern Arkansas rodeo.

While the EMCC men's team totaled 530 points in placing second behind Missouri Valley College this past weekend, East Mississippi's teams also combined for 1,000+ points for the second time in three weeks. The 1,075 combined team points recorded by EMCC at the Arkansas-Monticello rodeo rank the school's history

behind the program-record 1,190 combined team points earned at the East Mississippi-hosted rodeo three weeks ago in Meridian to open the spring season.

EMCC's women out-distanced team runner-up Missouri Valley College by 280 points this past weekend, while the nationally top-ranked Missouri Valley men's team posted a winning total of 1,060 points. West Alabama claimed third-place team honors in both the men's and women's competitions.

EMCC's standout sister tandem of Jaylie and Taycie Matthews

(Wynne, AR) combined to collect 330 points between them while finishing first and second, respectively, in the barrel racing competition. Jaylie, the National Intercollegiate Rodeo Association's top-ranked barrel racer during the COVID-shortened 2019-20 season, earned the maximum 180 points this past weekend with winning runs of 14.82 and 14.84 seconds to claim her sixth career collegiate barrels win. Her younger sister, Taycie, who entered spring competition as the NIRA's second-ranked collegiate barrel racer, col-

# Senator Sampson Jackson Weekly Report

The senate gavelled out on Thursday, April 1, 2021, and the session 2021 was adjourned pending official Sine Die on Sunday April 4, 2021.

In our final week of conferencing, we adopted the Conference Report to House Bill 761 that would allow the state Veterans Affairs Board to "enter into loan or scholarship agreements with employees or students to provide educational assistance where such student or employee agrees to work for a stipulated period of time for the board," to recruit and retain more nurses for veterans' homes.

The Conference Report to Senate Bill 2834 was adopted and would create the Mississippi Historic Site Preservation Fund Grant Program; within the Department of Archives and History that will start with a \$1 million legislative appropriation for granting nonprofit 501 (c) (3) organizations grants to secure and preserve "any Native American archeology site, (b) any endangered Mississippi battlefield property,

and/or (c) any endangered Mississippi Civil Rights Movement historic site." Adopting the Conference Report to House Bill 747 would allow the Rankin County sheriff to launch a pilot work release program to gauge whether it can be a viable part of prison reform by allowing certain non-violent offenders to participate.

The jailed inmate would be allowed to work and earn money to pay fines and fees, restitution, travel costs associated with employment, child support and to save for re-entry into society once released. After one year, the program will be evaluated for its effectiveness and could be implemented by the Department of Corrections over a larger geographic area.

Among other conference reports adopted were:

- Conference Report to House Bill 520 that would amend existing law to create a special fund in the state treasury to assist cities in paying costs associated with road and bridge improvements and water and sewer improvements. It would help counties with costs associated with road and bridge improvements.
- Conference Report to House Bill 1091 authorizes the operation of microbreweries that can produce and sell their products on premises as retail businesses.
- Conference Report to House Bill 1095 would authorize the Department of Revenue to be more customer friendly and "compromise and settle," certain tax issues.
- Conference Report to House Bill 1139 would stop the practice of having certain businesses pay June sales tax to the state on or before June 25.
- Conference Report to Senate Bill 2874 would require out of state contractors to secure sales tax permits from the Department of Revenue to

obtain building permits to work on homes and business structures in Mississippi, especially in the aftermath of natural disasters like tornados, hurricanes, and floods.

• Conference Report to Senate Bill 2474 would authorize the Department of Health to allow charges and payments to be made between state agencies for services under the medical marijuana program.

• Conference Report to Senate Bill 2062, Rural Fire Truck Acquisition Assistance Program, would authorize additional funding under for cities and counties when funds become available.

• Conference Report to House Bill 1197 would allow governmental entities to use the dual-phase design-build method of construction contracting over conventional construction when it fits the public interest because it saves money.

• Conference Report to House Bill 119 - Harper's Grace Law - says bill only refers to "CBD solution" meaning a pharmaceutical prepara-

tion consisting of processed cannabis plant extract in oil or another suitable vehicle.

• Conference Report to Senate Bill 2798 would allow investor-owned electric utilities to participate in the expansion of broadband services by leasing for profit, unused fiber connections.

• Conference Report to House Bill 356 would grant immunity to persons proving information that results in a child abuse investigation.

• Conference Report to House Bill 631 would allow off duty law enforcement officers to use their department vehicles on their second jobs.

• Conference Report to House Bill 928 would allow the commissioner of corrections to have a deputy director who can supervise operations when the commissioner is away.

• Conference Report to House Bill 1245 would require the Department of Transportation to maintain state highway rights of ways in cities of 10,000 or less.

• Conference Report to Sen-

ate Bill 2799 amended the Mississippi Medicaid Program and changed some medical reimbursements.

• Conference Report to Senate Bill 2795 - Mississippi Earned Parole Eligibility Act - establishes a set of guidelines that provide certain inmates a path to parole. Persons convicted of murder and human trafficking are not eligible. Non-violent offenders and certain violent offenders would be eligible to earn early release after meeting standards and getting approval from the state parole board.

• Conference Report to House Bill 1135 would create a delivery service permit allowing retailers to send alcohol products directly to consumers' homes. Age verification is one of several safety procedures to be put into place.

We made appointments to boards and agencies and passed a rules calendar honoring exemplary Mississippians.

Also in the team roping event for the Lions, Matt Watt (Scooba) teamed with his brother, Jacob from West Alabama's team, to score 80

points apiece for a fourth-place finish. EMCC's Blake Crawford (Felda, FL) picked up 20 individual points by teaming with Southern Arkansas' Brody Forsyth.

The Lions also collected 90 team points with Myles Neighbors' (Benton, AR) third-place finish in the steer wrestling event, including a winning first-round effort of 3.6 seconds.

Rounding out the men's team scoring for EMCC, West Smith (Emmet, AR) picked up 40 points in the tie-down roping competition. EMCC's Curry also advanced to the championship round of tie-down rop-

# Premeal preparations save time in the kitchen

We all look for ways to save time in the kitchen.

Prepping things in advance is a great time saver. One time saver is to chop onions, peppers, celery, and/or garlic.

Spread them on waxed paper-lined cookie sheets and freeze. After they're frozen, store in snack bags by the amounts you would need in a recipe.

Buy a few rotisserie chickens, or do your own in your smoker. Then debone it and chop the meat, separating white and dark meat by recipe and

preferences. Freeze in storage bags until needed. Make your own spice rubs and store in air type containers. Use your smoker to prepare Boston Butts, chickens, etc. pull these meats and freeze by recipe amounts in storage bags. Prepare liquid marinade and store by canning. Just remember, the

more prep you can accomplish, the easier a healthy lifestyle will be to accomplish.

**SOY GINGER MARINADE**  
2 cup soy sauce  
1 1/2 cup honey  
1 1/3 cup medium dry sherry  
12 cloves garlic, mashed to

4 tsp. ginger root, peeled and grated

In a stainless steel, combine ingredients and bring to a boil, stirring. Simmer for 5 minutes. and mix well or blend in a blender. Canner in canning device.

# In the Garden with Felder Rushing

You know that cringey feeling when someone attends a wedding wearing something so flashy it takes away from the bride's glory? Same thing happens when azaleas erupt into eye-popping bloom.

Don't get me wrong, I love azaleas. Really. It's just that they, like a handful of other equally blinding floral exhibitionists including snowball Viburnums, wisteria, dogwoods, Hydrangeas, Southern magnolias, and crape myrtles, are so stop-in-your-tracks gorgeous they cause less-showy natives and other more demur plants to fade into the background like wallflowers.

Those few garden critics who say I don't like them simply misjudge my point, which is that when these blousy beauties show up to banish dreary winter weather and jump-start our Spring gardens, myriad other not-so-floriferous beauties simply fade into the background.

Reminds me of Skippy and Daphne, the "fun girls" from Mt. Pilot in the old Andy Griffith TV program. They were well-meaning, but every time they showed up in Mayberry, three things happened: they jazzed things up, then quickly left town, but in the meantime they left the perfectly attractive, hard-working local Thelma Lou and Helen feeling... well, a little dowdy.

Isn't this what azaleas do to otherwise outstanding Spirea, Kerria, Japanese maple, blueberries, English dogwood (Philadelphus, also known as mock orange), black- and blueberries, and other more subdued flowering shrubs? When azaleas and snowballs show up they poke us in the eye and then disappear into the background as big green meatballs, leaving us both energized and dazed.

Me, I can just say no to them, like that third beer or extra helping of mac n' cheese. If I want to be blinded by azaleas all I have to do is look across the street for a fling with Spring bling.

Instead, I savor the more subdued true beauties that inspire and comfort. Instead of blinding but finicky dogwoods, I treasure my much easier to grow native redbuds, "grancy graybeard" also known as American fringe tree, cherry laurel,

hummingbird-laden red buckeye, and my arbor's stunning crossvine.

And perhaps the most delicious spring shrubs of all, our native deciduous azaleas which flower before they leaf out. Last week I saw these leggy natives, often called wild honeysuckle, flowering all up and down the Natchez Trace, covered with huge tiger and other swallowtail butterflies. Most are pink but there are other species that flower in white, yellow, orange, and even red. And they make me all but swoon with their heady sweet bouquet.

Speaking of fragrance, this is the season when the warm wafting fragrance of banana shrub beckons us to take off our shoes and run barefoot. Before long there will be a citrusy conspiracy going on between Magnolia, star or confederate jasmine, Ligustrum, privit, and honeysuckle; though each has its own signature attar, I can barely tell them apart when they battling up for nose-space.

Meanwhile, my unexpected tendency to over-accessorize my garden with glass bottles, Mardi Gras beads and other bling is being overshadowed by the party girls across the street vying for attention.

So last week I hosted a garden soiree with them, gathering them from around my little neighborhood. Made a big floral bouquet with them that was actually almost embarrassingly opulent. They were seated side by side in one of my great-grandmother's favorite vases, which is embossed with either dogwood or Cherokee rose flowers; even stuck in a couple of stems of dogwood, our local fun gal. Couldn't have been more lush had they been arranged in a vodka bottle.

We whooped it up during our sumptuous 'do, but they quickly faded, leaving me to savor my beloved main garden squeezes.

4 T. coarse, freshly ground black pepper  
Combine all ingredients. Seal in jar and store in refrigerator.

### MEAT MARINADE

1 cup olive oil  
1 cup red wine vinegar  
8 tablespoons lemon juice  
8 tablespoons mustard (Dijon)  
2 tablespoons Worcestershire sauce  
8 cloves garlic (minced)  
4 onion (small, minced)  
4 teaspoon black pepper  
2 teaspoon salt  
Mix all the ingredients. Can in canning device.

### DRY SPICY BARBECUE RUB

Dry Rub Mix:  
ground cumin  
paprika  
garlic powder  
onion powder  
chili powder  
kosher salt  
cayenne pepper  
black pepper  
white pepper  
brown sugar  
In a large bowl, combine 1/4 cup each of cumin, paprika, garlic powder, onion powder, chili powder, salt and ground pepper. Add 1/2 cup dark brown sugar. Mix all ingredients together well. Pour into a clean dry mason jar and store tightly sealed until ready to use.

### SPECIAL DRY RUB

8tbsp. paprika  
8 tbsp. light brown sugar  
8 tbsp. salt  
4 tbsp. ground red cayenne pepper  
4 tsp. dry mustard  
4 bay leaf  
In a food processor or blender, combine ingredients. Process until bay leaf is pulverized and mixture is thoroughly blended. Store in airtight container at room temperature up to 3 months.

### HERB MIX

4 tbsp. fennel seed  
4 tbsp. dried savory  
4 tbsp. dried marjoram  
4 tsp. dried thyme  
4 tsp. rubbed sage  
Combine all ingredients. Store in an airtight container.
