# Free legal clinic set for Oct.

#### From special reports

The Mississippi Volunteer Lawyers Project (MVLP) and the Sixth Chancery District in Mississippi are hosting three (3) free family law legal clinics to assist low income residents with their uncontested family law matters.

Individuals will receive legal court documents prepared by licensed Mississippi attorneys and legal advice on irreconcilable differences divorce (no-fault divorce), emancipation, guardianship, simple wills and name change cases. Participants can also secure a simple will. The clinics will be held in the following counties:

• Neshoba and Kemper Counties–October 8, 9 a.m. (Neshoba County Courthouse, 401 Beacon Street, Philadelphia, MS);

• Attala and Carroll Coun-ties–September 17, 9 a.m. (Attala County Chancery Building, 230 W. Washington St., Kosciusko, MS)

Choctaw and Winston Counties-September 24, 9 a.m. (Winston County Courthouse, 115 South Court Ave., Louisville, MS)

The legal clinics are open to the public; however, interested participants must register online at http://www.mvlp.net/pro-se-legalclinic-schedule/ or contact MVLP at 601-882-5001 or BJ Morrow at 601-656-1881 bjmorrow8@yahoo.comto find out if they are eligible for services and to schedule an appointment.

The legal clinics are pro se clinics, meaning the individuals who attend and receive services from the attorneys are empowered to

handle their legal matters in court on their own. The clinics are designed to assist self-represented litigants in preparing to go to court.

'In the Chancery Courts of the Sixth District we see a tremendous number of people who are in need of legal assistance and simply cannot afford an attorney. People have a right to represent themselves in most cases, but as judge, I have an obligation to only approve pleadings that are prepared in strict conformity with the statutes, said Honorable Joey Kilgore, chancery judge for the Sixth Chancery District. "These clinics are a great way to help low-income individuals draft legal documents that meet the requirements of the law and most of the attorneys in this district truly have a desire to help. I love that Mississippi is

making court access a priority." MVLP has assisted more than

200 litigants a year through the pro se legal clinics. "Pro bono work helps to bring closure to legal matters for individuals who cannot afford an attorney. MVLP is fortunate to work with attorneys across this state, who dedicate countless hours to making sure we restore hope in the lives of our underserved residents" said Gayla Car-penter-Sanders, Executive Director/General Counsel.

In 2020, MVLP served approximately 1,300 Mississippi residents through referrals, direct representation, advice and legal clin-

# COVID cases up by 42 over the week

The number of COVID-19 infections continues to go up in Mississippi.

State health officials continue to urge Mississippians to get vacci-nated for COVID-19.

In the past week, there have been 13,501 new infections statewide and 392 new deaths caused by the dread disease, according to the Mississippi Department of Health. Only 2 percent of overall cases were among vaccinated people.

The number of COVID-19 cases reported in Kemper County by the Mississippi Department of Health increased by 42 in the past week.

Kemper County has 1,363 infections reports since March 2020. That has gone up from 1,272 in the past week. There has also

# Wildcats take 40-0 win over Forest

The Kemper County Wildcats got back on the winning track Friday night as they blanked Forest 40-0 in prep football action.

The Wildcats improve to 2-1 on the season. They host the Quitman Panthers this Friday night at the East Mississippi Community College football field. Kickoff is set for 7 p.m.

Jamar Grace put the Wildcats on the scoreboard when he caught an 80-yard TD pass from quarterback Aaron Steele. Jay Russell kicked the extra point and the Wildcats led 7-0.

In the second quarter, Grace returned an interception 45 yards for a touchdown. The extra point try failed and the Wildcats led 13-0 at the half.

Grace returned the second half kickoff 81 yards

# 2-0 EMCC Lions roll

SUMMIT – In their first road test of the season, the Lions of East Mississippi Community College passed with flying colors by post-ing a decisive 49-7 victory over the Southwest Mississippi Bears Thursday night's MACCC football action.

For the second straight week, EMCC's defensive unit limited the opposition to a lone score, while the Lions' well-balanced offense combined for nearly 500 yards of total offense and again scored in all four quarters in moving to 2-0 on the year.

The game's initial tally and the first of seven touchdowns scored by the Lions was set up by a three-andout forced by EMCC's stellar defense. The Lions went 49 yards

on five plays to move ahead 7-0 at the 8:09 mark on a four-yard scoring run by Zias Perryman. The score followed a 20-yard rush by Arkansas transfer Montae Spivey.

In scoring their only points of the game, the home-standing Bears benefitted from back-to-back defensive interference penalties. They knotted the score on quarterback Luke Alleman's 14-yard keeper up the middle with two minutes left in the opening quarter.

The Lions responded by taking control of the contest with a 21point second quarter. In the first play of the quarter, EMCC's Jamari Jones capped an eight-play, 61-yard drive by hitting Spivey coming out of the backfield for an eight-yard scoring toss to make it a 14-7 con-

In response to limited faceto-face training caused by COVID-19, the Mississippi Department of Agriculture-Bureau of Plant Industry has approved an online private applicator certification program developed by the MSU Extension Service. Persons needing to obtain or renew their private applicator certification can complete the online training (two video training modules and a competency exam) by visiting the Online Private Applicator Certification Program on the Mississippi State University Extension's website at extension.msstate.edu. The fee for training and testing is \$20, payable online by credit card, debit card, or eCheck. ## Acts 13:1-12

Luke records for us in this passage the first mission team sent off by a church, taking the gospel to the ends of the earth. The church in Antioch was led by the Holy Spirit to set apart Paul and Barnabas for mission work (verse 2). After fasting and praying, the church sends them off. We learn some important principles of missions here.

The first is missions are commanded by the Lord. The Holy Spirit initiates this mission work. The Lord Jesus had told his apostles they would be his witnesses to "the end of the earth" (Acts 1:8). God has a passion for missions. God desires the salvation of the lost. He does not delight in the destruction of the wicked. He gathers his people through the proclamation of the good news of Jesus Christ.

The church in Antioch is set forth as an example in supporting mission work. Paul and Barnabas were the most gifted teachers, yet the church gladly encouraged and supported this mission work. The church was zealous for other people to find the life and forgiveness of sins they had found in Christ. Antioch is sometimes called the "cradle of Christianity" for its contribution to Christian missions.

our Lord said, to seek and save the lost. The first stop in world- wide missions was the island of Cyprus (verse 4). Barnabas was from Cyprus, so he would have known the landscape and the culture. They end up in Paphos, the capital. Paphos was the center of the worship of Aphrodite, or Venus, the goddess of beauty and sexuality. People from all over the regions of the Mediterranean Sea made pilgrimages to Paphos to celebrate the cult of Venus. Athanasius, and early Christian leader, would later write that Paphos was a place of Satan's seat, a city given over to the deification of lust. And the Lord directed his servants Paul and Barnabas to proclaim salvation and the forgiveness of sins to the people. Corinth in New Testament times had a similar culture (and we see it in our own culture today). Paul wrote the church in Corinth reminding them that they were delivered out of such depravity into the life of God and that those in the church must leave such practices:

"Do you not know the unrighteous will not inherit the kingdom of God? Do not be deceived: neither the sexually immoral, nor idolaters, nor those who practice homosexuality, nor thieves, nor the greedy, nor drunkards, nor revilers, nor swindlers will inherit the kingdom of God. And such were some of you. But you were washed, you were sanctified, you were justified in the name of The Lord Jesus Christ and by the Spirit of our God."

Many in Paphos are in heaven today because of Paul and Barnabas bringing Christ to them. They were enslaved to sensuality, but they were forgiven and delivered from it. They now know and love the living God. The church is to have concern for the souls of people in its preaching, not anything like levity. The world may have the appearance of a festival to men, but it is displeasing to God.

God shows his love for sinners in that he gave his Son for them. Christ came to turn people from the power of the devil to the power of God. The opposition of the devil comes in the person of Elymas the magician (Acts 13:8). He tries to dissuade the governor of Cyprus from listening to the gospel.

Assions. Paul rebukes him, calling him a son of the devil and says: "will you



not stop making crooked the straight paths of the Lord?" This is a reference to John the Baptist's ministry and the need of men to repent, to turn from their crooked paths to the way of the Lord. The devil would also dissuade you from listening to the word of God.

Satan uses false teachers such as Elymas, a man who would be assuring the governor that all this talk about forgiveness and repentance is foolishness. But what is the devil but a spirit of vanity? The wise response to the gospel is to become poor in spirit and call upon the Lord.

Sergius Paulus, the governor, was a man of intelligence (verse 7). But he was also a man with a great spiritual need. He didn't need touches of reform here and there. He needed his guilt before God removed and the creation of a new nature given to him from God. And that is the good news of Jesus Christ. He came to make us new, to atone for our sins, to give us reconciliation and fellowship with the living God. And he is willing to receive whosoever comes to him.

test.

The Lions then put together their longest drive of the night by marching 83 yards on eight plays highlighted by Jones' 46yard pass completion to Cameron Hines on the drive's second play. The Lions primarily kept the ball on the ground the rest of the possession, as Perryman powered in from three yards out for his second score of the evening to extend the EMCC lead to 21-7 with 8:15 left.

Utilizing their two-minute drill to close out the half, the Lions mostly stayed with their passing game in capping a nineplay, 58-yard drive at the 1:03 mark on Jones' 20-yard scoring strike to Tonorris Brookins II. Peyton Rodgers' fourth of seven successful point-aftertouchdown attempts on the night made it a 28-7 contest heading into the break.

Following intermission, another three-and-out forced by EMCC's stingy defense led to a nine-play, 57-yard scoring drive that resulted in a 9-yard touchdown toss by Jones to running back KJ Lawrence.

Another accurate PAT by Rodgers lengthened the Lions' lead to 35-7 with 10:32 left in the third quarter.

Later in the quarter as the Bears were threatening within the red zone, EMCC sophomore linebacker Brandon Lairy stepped in front of a Christopher Roberson pass attempt at the 10-yard line and returned the interception 48 yards. Four consecutive pass completions later, Jones again found Brookins, who caught the ball at the 25-yard line, juked a would-be defender and bolted down the right sideline to complete a 35-yard, catch-and-run score at the 1:46 mark that increased the margin to 42-7.

EMCC's longest play of the evening came at the beginning of the final quarter and put the MACCC's mandated 38-point mercy rule into effect. Jones hit Zach Patterson over the middle for a 67-yard scoring pass.

Jones connected on 29-of-46 passing attempts for 347 passing yards and five touchdowns.

Having completed passes to 10 different receivers, Jones' top target on the night was

Starkville's Joshua Aka, who caught nine passes for 72 receiving yards. Patterson followed with five grabs for 85 yards, including the 67-yarder

to close out the game's scoring. Defensively as a team, East Mississippi recorded 10 stops behind the line of scrimmage against Southwest, including five quarterback sacks. Individually, Tait Deer led the way for the Lions with 10 total tackles, four TFLs and 1.5 sacks.

Thursday's contest in Summit also featured the first headto-head meeting between 14thyear EMCC head coach Buddy Stephens and first-year Southwest head coach Cliff Collins, who previously served as the Lions' defensive coordinator and defensive backs coach under Stephens' guidance.

The 2-0 EMCC Lions will begin MACCC North Division play on Thursday (Sept. 16) by traveling to Moorhead to take on the 2-0 Trojans of Mississippi Delta Community College. Kickoff at Jim Randall Stadium is set for 7 p.m. on the MDCC campus.

per fat bomb). To form them, you'll need to squish together the mixture a few times in your hands to get it to stick together, then roll it into a ball shape. (Note: If your mixture is too sticky and doesn't hold together well enough, quickly pulse in 1-2 tbsp almond flour.) Optionally, roll the fat bombs in a coating. Place fat bombs on a plate

and refrigerate for at least 45 minutes. These are soft fat bombs, so they won't really firm up; chilling them just gives time for the flavors to incorporate. Store them in the fridge.

#### PEANUT BUTTER FAT BOMBS

4 ounces cream cheese 2 ounces creamy peanut but-

1 ounce Swerve Sweetener (granular)

Mix Peanut Butter & Sweet-

ener: Stir together peanut butter and sweetener in medium bowl using spoon until combined, a few minutes, scraping down spoon and sides of bowl as needed. Stir In Cream Cheese: Microwave cream cheese in separate bowl until very soft and pliable, about 10 seconds. Add cream cheese to bowl with peanut butter mixture and vigorously stir until very smooth and completely combined a few minutes. Freeze & Serve. public education for all children with a disability.

Any individual, who knows of a child in the Kemper County School District with a disability and is not presently being served, should contact Amanda Hailey, Special Education Director and Child Find Coordinator, at 601-743-5125. Hailey is responsible for conducting an annual publicity campaign, contacting agencies, coordinating disability referrals, and initiating the evaluation process for in-school and out-of-school children who may need special education services. She is also responsible for ensuring that the Child Find procedures mandated by the Mississippi Department of Education are implemented and followed in a timely manner.

Once all the information has been obtained from the referral stage, a comprehensive evaluation is conducted by qualified personnel and will include administering an achievement, intelligence, and other appropriate tests that would be necessary for determining eligibility. After eligibility has been determined by the district's Multidisciplinary Evaluation Team, the child is placed in an appropriate special education program according to the individual needs of the child.

Information identifying the individual will be maintained by the school district and will be provided to other agencies in accordance with the Family Rights Privacy Act. Parents are guaranteed the right to examine documents concerning the identification, evaluation, and educational placement of their children. Access to this information is forbidden to any unauthorized person without written parental permission.

Programs are offered for Autism, Deaf-Blind, Developmentally Delayed, Emotional Disability, Hearing Impairment, Intellectual Disability, Language Speech Impairment, Multiple Disabilities, Other Health Impairment, Orthopedic Impairment, Specific Learning Disability, Traumatic Brain Injury, and Visually Impaired.
