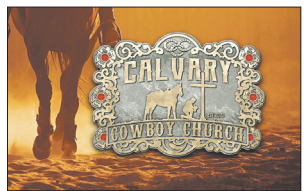

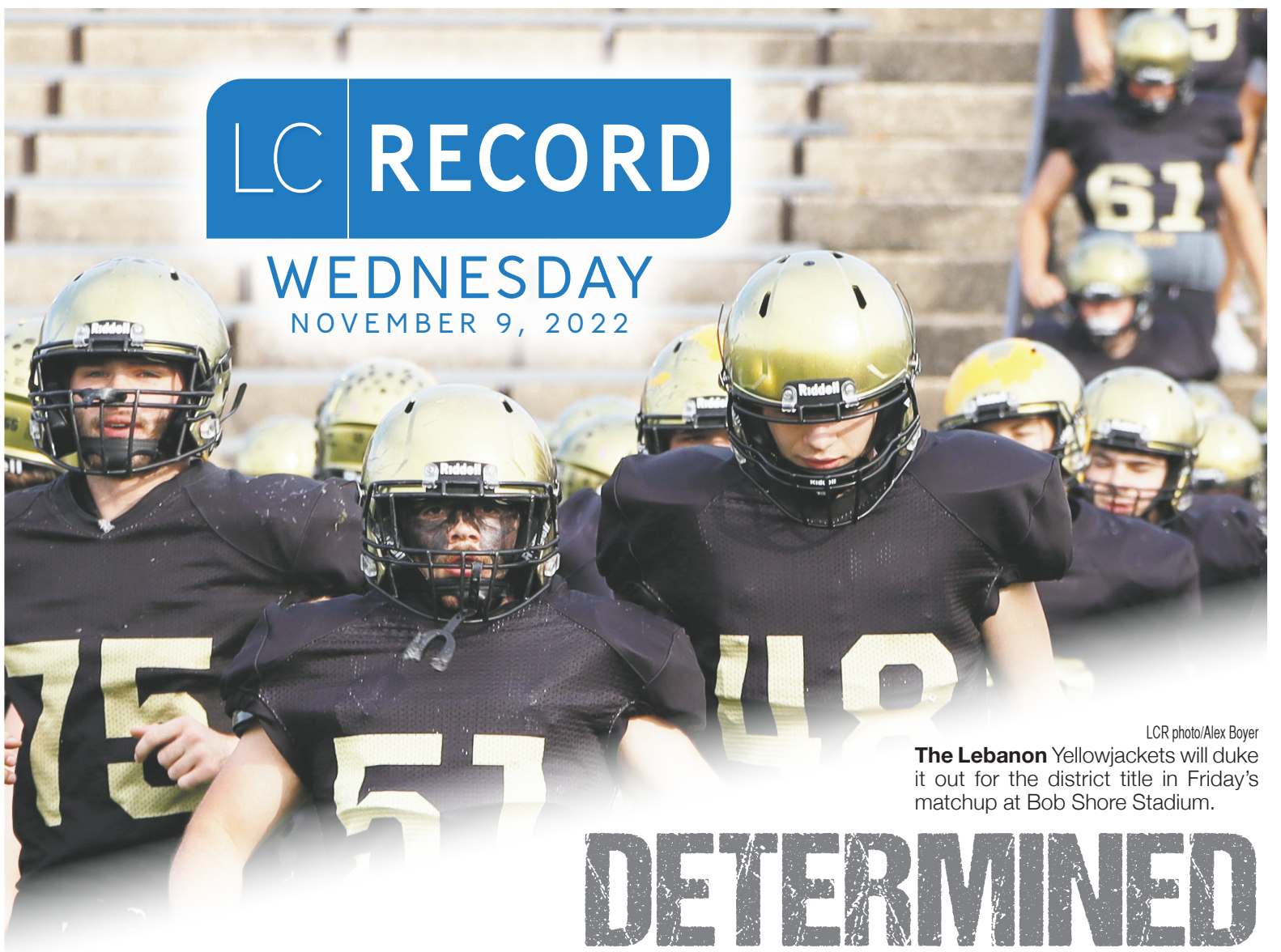

## DETERMINED

### Jackets to face Lakers in district showdown

It was the rematch everyone hoped would happen as the Lebanon Yellowjackets and Camdenton Lakers officially punched a ticket for a date with each other on Friday, November 11, at Bob Shore Stadium with a district championship on the line. The Lakers beat Rolla in the Class 5 District 5 semifinal on Saturday, 42-6, while Lebanon beat Waynesville on Friday, 53-12.

Lebanon fans will hope that part two goes better than part one as the Yellowjackets were steamrolled in the week eight matchup with the Lakers, 45-28.

It was the Bear Shore, and Kam Durnin show as the dynamic duo proved too much for a struggling Lebanon defense, but since then, the Yellowjackets have looked much better on that side of the ball.

Shore finished the game 12 of 17 passing for 179 yards and one touchdown, but it was the ground game that the Lakers were able to control the clock with as Shore rushed for 130 yards and four touchdowns while Durnin, a Wichita State baseball commit, had 61 yards rushing, 117 yards receiving, and two touchdowns.

"I was impressed with both (Shore and Durnin)," Lebanon head coach

Will Christian said after the week eight game.

"The Durnin kid was electric in all phases, and Bear ran the ball well. You have to credit their receivers and offensive line because it isn't like we weren't trying. I thought we adjusted well in the second half to some stuff, but it wasn't enough."

After Camdenton took a 14-7 lead, the Lakers took advantage of a fumble from the 'Jackets and marched down the field to take a 21-7.

Lebanon responded with a touchdown drive but surrendered a 26-yard field goal before halftime.

### Man arrested for burglary connections

A 44-year old Laclede County man was in the Laclede County Jail after being arrested by Laclede County Sheriff's Deputies and Lebanon Police Officers Friday in Lebanon in connection with burglary.

Jason M. Moore has been charged with receiving stolen property and is being held on a \$25,000 bond.

He was arrested at a Lebanon laundry mat, law enforcement officers were led to a motel room in Conway, where officers located stolen property from at least three Laclede County burglaries. Moore is suspected in at least one burglary in Lebanon.

Property was found from a burglary that occurred in the Eldridge area on October 7, and property from a October 26 burglary in the Russ area. Deputies also located property stolen in a burglary that occurred this week in the Conway area.

Moore is wanted in Texas for a parole violation. Laclede County Sheriff David Millsap said he has an extensive criminal history in several states.

"We have worked several burglaries and thefts recently in rural areas of Laclede County, we believe Moore and others, with him, have been involved in the burglaries and thefts. This arrest was the result of hard work by both the Sheriff's Office and the Lebanon Police Department over the last several weeks," said Millsap.

According to Sheriff Millsap, the suspects vehicle was captured on video near two of the burglaries.

## Covid-19 Update

### Health Department forecasts increased Covid numbers for Laclede County

Covid-19 has been out of the spotlight in recent months and number of cases is relatively low, it is still a health concern, according to the Laclede County Health Department.

Currently, COVID-19 risk levels are reported to be low in Missouri, except for the northwest part of the state and St. Louis, according to the Center for Disease Control. No counties or regions are showing a high risk level at the current time.

According to the website, covid.cdc.gov, 15,885 people or 44.5 percent of Laclede County residents have received at least one dose of the COVID vaccine. A total 13,845 or 38.8 percent have completed a primary series of vaccinations.

Laclede County Health Department Administrator Charla Baker said the current total number cases of COVID-19 reported in the county is 9,472 as of Monday.

"That is cases that have been reported to us, so obviously we know that all of the home testing

that is being done is not reported to local public health agencies, so in reality that number if much higher," she said.

In March, April and May, COVID numbers were low. In March there were 49 positive cases, in April 12 and in May there were 57 cases reported.

In June, the numbers started to jump with 225 cases reported. Over the summer numbers would fluctuate up and down.

In October the total number of cases was 152, and for Nov. 1 to Monday, there has been a total

number of 53 positive cases expected.

"We expect to see an increase in cases around this time simply because there's a lot going on in the late fall and winter months," she said. "Not only could individuals be experiencing COVID, they could also be experiencing influenza, lots of different viruses, we've been hearing about a lot of children being positive for the RSV virus, there's a lot of things going around this time of year."

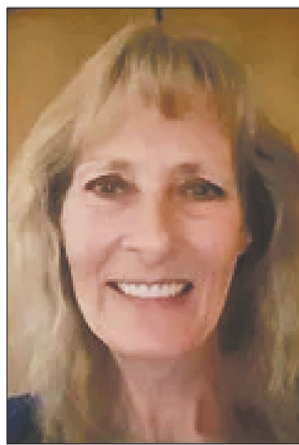

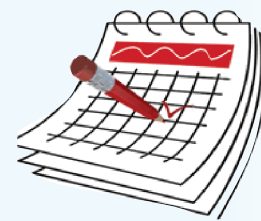

Dr. Veralee Hardin-Phillips passed away peacefully on November 1, 2022, with her beloved husband Joe by her side and surrounded by family and friends. Veralee was born in Stoutland, Missouri, to Aubrey and Della M. (Calkin) Blackburn on May 18, 1925. She was a lifetime educator, serving as an elementary school teacher, a principal, and ultimately ascending to Professor Emerita at the University of Missouri-Columbia, where she was an active staff member for fifty-one years.

Visitation will be held 5 - 7 p.m. Wednesday, November 8, 2022, at Memorial Funeral Home, Columbia, Mo. The celebration of life will take place at 10:00 a.m. at First Baptist Church of Columbia, Mo., on Thursday November 9, 2022, with Pastor Carol McEntyre officiating. Dr. Hardin-Phillips attended elementary and secondary school in Stoutland, beginning her education in the first grade at the age of five. Veralee next taught a stint in the Springfield Public Schools.

Veralee sought higher education and enrolled in the University of Missouri-Columbia College of Education in 1954. Through her direction, the Child Study Clinic on the University of Missouri campus became the preeminent facility in the United States for teacher training in the education of children with learning disabilities. Dr. Hardin-Phillips went on to direct graduate level programs in learning disabilities at the MU College of Education. She was an academic adviser for over thirty doctoral and five specialists' degrees. She is the recipient of multiple awards in her decorated career, among them the University of Missouri Distinguished Faculty Award, The Distinguished Service Award for Outstanding Service to Special Education, and with her husband Joe the "Friends of the College of Education" Award.

Dr. Hardin-Phillips was a staunch supporter of gender equality her entire career. She was the first female member of the University of Missouri Athletic Committee. She was also instrumental in the implementation of the Title IX laws in both the Missouri University System and in the state of Missouri as a whole.

Dr. Hardin-Phillips met the love of her life Joe Phillips in 1978. They were married in 1980 and stayed side by side for forty-two years. Both were lifetime educators and both maintained strong support for University of Missouri students and activities.

Dr. Hardin-Phillips is survived by her husband of forty two years, Dr. D. During the course of the investigation deputies said Moore's vehicle was displaying a stolen license plate out of Camdenton, and at times a stolen plate from Lebanon.

"During this rash of property crimes we have worked closely with the Lebanon Police Department, and received assistance from Lake Area Narcotics Enforcement Group, as well as Mid States

Organized Crime Information Center in Springfield. We received invaluable assistance from a local business owner," the Sheriff added. "Without going into a lot of detail this was another instance of good ole fashion investigative police work, enhanced by today's technology."

The Sheriff reminded citizens to ensure that when they are not at home to lock doors and

windows, and to record serial numbers or add a personal identification marker to property.

"Often we come across property, at a search warrant, or even during a traffic stop that maybe stolen, but the original owner of the property did not record the serial numbers, and we are hampered in seizing that property." The property owners in these three burglaries got some of

their property back but not all the property. "During the investigation I interviewed a person, often involved in stolen property in the county, who told me most of the property being stolen is traded locally among those dealing in methamphetamine and opioids, and that it is moved often and quickly," the Sheriff said.

The Sheriff's Office during the last month

and half have recovered two stolen tractors, taken in the summer in the Eldridge area, and a stolen side by side stolen out of Camden County. Both tractors, and the side by side, were recovered in the Eldridge area. "We have an investigative focus on individuals involved in the tractor thefts and have presented a probable cause statement to the Prosecutor's office on one

Eldridge resident for possessing and selling one of the stolen tractors." That case is under review for formal charges.

The Sheriff said that others may be charged in connection to the cases listed, and the Sheriff's Office is still working several active leads into other property crimes.

The Health Department has received verification of 185 deaths for Laclede County residents.

Baker said people needing to be tested for COVID should contact their primary care physician.

"Most health care providers locally are testing if you're symptomatic, and some do require you to be a patient of their's, for example, Jordan Valley Community Health Center can do both testing and

vaccinations, but they do require you to be a patient of their's," she said.

A lot of healthcare providers, including Lake Regional and some pharmacies in town are offering vaccinations.

"A concern we hear sometimes is that people needing to be tested for travel, employment or school have a difficulty finding a place that will test for that,"

she said.

At-home testing can be purchased, but she said people should check and make sure that home test results will be accepted.

"Be mindful that COVID is still around, it's not in the media, it's not being reported on as much, It is still around, it is something I think honestly we're going to be dealing with from now on out," she said.

# Conway considers four-day school week

## School board set to decide with Monday vote

Parents, teachers and the Conway school board met Tuesday evening for a presentation on the proposed four-day school week. The change will be voted on at the next school board meeting in the Conway High School library Monday, Nov. 14 at 6:30 p.m..

"We believe that every school in our conference will be using a four-day school week and I think the presentation of the plan has been well received," said Conway Superintendent Luke Boyer.

"Our parents have a few questions on the schematics of how everything will work out but I think overall there's overwhelming support for the move."

According to the school district, the driving reason for the change is retention of current teachers and improving recruitment of new educators.

"The biggest benefit is both attracting new teachers and retaining our current teachers. We need to be competitive with the school districts that are around us and just by giving teachers the ability to

plan, and to collaborate one day a week, instead of having to do it in the after hours is a huge benefit," Boyer explained. "It gives teachers back a lot of family time where right now a lot of that planning happens outside of school hours and even on weekends... So we know that that's a huge, huge factor. And that's the primary reason why we're pursuing this."

If the vote passes, school would be in session Monday through Thursday rather than the standard Monday through Friday school week. In order to allot for state requirements, each day of the

four-day school week would be 15 minutes longer. Along with other schools in Conway's conference, several other schools in the area have already committed to a four-day school week. Joel E. Barber already attends classes four days a week. According to Dr. Rachele Jennings at Joel E. Barber, students and parents alike were excited about the switch and have adjusted quickly. The biggest factor stacked up against the vote is childcare for Conway students on Fridays.

Though Conway considered offering childcare resources through the district, research has shown it hasn't been utilized in other districts already using a four-day week.

"I think the biggest issue that we have is childcare, and we want to be transparent about it, because we know this is going to be the biggest issue that parents face, too," said Boyer. "It's a big adjustment but we have wanted to start this discussion early so parents can be proactive and find childcare."

While some clubs and sports will still meet on

Fridays if the school switches to a four-day week, no classes will be offered and teachers would utilize those days for planning and development. This will also give students the opportunity to work on projects and homework on Fridays.

"With the research that we've done, our best interest for our students in our community is to say that we're not offering Friday childcare and to give other people the opportunity to provide outside resources for childcare on the Fridays," Boyer added. "Right now, what we're seeing for most school districts is less than 2% of students and parents take advantage of school childcare. So we just don't believe that that's feasible and in the best interest of our district."

As far as Conway staff goes, a school survey was conducted and showed that more than 80% of the faculty approved of the new four-day school week proposal. Part of this plan would also increase hourly wages for the employees of the

school district.

"Right now, our calendar has one day per month that our teachers use for collaboration, professional development and planning but the days outside of that are teachers will use their own personal time to plan and collaborate," Boyer said. "If this passes, I have no

doubt that our educators will still utilize each Friday for these things to alleviate their night and weekend hours."

The LCR will have more on this proposal following the school board vote on Monday. Should it pass, the four-day week won't go to effect until next fall.

# Local runners compete at state cross country meet in Columbia

It was a successful state cross country meet for local runners as Conway and Lebanon High School runners competed at the Class 2 and Class 5 meet.

The runners competed at Gans Creek Cross Country course in Columbia on Friday and Saturday.

Conway junior Dorothea Gantert ran a personal best at the meet to end the season, finishing 26th out of 163 runners with a time of 21:30.

According to head coach Andrew Lowery, Gantert is the fourth individual fastest runner at the state meet for the Bears.

Senior Gracie Vestal, a four-time state qualifier, ran the sixth fastest individual time at the state meet for CHS, running a 23:34 and finishing 105th, respectively.

Vestal is the sixth runner from Conway to become a state qualifier in all four seasons.

For Lebanon, junior

Ella Johnson ran a 21:53 in girls' Class 5 and finished 149th out of 168 runners.

On the boys' side, junior Peter Stunja finished 97th out of 155 runners and ran a time of 17:19 at a challenging course.

"We wrapped up a successful season, and the race featured the best runners in the state of Missouri," head coach Josh Smith said.

"Both Lebanon runners have had incredible seasons and have truly given everything to reach this ultimate goal of running in the state meet. Ella and Peter went out and ran solid races to cap off their season," he said.

"Peter and Ella committed to up their training level to qualify for the state meet and establish new personal records."

These two, along with the rest of the team, put in hundreds of miles from June to November in order to reach these lofty goals.

"Neither of these athletes has competed in the state meet

previously. The atmosphere and experience of the state meet can be a lot to take in. Ella and Peter did a great job of staying in control of themselves and running their race," he added.

"This was a huge learning experience for these runners and will serve as a launching pad for our program. Both of these runners are returning next season and have inspired the young athletes on our team."

Smith also mentioned that both runners are leaders for the team.

"Peter and Ella are the ultimate team leaders," he stated.

"The success these two had this year will directly correlate to their future as a runner and our future as a program. I couldn't be more proud of these two as people and as runners."

The state meet marked the end of a successful cross country season for both the Conway Bears and Lebanon Yellowjackets.

Gavin Smith opened this second half with an 80-yard touchdown run on the first play from scrimmage in the third quarter, but from there, the Lakers' offense was too much for the 'Jackets' defense.

Since allowing 40-plus points two weeks in a row, Lebanon has allowed just 26 points in the previous three games.

Lebanon finished the game with 423 yards of offense (407, 16 passing) but had ten

penalties for 85 yards. "We weren't disciplined enough," Christian said of the penalties after the game. "We were shifting and moving at one of our positions, and you can't have that in a game like that."

This go-around, we can expect to see a much more disciplined team that will look to stop the run and try to create turnovers when Camdenton puts the ball in the air.

The 'Jackets will also

need to be more efficient through the air. In their first matchup, they passed just six times and completed 16 yards through the air.

Cade Muscia rushed for 121 yards on 25 attempts (4.8 YPC) but had a long carry of just 15 yards. The offense will go as he does, and if there is an offense that can chew the clock and keep their team in the game, it is Lebanon's.

At the beginning of the season, Camdenton

head coach Jeff Shore announced that this year would be his last in Laker Land. Shore has compiled a 95-43 overall record (79-30 Ozark Conference),

which adds another point of emphasis to this game as he coaches his last game against a legendary coach in Christian.

The 'Jackets are

searching for their fifth district championship in six years, but the Lakers have proven their offensive attack and athleticism on defense is legitimate.

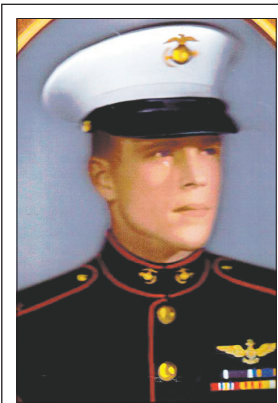

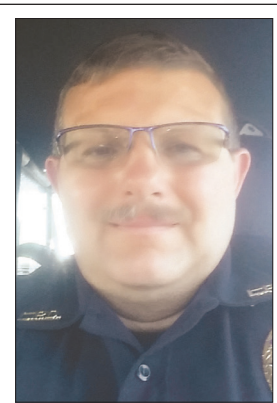

DEAR ABBY: I was taught to write handwritten thank-you notes when I received a gift. Over the last few years, my gifts have been acknowledged with a brief text, Facebook post, a photo or not at all. I enjoy giving gifts, but the lack of response I receive from today's younger folks leaves me feeling frustrated and dismissed. Must I adapt my expectations to a new normal in etiquette? -- MANNERLY MISTER IN TENNESSEE

DEAR MANNERLY MISTER: The topic of thank-you notes is one of the most common complaints I get from readers. While there's no excuse for not acknowledging a gift, you may be judging those writers harshly. Although handwritten thank-you notes are the "gold standard," many folks today opt to take a shortcut by using technology that didn't exist before the quill and inkwell.

While texts may seem cold or terse, they are better than no acknowledgment at all. A common misapprehension is that thank-you notes must be long or flowery. In fact, short and to the point is more effective. Many people don't send thank-you notes because they don't know what to say or are afraid they'll say the wrong thing. I advise readers to keep a notebook handy when they open gifts and jot down the first words that come to mind when they see what's inside. Do they like the color? The style? Is it something they have been wanting? Write

it down and use it for inspiration!
