# **The year in review** 2021: A lot more than just Covid-19

In Las Cruces, 2021 saw the return of live theater, athletic events and many other public

gatherings after a hiatus of about a year and a half. It was also a blockbuster year for filmmaking in Las Cruces, and New Mexico State University hired a new football coach, Jerry Kill.

We saw the selection of a new superintendent for Las Cruces Public Schools, as former Camino Real Middle School Principal Ralph Ramos succeeded the late Karen Trujillo. The LCPS administration building was re-named in her honor in September. LCPS Board of Education President Ray Jaramillo was re-elected in November, and Pamela Cort, who was appointed to the board in July, was elected to a full four-year term. New board member Robert Wofford was also elected, replacing Maria Flores, who is retiring after almost 13 years on the school board.

In municipal elections in November, Mayor (and Doña Ana County Commissioner) Diana Murillo-Trujillo was reelected in Anthony, and Hatch chose a new mayor, James L. Whitlock, who succeeds former state Rep. Andy Nuñez, who was appointed mayor in 2013. Las Cruces will have its first all-female city council,

Becki Graham and Becky Corran will begin four-year terms on the Las Cruces City Council Jan. 1. Corran, accompanied by two guests, and Graham, joined by her husband, Mike Graham, and her mother, Julia Roan, were sworn in at Las Cruces City Hall Dec. 21 by Third Judicial District Judge Conrad Perea. Yvonne Flores was sworn in for a second term. They join Mayor Pro Tempore

Kassandra Gandara and Councilors Tessa Abeyta-Stuve and Johana Bencomo on what will be Las Cruces' first-ever all-female city council, serving with Mayor Ken Miyagishima, who became the longest-serving mayor in the city's history in November. Graham

replaces Gabriel Vasquez, who did not seek a second term and is running for Congress. Corran replaces Gill Sorg, who served 12 years on the council and didn't run again. Instead, he was elected in November to the Doña Ana Soil and Water Conservation Board of Supervisors.

# Downtown stage named after Roberto Estrada

At its Dec. 20 meeting, the Las Cruces City Council voted to name the Plaza de Las Cruces stage "Roberto V. Estrada Pavilion" to honor "a local icon, philanthropist, Guinness World Record holder and founder of Roberto's Restaurant," the city said. "His contributions to the community touched the lives of many in southern New Mexico and his legacy will continue in Las Cruces. In 1980, he was approached by the Las Cruces Chamber of Commerce to contribute his cooking skills to an event known as Vaquero Days. Later, this was renamed The Whole Enchilada Fiesta, and it became an ongoing annual event that would put the community on the map, bringing worldwide recognition to Las Cruces and Downtown." Estrada died Aug. 18.

Interim Deputy Director Wastewater Laura Montoya Why did you decide to join the LCU?

I joined LCU as a water quality lab technician in 2006 because I wanted to stay in my career field, and LCU is a great place to work.

I have been working in the chemistry field since 1985 to 2000 as analytical chemist for the Department of Defense at White Sands Missile Range (WSMR) at High Energy Laser Testing Facility. I quit my job to raise my son and when he entered elementary school, I was ready to go back to work. There was a job opening at the Jorge A. Garcia Water Quality Laboratory (WQL), and I was hired in May 2006. I worked there until 2016 and worked in Pollution Prevention

What is something about you that we wouldn't know and that you'd like to share?

for five years.

I never even saw a wastewater sample. much less analyzed one, until I began working with the WQL analyzing sewage. Believe me, that took a little getting used to. It was a complete 180-degree difference between the samples I was accustomed to and the samples I was now analyzing. After a couple of years of not really knowing why the analytical results of these wastewater samples were so important, I became

theory and technology of wastewater treatment; in fact, I became fascinated by it.

So much so that I began teaching as an Adjunct Professor for Water Technology at Dona Ana Community College in 2011, and I'm still there, ten years later, teaching Water/ Wastewater, Chemistry and Microbiology. Many of the students I have taught over the vears are now working in the LCU Water and Wastewater lines of business.

As I look back over my 36-year chemistry career, I can honestly say that these last 15 years of working and teaching in the field of Water and Wastewater have been by far the most rewarding and humbling years of my life, second only to being a mom.

Why did you decide to join the LCU?

I wanted the opportunity to work for an organization that was solid, a place that would give opportunities to grow. I've been with LCU for 13 years.

What is something about you that we wouldn't know and that you'd like to share?

# City seeking state grant to establish new commercial air service

### FROM A CITY OF LAS CRUCES NEWS RELEASE

At its Dec. 20 regular meeting, the Las Cruces City Council unanimously adopted a resolution authorizing city staff to submit a \$3.5 million grant application to the New Mexico Department of Transportation-Aviation Division (NMDOT-A) that could establish intrastate air service between Las Cruces International Airport (LCIA) and other New Mexico cities through the New Mexico Rural Service **Enhancement Program** 



Las Cruces has been without commercial air service since July 2005. A grant application seeks to change that.

(NMRSEP). The resolution authorizes the city to provide 10 percent in matching

funds, for a total request of \$3.85 million to participate in the program.

If approved by NMDOT-A, in-state flights to and from Las Cruces to Albuquerque would initially be established.

Flights out of LCIA could begin as soon as mid-2022. In time, additional flights to and from Santa Fe and other New Mexico cities could be inaugurated, depending on demand.


A request for proposals has been initiated by the city to determine a provider for flights. Proposals were due Dec. 28.

Las Cruces has been without commercial air service since July 2005.

LCIA is continuing with phase two of a passenger air service study led by DuBois & King and Airplanners. The study is in support of the city's strategic plan and LCIA goals to have daily, regional commercial flights.

If the NMDOT-A grant is awarded, city council would be presented with a budget adjustment, probably sometime between February and April, to accept the award and budget the cash match.

The NMRSEP Act was passed by the 2021 New Mexico Legislature to promote air service to connect New Mexico communities, particularly where air service does not already exist.

Today marks the last column for Baxter Black's "On the Edge of Common Sense." Black turns

77 in January, and we learned last week from his wife, Cindy Lou, he's been battling some serious health problems and will be hanging up his word processor to ride into the retirement sunset

In the early 1990s, I lived in a one-room studio apartment in Fort Smith, Arkansas. All along one side were floor-to-ceiling windows. The wood floor would have been ideal for a basketball court if it weren't for the very low ceilings. Of course, that didn't stop me

time to time. During the time I was living there, my week's routine included two radio delights.

One delight was listening to the Friday morning report from baseball broadcasting legend Red Barber, who called games in

New York from 1939-1966, first with the Brooklyn Dodgers and then with the Yankees. Barber

would chat with NPR host Bob Edwards about sports and a variety of

> other things. The second weekly delight was the report on NPR's "Morning Edition" from a cowboy poet and large animal veterinarian named Baxter Black. You never knew what Baxter would

present from week to week. Sometimes, it would be a genuine cowboy poem. Sometimes it would be a hilarious tale of his ranching life. Other times it would be commentary of some human foible. No matter the topic, I was always entertained, and appreciated this glimpse into a life I wasn't close to at that time in my life.

Flash forward to 2010, when I joined the Las Cruces Bulletin. To my delight, one of the Bulletin's regular features was the

weekly Baxter Black column. I enjoyed him then for the same reasons I had 15-20 years earlier. Quickly I learned Black had a

big following in Las Cruces.

Part of that was geographical. Black grew up in Las Cruces, and his father was dean of New Mexico State University's agriculture college. The younger Black studied at NMSU before finishing his schooling at Colorado State.

Part of that was topical. Living in a Western state, with a lot of working farmers and ranchers, New Mexicans could relate to Black's stories.

Many of his fans, however, had never sat in a saddle or even pulled on a pair of cowboy boots. They just enjoyed his wit and the way he could weave a tale.

When I'm out and about or attending a community event, people often come up to me specifically to say how much they enjoyed Baxter Black.

That said. Black had his crit-

ics as well. Some people asked me why we ran his column. Others said he was out of touch, or out of date, or downright backwards in his thinking. In fact, I fully expect to hear negative comment about two words in his final column today. His fans, though, outnumbered the naysayers about 10 to 1.

For me, Baxter's cowboy poetry was always a treat, and a welcome diversion to life's frustrations and complications. Regardless of his topics, I almost always learned something. Yes, there were times I didn't quite find the intended humor. but there were other times I found his writings almost existential.

He's lived for many years in Arizona, fittingly, on a street called Red Chile Road.

His last two columns in the Bulletin, to me, show some of the many sides of Baxter Black.

His Christmas Eve column was a hopeful mashup of wonder, faith, science and miracles.

I like being there when a

horse matters.

When you can't do the job alone; a cow in the bog, a race against time, a boulder to move. a detour to take, a mountain to cross, a crevice to leap, a war to win, a sweetheart to impress, or...when you've gone too far to walk back.

Shakespeare's King Richard III said when fate hung in the balance, "A horse! A horse! My kingdom for a horse!"

# Time for feds to view marijuana realistically

President Biden and Congress have many pressing issues before them, but this administration, like those which have preceded it since 1970, continue to perpetuate the absurd and heinous policy of classifying cannabis as a Schedule I drug.

One of the main reasons for classifying it at the top of the narcotics schedule is the federal government's contention that marijuana has no medical benefits and is among drugs (LSD, Ecstasy, peyote and heroin) with the greatest potential for abuse. Among drugs considered a lower risk (Schedule II) are the recent headline-grabbing and deadly narcotics: methamphetamine and fentany! This makes a mockery of the federal government's drug classification system.

The FDA and DEA run roughshod over the pot issue, perpetuating federal laws that conflict with state laws and hinder legitimate research into the medical benefits of cannabis.

Thirty-six states, including New Mexico, have legalized medical marijuana, touting the drug's many healing benefits in treating epilepsy, autism and other ailments. New Mexico, too, is among 15 states that have legalized the sale and consumption of cannabis, and in many cases, enacted legislation to expunge criminal records for pot "crimes" that have disproportionately impacted people of color for decades.

What is driving this continued, antiquated abuse

of federal power that lacks any credibility whatsoever? How many people have you heard of or read about who died from a marijuana overdose? Zero. How about those dying from Schedule II drug fentanyl or engaged in a ruinous meth-using lifestyle? Tens of thousands!

It's time for this administration to end this shameless, sham classification of cannabis. Last December (2020), the House passed bi-partisan legislation to do just that but the Senate never did. Biden says he supports decriminalization, but not federally legalizing pot. The War on Drugs is over. We lost. Just say "No" to this laughable system.

# City celebrates 20 years of Unidad Park, begins renovations

The City of Las Cruces celebrated 20 years of one of its most popular parks with a special ceremony earlier in December that included city officials, volunteers and the city's Parks and Recreation Department mascot, Ziggy.

The event, called "Honoring Our Past, Celebrating Our Future," recognized Unidad Park, 1500 E. Hadley Ave., as a "community-built structure that was erected in 2001 thanks to community donations and dozens of volunteers," the city said in a news release.

Because the park playground is made mostly of wood, the harsh Southwest climate has deteriorated playground equipment surfaces during the past 20 years to a



City dignitaries and parks officials and advocates gathered to kick off renovations at Unidad Park, 1500 E. Hadley Ave., and to celebrate the park's place in the community over the past 20 years.

"The safety of this playground is precisely why we recommended that it be replaced with materials that will hold up better over time and meet playground industry standards," Delgado said. "That's why we're investing close to \$2 million in this park alone, paid for from the general obligation bonds that voters supported in 2018."

A splashpad will be a new feature at the park, the city said. The walls that feature tiles with children's handprints and the wood slats with names will remain as an historical part of the site, the city said.



# 'I just had a total moment of peace'

Las Cruces man summits Africa's Mt. Kilimanjaro in triumphant second climb

"My mind went very calm. I just had a total moment of peace."

That was Ride On Sports of Las Cruces owner David Hill's experience a couple of weeks ago as he stood atop Mount Kilimanjaro, the highest free-standing mountain in the world.

Hill and his guide, Salim, began the final part of their journey at midnight Thursday, Dec. 9. in blizzard conditions with 4 inches of snow on the ground, emerging from the clouds as they summited at sunrise in 5-degree weather.

"It was unbelievable," Hill said.

It was also a redemption.

The climb was Hill's second attempt to reach the top of the 19,341-foot stratovolcano. During his first climb, in January 2019, Hill broke his leg


at 16,000 feet and had to be piggybacked off the mountain by Salim. "You walk off this

time," Salim told Hill during the second climb.

Salim, a native Tanzanian and professional guide, has climbed Kilimanjaro about 250 times, Hill said.

Hill suffered a tibial plateau fracture when he planted his leg wrong during their first climb together.

He spent four months on crutches and eight months in rehab before he could start walking and hiking again. It was a year before the 62-yearold could return to trail running. With nine pins in his leg, Hill spent the next two years in training, climbing mountains in New Mexico, Colorado, Texas, Utah and Arizona as he prepared for the conquest of the "Mountain of Greatness," as Kilimanjaro means in Kiswahili.

in Las Cruces grouping. Winning first place for 2022 was Chachi's restaurant. Finishing second was Matteo's, and coming in third was Si Señor. In some things, finishing third might be a disappointment, but when you live in a region that has the best chile in the world, and there are probably a hundred Mexican restaurants, finishing third is a badge of honor not unlike winning a bronze medal in the Olympics.

Interestingly, Si Señor also finished third last year, but the other two winners last year did not make the final three. For the 2021 results last year, El Sombrero took the top spot and La Posta de Mesilla finished second.

For others, the 2021 rankings might be more consistent with your tastes. My prediction, though, is that the average person in the Mesilla Valley would have a completely different ranking. 

Requests shall be considered on a case-by-case basis provided that each councilor participating by conference telephone can be identified when speaking, all participants are able to hear each other at the same time, and members of the public attending the meeting are able to hear any councilor who speaks during the meeting.

#### A. Regularly Scheduled **Open Meetings.**

Unless the business before the City Council dictates otherwise, the City Council will conduct open meetings to take formal action on the first and third Monday of each month at 1:00 p.m. as referenced in Exhibit "A." When Monday is a city holiday, the meeting shall be held on the next business day. The City Council has the authority to change the meeting time with minute action in compliance with the Open Meetings Act, for subsequent regular meetings. Staff is hereby authorized and directed to publish this resolution one time as a legal advertisement in a newspaper of general circulation in the City of Las Cruces.

The City Council will conspicuously post an agenda of the meeting at least 72 hours prior to the meeting. In accordance with this resolution, the agenda shall be issued and circulated to the press, radio, and other public information media who have provided a written request for such notice and posted on the bulletin boards of City of Las Cruces City Hall, Thomas Branigan Memorial Library, and on the city's website.

The agenda shall indicate the date, time, and place of the meeting, a list of all action items to be considered at that meeting, and a list of any other specific items of business to be transacted. The City Council shall only take action on items appearing on the agenda.

#### B. Hearings Before the City Council.

At any hearing at which a quorum of the City Council will be present, the City Council will provide notice of the hearing as an open meeting to take formal action and shall issue an agenda as prescribed in Section III(A) or (C) of this policy. Within a reasonable time, but in no less than 72 hours prior to the hearing, the City Council shall also provide actual notice to all parties in that case or their counsel and to any other

person who has requested such notice of the date, time, location, and purpose of the hearing.

If during the course of a public hearing at which a quorum of the City Council presides, the City Council determines that the hearing should be recessed and reconvened to a date subsequent to that date stated in the meeting notice, the City Council will specify the date, time, and place for the

reconvened meeting prior to recessing and will conspicuously post notice of the date, time, and place for the reconvened meeting near the door of the place where the original meeting was held and on the bulletin board in the lobby of City Hall.

C. Other Open Meetings In Between Regularly Scheduled Open Meetings. If the public interest requires other formal action by the City Council in between regularly scheduled open meetings, the City Council may conduct an open meeting to take formal action at such times. Except in the case of an emergency as defined in NMSA 1978. Section 10-15-1(F), the City Council will provide notice of each such meeting by conspicuously posting an agenda and a notice of the date, time, and location of such open meeting on the bulletin board in the lobby of City Hall, the city website, and by emailing a copy of the notice to the press at least 72 hours prior to the special open meeting. emergency. **Emergency Meetings** THAT emergency meetings will be called only under unforeseen circumstances which demand immediate action to protect the health, safety, and property of citizens or to protect the public body from substantial financial loss. The Las Cruces City Council will avoid emergency meetings whenever possible. Emergency meetings may be called by the Mayor or a majority of the members upon four (4) hours' notice, unless threat of personal injury or personal damage requires less notice. The notice of all emergency meetings shall include an agenda for the meeting or information on how the public may obtain a copy of the agenda. All emergency measures adopted must be submitted to the Attorney General within 10 days of the meeting at which the action was taken, provided that the requirement to report to the Attorney General is waived

# Arts council likely to move in 2022; community asked to help

In 2021, the Doña Ana Arts Council (DAAC) marked its first 50 years serving Doña Ana County and the region with the arts and through the arts. Hopes have been shared that, in 2022, it can continue its service with a move into a permanent site.

From its start in 1971 in a private residence and in five other locations since then, DAAC has been an investment in our community through the arts.

Visionaries here have been making the case for the power of the arts in a creative economy and the importance of community pride through the arts these past five decades, and we are moving confidently with that same vision into the next five decades.

Despite the pandemic, we've enjoyed 15 great months in our current

spot, 250 W. Amador Ave., and it has had the best gallery of all of them.

Norman Todd made sure we had a great space for showing art, and even though everyone in the audience had to wear masks and keep their distance from each other, we've also had three superb performances here. Todd passed away in August of this year, and his family has decided to sell the building where the arts council has been located since September 2021.

They have been fantastic, and we can fully appreciate how this is something Norman's family feels they have to do. However, this means the arts council will most likely be again moving, either at the end of August 2022 or possibly even months before.

The DAAC board of directors gave the green light to start a search for a new location, with an emphasis on possibly finding a permanent address where visual arts, performing arts and classes in the arts can productively coexist.

Particular interest is focused on arts programming for young people: continuing the initiative of Jordan and Marian Wolle with Career Art Paths, along with other summer art programs as well as building on the recent collaborative success in arts integration with seven entities that included Las Cruces Public Schools and Kennedy Center Partners in Education.

The sites being contemplated are even in historic adobe structures. This could be very appropriate, given our history here with adobe and the arts council's own time in two historic adobes.

Three of the five past Las Cruces locations for the arts council have been just blocks apart in what is now the Las Cruces Arts and Cultural District (ACD), and two of those three were historic buildings constructed of adobe. Adobe construction predominated for most of the area's buildings for 100 or more of the past 170 years, and in 2005, DAAC moved from an adobe storefront on Campo Street to the iconic, two-story, adobe Rio Grande Theatre (RGT) on Main Street.

The incredible generosity of two granddaughters of one of the original owners of the theater got the ball rolling. Then, our community and legislators stepped up and made something spectacular happen. Ostensibly, RGT was to be the prominent and permanent home of DAAC, but several conditions made it necessary for us to move out and turn operation of the theater over to the City of Las Cruces in 2017.

The arts council is asking for the community to step up again and help something "spectacular" happen again, but this time where gallery space, performances and classes can all be adequately accommodated. The history, the arts and the culture in Downtown Las Cruces all seem to be compelling considerations in the search for a new, permanent home for DAAC.

Very attractive sites are also being seriously considered outside Downtown and the ACD.

The two key points for us are that it has to work for what we are doing in the arts, and it has to be something we can afford.

DAAC is open 9 a.m. to 5 p.m. Monday through Friday and noon to 5 p.m. every second Saturday.

adults and \$12 for students and seniors. Tickets will be available at the door and check online at no-strings.org.

"The Ring Leader" is "a family friendly show about a (circus) ring leader who is nearing retirement and a newcomer who is finding her way in the circus," said The Dance Eclectic Creative Director Morgan Rivera.

The show was inspired by the 2017 film "The Greatest Showman," and the life of P.T. Barnum (1810-91), who, with James Anthony Bailey, founded the Barnum and Bailey Circus, which operated 1871-2017.

# Farm and Ranch Heritage Museum director looks back on 1st year

New Mexico Farm and Ranch Heritage Museum (NMFRHM) is "a living, breathing part of the city and the state," said Heather Reed, who celebrated her first year as executive director Nov. 2.

Coming to NMFRHM from the South Carolina Historical Society in Charleston, South Carolina, Reed said she was struck by how much a part of the community the museum has become since it opened in 1998.

People from throughout southern New Mexico "don't just come when they have family and friends in town," she said.

"This is their home. It's a place to celebrate the state and the community," she said.

Covering 47 acres, the museum's main building has more than 24,000 square feet of exhibit space to tell the 4,000-year history of farming and ranching in New Mexico. Just one example is "Her Story: Women in Agriculture," a rotating wall display that went up last summer and will change every six months to tell

Heather Reed has been the executive director of the New Mexico Farm and Ranch Heritage Museum, 4100 Dripping Springs Road, for a little more than year now.

the story of the women who have become icons in New Mexico farming and ranching.

NMFRHM is "a welcoming place," Reed said, and home to bright and colorful interactive exhibits, with no velvet ropes.

"You get to be a part of the story as much as your family has been a part of the story we're telling," Reed said.

NMFRHM hosts frequent live demonstrations at the museum, including weaving, quilting, blacksmithing and other basics of farming and ranching, as the museum helps to "keep traditional skills alive," Reed said.

NMFRHM also has a spacious outdoor courtyard with a breathtaking view of the Organ Mountains, the Eagle Ranch mercantile gift shoppe and a 150-seat theater.

It is also showplace for the works of local artists, and the museum welcomes meetings and events in its large meeting rooms.

The museum's outdoor exhibits include 20 acres devoted to real, live sheep, goats and cattle — from

newborn to adult — along with a greenhouse and historic farming and ranching machinery. It also hosts extremely popular annual events like Cowboys Days in March.

NMFRHM continues reaching out to the community it serves, Reed said, welcoming more stories and artwork, along with projects from local 4H clubs, the Farm Bureau and other farming and ranching organizations for children and adults.

"The biggest thing we can do is pay attention to our customers," Reed said. "What does our customer want to see?"

Reed said she spends as much as time as she can out and about in the museum and on museum grounds, talking to employees and interacting with members of the public. And, she is frequently recognized away from the museum by its regular visitors.

Reed began work at NMFRHM with the museum closed to the public because of the pandemic. A small crew returned to work at the museum Feb. 8, she said, and full staff returned July 6.

"People are so happy we've reopened," Reed said.

Reed said the museum welcomes additional volunteers to lead tours, help in the office and conduct live demonstrations.

"Come to us and we will find a wonderful place for you," she said.

A native of northeast Ohio, Reed grew up surrounded by family heirlooms and ancestors' stories. With regular visits to her grandparents' farm during her youth, she personally raised and showed goats, a sheep and a llama.

Before becoming the first director of Museum and Education at the South Carolina Historical Society, Reed spent seven years working at the Taylor County History Center in Buffalo Gap, Texas, where she held the positions of executive director, executive vice president, site manager and curator. Her professional experience also includes service at The Grace Museum in Abilene, Texas: Amazement Square Children's Museum in Lynchburg, Virginia; and the Ohio Historical Society in Columbus, Morgan County Historical Society, Perry County Historical Society, Athens County Historical Society & Museum and the Ohio Agricultural Research and Development Center in Wooster, all in Ohio.

Reed was an adjunct instructor of undergraduate courses on cultural and heritage tourism at McMurry University in Abilene, Texas. She holds a bachelor of arts degree in history from The College of Wooster in Ohio and a master's degree in public history with a focus on museum studies, interpretation and heritage tourism from North Carolina State University.

environment, ALR said. The presentations will be Mondays, Jan. 10 and 17 and Wednesdays, Jan. 12 and 19.

• February: "Medications and the Older Patient," with Mark Stratton, Ph.D., professor emeritus professor in the College of Pharmacy at the University of Oklahoma. Stratton will discuss the problems older people encounter when medications are used inappropriately, excessively and unnecessarily and how to use medications to minimize their risk. The series will conclude with a presentation on managing chronic non-cancer pain with a focus on avoiding opioids. The presentations will be Tuesdays, Feb. 8 and 15 and Thursdays, Feb. 10 and 17.

• May: "Climate," with New Mexico Climatologist David DuBois, Ph.D., who is a member of NMSU's Department of Plant and Environmental Sciences. DuBois will discuss what climate means and how we know that it is changing. The presentations will be Mondays, May 9 and 16 and Wednesdays, May 16 and 18.





the scary thing is the players think they can be even better than their 11-2 record shows.

"I think we are in a good spot," said redshirt senior Clayton Henry. "It's even better; we all know that we aren't close to being how good we can be."

The Aggies finished nonconference play with a six-game winning streak, including four straight road wins. Those road wins consisted of close

victories over archrivals UTEP and University of New Mexico, a win over Loyola Marymount despite making 26 turnovers and overcoming an 18point deficit to beat Pac-12 opponent Washington State.

"There have been

multiple times where we've seen stats like 26 turnovers and all that, and we are still winning," said Henry, from Calgary, Canada.

"We just know that if we get a complete game, it's going to be really scary (for opponents),"

Henry added. "That is where we are trying to get have to grab the scripture, to."

The Aggies wrapped up nonconference play with a pair of home victories — 93-60 over Northern New Mexico Dec. 18 and 84-59 over UT Permian Basin Dec. 20, in a contest that was closer than that through much of it.

Jans said the team has been able to win in tough environments and has been able to overcome adversity.


"Those experiences are going to help this particular team going forward," Jans said.

# How to golf with ironclad nerves, steely mind, commanding presence

While recently going through some of my golf files, I found notes from when I served as performance coach (i.e. sport psychologist) for the Aggie men's

Golf Doctor golf team. At the time, I prepared a notebook for the players which contained detailed information on maintaining confidence, developing a positive attitude, setting realistic goals, practicing with a purpose and much more. I saw it as the golf-

It began: "Being mentally tough in golf begins with who you are and what you do. The

bedrock dimensions are personal qualities which you can learn and solidify with effort and dedication. To be a winner, there is no real substitute for these qualities."

I will share below just a few of the highlights of

that team notebook for vour benefit as well. The first section of the

notebook had to do with identifying those critical and necessary behaviors that give you the best chance of playing your best, and without which you are probably sabotaging your performance. At the top of that list is that you are undaunted by adversity: when something bad happens, as it inevitably will, you respond not with whining and excusing, but with better play. You maintain a positive attitude, always. Your selftalk is helpful and soothing, not self-demeaning and self-defeating.

To avoid the trap of paranoid thinking that sucks a golfer in like quicksand, you detach yourself from blaming and complaining. That's very hard to do while playing a game as frustrating as golf. During a round of golf, you demonstrate your mental toughness by staying in the present, with little attention to what's behind or ahead of you. You fully immerse yourself in the shot or putt facing you right now, grasping that

the main task is getting the ball into the hole in the fewest strokes — not how things "should" look, or how you wish them to look, in the process.

Like a samurai warrior vou have trained vourself to stay patient and wait for the opportunity to "close the deal."

A week after the notebook, I had my Aggie players gather around for a mini-clinic in which I presented this personal proposition: Ask yourself if you rapidly size up the situation clearly and completely before each

shot, and then select your play based on a reasonably high probability of success. Playing smart golf — mentally adept golf — means playing to your highest probability of success, not trying to hit a gap wedge 155 yards to a tight pin just because you did it one time last year. It's a challenge for many golfers to select the club they can hit well nine out of 10 times, not one out of 10. Next, ask yourself if you check your fundamentals frequently

In the next few months. South **Central Solid Waste** Authority (SCSWA) will be exchanging all existing **Friedman Recycling** containers with the newest recycling initiative between SCSWA and City of Las Cruces, updated containers. "It's part of a process to allow us to provide even better service quality," said

Patrick Peck. SCSWA director. "The updated decals on containers will help educate our residents about what goes in the blue bin and lead them to the one-stop-shop customer service phone number." The joint number that will service both SCSWA and Las Cruces Utilities is (575) 541-2111, where there will always be a person to find the right answer to your recycling and solid waste questions or needs.

From December to March, SCSWA staff will exchange recycling containers on the day of service after the truck has gone by and emptied the containers. The crew will exchange recycling containers on the normal service day and urge

curbside recycling customers to leave containers out on the curb until 4 p.m. Customers can place their containers out even if they are not completely full or empty; they will get swapped out just the same.

"The recycling container exchange project will take a few rounds on each route," said Miguel Fernandez, SCSWA program administrator. "If vour containers did not get exchanged by 4 p.m. on your service day, we ask that you roll in the container and continue to utilize the existing container until it is exchanged. During the container swap, the SCSWA website will have maps indicating

where we're currently replacing containers." Fernandez explained that each new container has a QR Code so customers can use their smartphone to scan & retrieve instant information like their pickup schedule, know what and what not to throw in their blue recycling container. Also, the SCSWA has provided customers with an option to download the Recycling Coach App, which will provide customers with their pickup schedules, push notifications, holiday pickup schedules and allows customers the options to print out a 1-. 3- or 6-month calendar of pickup schedule.
