#### **Gabriel Vasquez (D) U.S. Representative** candidate District 2

1. The decision to have an abortion should be between a woman and her

doctor and we should codify that right into law to ensure that politicians never come between a woman and her healthcare decisions.

2. As a hunter and responsible firearm owner there are several common-sense laws we can pass to keep our families and communities safer. These include expanding background checks, closing the gun-show loophole, instituting red flag laws, protecting victims of domestic

violence and banning ghost guns and bump stocks.

3. Economy: We must put New Mexico's workers and small businesses first. Starting by raising the minimum wage to \$15 an hour and increasing support for small businesses. Healthcare: Every New Mexican deserves access to quality, affordable healthcare. I'll work to lower healthcare costs for New Mexicans by fighting for a public option and ensuring that Medicare can negotiate for lower prescription drug costs. Immigration: We must reform our immigration system to protect DREAMERS and provide hard-working families with a permanent path to citizenship, while ensuring we have a safe and secure border

4. Ensuring safe, secure, and fair elections is important to all of us – every eligible American deserves to have their voice heard and their vote counted, regardless of their political party. I'll fight to protect every eligible American's right to cast a ballot and have their votes counted and to make sure that, when the votes are counted, the will of the people prevails. Keeping election administration away from partisan interference, automatic voter registration, and expanding access to voting by mail are steps we can take to help voters access the ballot and know their votes will be counted.

**5.** Politicians must stop treating immigration as a political prop & commit to enacting real reforms so that we can provide permanent solutions to our DREAMers, allow those who come to our country to seek asylum to have a timely & humane opportunity to have their cases heard, & give people who are here, or want to come here, the opportunity to become citizens. We should invest in better technology that will help secure our border from those using it to smuggle drugs into our country. We must also address the causes of migration from Central America which include climate change, economic instability, crime, and political corruption. We can, & must, find a balance between treating

people humanely and keeping our border communities safe.

6. It's climate change. We can address this challenge by beginning our transition to a clean energy economy. This transition will create good paying jobs right here in New Mexico with the investments that would be made in infrastructure, manufacturing, and maintenance of both. New Mexico can become a clean energy exporter, not just an exporter of oil and gas, which would benefit workers and communities across southern New Mexico, including the Permian Basin. My top priority during this transition is to protect our workers and communities and to give them prosperous futures.



#### **Yvette Herrell (R) U.S. Representative** candidate District 2

1. Individual states should have the final say over how abortion is regulated. I do not agree with the NM statute that

permits abortion up to birth - I am pro-life and believe there should be limits.

2. There are enough laws on the books today to take illegal guns off the streets, hold criminals accountable, and dramatically reduce gun violence. This starts with electing the prosecutors who will try these crimes and uphold their oath to keeping Americans safe.

3. Because of out-of-control spending in Washington, costs have risen for hard working Americans, making it hard for many to get ahead. As prices rise, job creators face difficult decisions, slowing the economy and making every aspect of life tougher. Congress needs to rein in spending to stop inflation. Second, crime is out of control. We must stand with law enforcement and get them the tools they need to keep our

families safe and allow them to focus on what they do best. Third, securing the southern border is critical and far overdue.

**4.** We must restore confidence in our elections, and that starts with transparency and accountability at every level. I support voter ID requirements, more accountability for the elected officials who run our elections, and making it easier for people to vote in-person. This is a fundamental part of our democracy and it's time to end the partisan rhetoric and work together to find common sense solutions and restore faith in the process.

**5.** We all know the system is broken. The border is open for illegal immigration, yet it is too costly for those wanting to become citizens, confusing, and unnecessarily complicated. We can reform immigration to make it work for all, but Republicans and Democrats must stop playing political games. I am ready to work across party lines to develop a process that solves the problem, not continue to kick the can down the road. Real people and families are suffering because Washington can't get past the talking points and get to work.

**6.** Right now, it's the fact that this administration sees foreign oil as the solution to our current energy crisis. Americans produce the cleanest barrel of oil anywhere in the world, so buying dirty and potentially compromised oil from overseas is ridiculous. Common sense says we should produce right here in America, cleaner and more sustainably than those we buy from. We need to find viable, long-term solutions to the energy needs of this nation, but we must also remain realistic to the needs of the America we live in today.

## Michelle Lujan Grisham (D) candidate Governor

**1.** I will always defend every New Mexicans' right to make their own decision about reproductive health care with their family and their doctor. As

Governor, I repealed New Mexico's outdated anti-abortion law, in order to ensure abortion remains legal in our state regardless of the Supreme Court. I have expanded access to abortion in our state, including protecting New Mexico women and doctors from other states' extremist bans. As governor I will continue to ensure that New Mexico remains a safe haven from extremist attacks, protecting access to abortion in our state.

2. Keeping New Mexicans safe also means keeping guns out of the hands of criminals. That's why my administration took action to require universal background checks for gun purchases, enact critical red flag laws, and pass bipartisan legislation that increased the penalties for gun crimes. I support common-sense gun safety laws like banning assault weapons, and keeping guns out of the hands of people who shouldn't have them, including children. We can take steps to keep New Mexicans safe from the scourge of gun violence, while also respecting the rights of responsible gun owners.

3. My administration has been leading efforts to make New Mexico a worldwide leader in clean energy production. We put in place policies that will expand clean energy, lower energy costs, and go after polluters. Earlier this year, New Mexico became home to the largest single-phase wind farm in the country, creating hundreds of good paying jobs. The ambitious goals we've set to reduce our emissions mean that New Mexico is leading the way in fighting climate change

and preserving our state's beautiful air, land, and water for future generations.

**4.** One of my responsibilities as governor is making sure New Mexicans have what they need to thrive. Earlier this year, I signed legislation that eliminated taxes on Social Security benefits. I also signed legislation that cut the state's gross receipts tax for the first time in 40 years, saving money for small businesses. Last year, I signed legislation that cut taxes for more than half a million families. As we grow our economy, we should continue to look at ways to save New Mexicans money and foster business and industry in our state.

5. Serving as New Mexico's 32nd Governor has been my greatest honor. I'm proud of what we've delivered for New Mexico and excited about what the future holds for our great state. Prior to serving as New Mexico's Governor, I served three terms in the United State House of Representatives and served the people of New Mexico in a variety of roles at the local and state levels. I'm running for re-election to build on the progress we've made so that New Mexico can thrive for years to come.

**6.** Education, economic prosperity, and public safety. We invested over \$1 billion in New Mexico's schools, increased teacher salaries, achieved universal pre-k, and made tuition-free college a reality. ## Mark V Ronchetti (R) candidate Governor

- **3.** I am a strong supporter of our oil

and natural gas industry and pursue an "all-of-the-above" energy policy. I support the development of renewable energy and other energy sources, like small modular nuclear reactors. But New Mexico oil and gas must continue to play a key role in our energy economy. The governor

passed her own Green New Deal in New Mexico and it's led to higher energy costs for New Mexicans and now we are being threatened with rolling blackouts this summer. We are far better off drilling for oil in New Mexico than we are importing it from Iran, Russia, or Saudi Arabia.

**4.** Our complicated and nonsensical tax system hammers small businesses, and punishes working families. MLG inherited the largest budget surplus in history and raised taxes anyways. She has grown government spending by more than TWO BILLION dollars and what do we have to show for it? New Mexico is last in education, #2 in violent crime, and we now have the highest unemployment rate in the country. I will reform our tax system first and foremost by cutting taxes. We will get rid of the double and triple taxing facing our small businesses and allow families to keep more of what they earn.

**5.** I'm an outsider who will always be on the side of hard-working New Mexicans. If political and government experience made for great leaders, we'd have two of the best in Joe Biden and Michelle Lujan Grisham. That's clearly not the case. New Mexico is an amazing state, but the politicians have let us down. We don't need more political elites – we need leaders with character and integrity who will listen to people, understand their concerns, and fight tirelessly on their behalf for the change we need. That's what I will do.

**6.** My top three priorities are securing the border, fighting crime, and improving our schools. I will secure the border by deploying the National Guard and creating a Border Strike Force to target and disrupt the drug and human trafficking cartels. I will fight crime by ending "catch and release," supporting our men and women in law enforcement, and ending the current state of lawlessness by putting real teeth in our laws. To improve schools, we will get money directly to the classroom, empower parents, and help catch kids from up the learning losses they suffered from the COVID shutdown.

**7.** We need to make it easy to vote and hard to cheat. It's critical that to any democracy citizens have faith in their elections. That's why I strongly support a Voter ID law that requires voters to show photo identification to cast a ballot. I support early and absentee voting, however I will oppose the practice of automatically sending live ballots to homes without a voter request, as has been proposed by Governor Lujan Grisham. This opens the door to fraud, since 20% of the population moves every election cycle. I will also fight against any effort to legalize ballot-harvesting.

**3.** New Mexicans are frustrated with a failing economy, a failing educational system, and a failing healthcare system. Symptoms of these issues abound in the form of crime and families living below the poverty line. Our citizens and families have solutions to these problems, but government has stymied their ability to act in their communities. State government has overstepped its boundaries in deciding it should intervene where families have not instead of empowering families and communities to solve their own problems. I will fight to restore power to individuals and families in New Mexico.

**4.** According to Table 4.13 in the Book of the States published by the Council of State Governments, I meet all requirements outlined for qualification to run for the office of Lieutenant Governor including age, citizenship, and residency requirements. Further, I am a 13th generation New Mexican with a passion for preserving New Mexicans' culture, independence, liberty, and family values. I am the only candidate for Lieutenant Governor in New Mexico who is not controlled by a party agenda or divisive party rhetoric - I am running to represent YOU, not a political party.

**5.** As president of the Senate, I am tasked with bringing efficiency and integrity to the Round House in Santa Fe. New Mexico's congress has historically played political games in order to squash legislation sponsored by opposing parties or to maintain control of finances. Many of these games are played at the behest of special interest groups to detriment of our citizens. ## Maggie Toulouse Oliver (D) candidate Secretary of State

**1.** Experience. I've been an election administrator for over 16 years, serving first as a County Clerk in

Bernalillo County and then Secretary of State. As New Mexico's Secretary of State, I served as President of NASS (National Association of Secretaries of State) during the 2020 election, and led a bipartisan campaign combating election disinformation. My record includes overseeing an election during a pandemic and the state's largest wildfire, modernizing New Mexico's registration processes,

expanding ballot access, and creating and implementing a more transparent campaign finance system.

2. My top priorities include expanding ballot access, combating election disinformation, and continuing to shine a light on dark money by making our campaign finance system more transparent. I believe we should make it easier – not harder – for New Mexicans to vote. Election disinformation promotes voter apathy and undermines confidence and participation. As such, I believe my role as Secretary of State includes providing citizens with accurate and widely available information. Lastly, I want to continue making our campaign finance system more transparent so we know who is funding our politics.

3. While so many states across the country continue to pursue legislation that restricts access to the ballot, I support legislation and initiatives that do the opposite – it's a false dichotomy to suggest increased access comes at the expense of election integrity. This past session, I was in the Legislature providing expert testimony for a number of Bills that would expand ballot access and modernize New Mexico's elections. A critical part to this is also providing people with reliable sources of election information so they feel confident in our elections and voting procedures.

**4.** I would support changes to New Mexico's voting procedures that address issues related to accessibility, both when registering and casting a ballot. For instance, New Mexico is a rural state, and therefore we should do our best to accommodate the unique needs of our rural voters – whether that is expanding vote by mail periods or opening voting

convenience centers. I implemented same day registration so that, for the first time in our state's history, Independent and DTS voters had a chance to vote in our primary election – those are the types of initiatives I support.



## Audrey Trujillo (R) candidate Secretary of State

**1.** I have bachelor degrees in Criminology, Spanish and Portuguese as well as a Master in Public Administration

from the University of NM. I also have worked and volunteered at numerous jobs in the public, private and nonprofit sector, holding titles of Executive Director, President, Treasurer and Coordinator. In addition I have run my own state licenced businesses. I am also heavily

#### Raul Torrez (D) candidate Attorney General

**1.** New Mexico must continue to be a safe harbor for women seeking to access reproductive healthcare. We also

need comprehensive legislation to prevent bordering states from imposing civil and criminal liability on women and healthcare providers. I will work with the New Mexico Legislature to help craft such legislation and to provide the Attorney General's Office with the maximum authority required to prevent other states from utilizing state and local law enforcement or our courts to issue subpoenas, request discovery or assist in any civil or criminal matter targeting anyone who travels to our state to access reproductive healthcare.

**2.** As a prosecutor of nearly twenty years and District Attorney, I have seen the havoc gun violence has wreaked

on our community. As Attorney General, I will continue to advocate for common-sense gun control legislation that would implement stiffer penalties for threats of mass violence, particularly at schools, and for the use of guns in the commission of a crime. I have and will continue to support legislation that creates penalties for parents that negligently store firearms.

**3.** As a career prosecutor, District Attorney, and as Attorney General, I can use my experience in both the state and federal criminal justice system to work with the Legislature to craft common-sense gun legislation that is practical and reflects the needs of our community.

**4.** As Attorney General, I will enforce the rule of law against anyone, regardless of who they are, their party, or the office they hold. In addition to prosecuting public officials for corruption or abuses of power, I will also commit to ensuring timely compliance with the Open Meetings Act and Inspection of Public Records Acts.

**5.** I will work to rebuild the inhouse litigation capabilities of the office and work to end the extensive use of out-of-state law firms, particularly for consumer protection cases. The Office will aggressively investigate and prosecute claims of consumer fraud including price gouging, wage theft and worker misclassification, and abusive landlord and debt collection practices.

**6.** As Attorney General, I will use my nearly two decades of experience as a prosecutor to strengthen our criminal justice system by implementing common sense policies to keep violent, repeat offenders off our streets. Additionally, the Office will aggressively fight for consumers and workers, safeguard the environment, take on corruption and special interests, and protect our democracy and women's rights.



## Jeremy Michael Gay (R) candidate Attorney General

education, transparency, and prosecution. I will invest in educating New Mexicans on their rights as citizens so they will be less vulnerable and more empowered to identify and report scams, fraud, and corruption. I will maintain a policy of transparency by exposing those who are engaging in illicit activity and recognizing those who are examples of integrity and public service. I will prosecute criminal activity, fraud, and abuse to deliver results and real consequences for those who choose to victimize and illegally profit off honest citizens.

**4.** As Attorney General, I will act as a real watchdog for the people of New Mexico instead of as a political insider covering up for corrupt politicians. It will be clear in Santa Fe and across the state that the Attorney General's office will no longer turn a blind eye to misconduct. When political fraud, waste, or abuse is uncovered it will be exposed and uprooted.

Cracking down on exploitative adult guardianships by broadening the investigatory authority of the office and providing greater protection of vital public information and critical infrastructure by auditing cyber security funding.

**3.** These pre-approved, independent public accountants (IPAs) also audit all other public entities in addition to State agencies. Candidates for State Auditor (SA) should not receive contributions from IPAs as the SA regulates IPAs and approves them to engage in audits & imposes restrictions, including disqualification, depending on their performance. The SA also provides oversight of audit contracts in addition to determining, by rule, how often IPAs must rotate out of existing contracts. This prohibition

of campaign contributions to SA candidates protects the integrity of the Office of SA.



## Robert Jason Vaillancourt (L) candidate State Auditor

**1.** I was born in Albuquerque, New Mexico. I am the former General Manager of several NM Businesses. I am the former State Grassroots Director for a

national Nonprofit organization. I am willing to serve New Mexico and my fellow New Mexicans.

1. Thanks to the trust the voters have placed in me, for the last 4 years, I am proud to say I've raised the MOST

money, closed the most wells & protected more acres than any previous land commissioner. We made renewable energy and economic development top priorities. I've issued executive orders on water and the Greater Chaco Region, saving 100 million of gallons of freshwater and protecting over 70,000 acres from future development. I've established programs to hold bad actors accountable and ensure remediation and removal of abandoned wells, saving New Mexicans millions in cleanup costs.

**2.** Diversification is the biggest challenge we face. The billions we raise from oil & gas will not always be here and we need to look to protect our environment and raise money from other sources like: renewable energy, economic development and border commerce. This summer, I signed a lease for the largest wind farm in the western hemisphere to be developed on state trust land ensuring that we tripled renewable energy production in less than four years.

**3.** As a former teacher, I know firsthand how important our revenue is for education. My office has focused on expanding

and creating revenue sources like the new Netflix facility, tripling renewable energy and helping solve challenges like access to affordable housing. However, using our natural resources to generate revenue CANNOT come at the expense of the long-term health of the land. We've prioritized working with current lease holders to restore the health of our public lands, clean up spills, properly plug oil wells, and remediate environmental damage, all while maximizing revenue.

**4.** Support. We have gone above & beyond any previous land commissioner to enforce environmental regulations. In addition to closing more wells, demanding stricter methane and produced water regulations and protecting more acres, we have saved New Mexico taxpayers over \$15 million dollars in cleanup costs by taking companies to court when they're not willing to clean up their messes.

**2.** The past few years have shown me the biggest challenge facing the SLO is to stay focused on the job of the SLO. The mandated job of the SLO is to generate as much revenue as possible on state trust land while protecting the value of the publics asset (land). The SLO must be independent and free from ALL outside special interests and free from partisan politics. The SLO and its Commissioner should not be beholding to any political party. As an Independent candidate I owe no allegiance to anyone except Jesus Christ and the citizens of the state of NM.

**3.** The balance between responsible stewardship and max revenue generation should be the only focus of the Commissioner and the SLO. **4.** The PEC utilizes the state audit as a primary resource for assessing the stability of finances of a school. In addition, information is obtained from PED budget bureau as well as information from the financial framework data that is inputed every year of the contract term. It is difficult to assess the financial stability of a school that has not been in operation, however, prior to a vote for commencement of operation of a new school, the budget submit is reviewed by the PEC.

**1.** Yes. I was endorsed by the Bi-Partisan Judicial Nominating

Commission in November 2020 for the position I currently hold and appointed by the Governor

2. Serving on New Mexico's two highest courts, along with my over two decades in private practice helping New Mexican families and small businesses. As a judge, I have authored more than 125 opinions and decided hundreds of other cases in all areas of the law. While in private practice, I co-chaired the State Bar's Ethics Advisory Committee and now serve as the Supreme Court's liaison to the Disciplinary Board. I previously served as Co-Chair of the Advisory Opinions Committee, dedicated to advising judges on their responsibilities under the Code of Judicial Conduct.

**3.** Public financing of judicial races is the most important policy necessary to retain judicial independence and deter political influence. In 2021, the Legislature expanded public financing to all district court races. NM is the only state that provides public financing for both statewide and district court judicial races. Public financing alleviates concerns that a judge's decision was influenced by a large campaign contribution and promotes public trust in our judicial system. For that reason, I've applied for and secured public financing in my efforts to retain my seat on the Supreme Court.

**4.** Access and transparency. Expanding virtual hearings is cost effective, increases access, saves money for citizens, and increases legal service options to underrepresented communities. Virtual hearings reduce the time parties have to take off work to attend and eliminate transportation and childcare issues. Allowing unrepresented parties to e-file pleadings also expands access. Live-streaming Supreme Court oral arguments increases transparency, as the public can see our work. Expanding our outreach to NM's schools teaches students about the role of the courts and the rule of law in our society.



# Thomas C Montoya (R) candidate Justice of the Supreme Court

**1.** I have been endorsed three (3) times by the Judicial Nominating Commission for District Court Judge. I did not apply to

the Commission this time.2. 40 years of practice in all NM trial and appellate courts.

**3.** A judge must place the law above any other consideration in deciding a case. A judge cannot, in the performance of judicial duties, by words or conduct, manifest bias or prejudice, or engage in harassment, including but not limited to bias, prejudice, or harassment based upon race, religion, color, national origin, ethnicity, ancestry, sex, sexual orientation, gender identity, marital status, spousal affiliation, socioeconomic status, political affiliation, age, physical or mental handicap or serious medical condition, nor permit others subject to the judge's direction or control to do so.

**4.** Because the Supreme Court is the rule-making body governing all courts, attention must be paid to adherence to the Constitution and the rule of law throughout the state. Cases cannot be decided because of a desired outcome, but only on the law and facts of the case. Judges must decide on what the law is, and not what the law should be, in the opinion of the judge. There can be no respect of persons before the law, resulting in a different decision based upon the person or company which appears before the court. All persons are required to be equal before the law, regardless of rich or poor.

**1.** I was recommended by the Bi-Partisan Judicial Nominating

Commission and interviewed, vetted, and appointed by the Governor for this position on the NM Court of Appeals.

**2.** I have over 34 years of experience as a practicing attorney and judge in my home state of New Mexico. My experience is in nearly every area of law that comes before the courts of New Mexico. I served as a district judge for over 9 years and I currently serve as a judge on the Court of Appeals, having been appointed in April 2021. Before becoming a judge, I served as a prosecutor in the First and Fourth Judicial Districts. In my practice, I was a criminal defense attorney and I handled a wide variety of civil cases from divorces and auto accident cases to complex wrongful death cases.

**3.** First and foremost, the judiciary must remain independent from any influence, political or otherwise. I believe the current Canons of Judicial Conduct sufficiently set forth the expected conduct of a judicial candidate in a partisan election. However, I think the requirements to qualify for public financing for judicial campaigns should be adjusted. Instead of having our committees collect over 1,300 \$5 contributions, a different threshold should be required in

order to take money completely out of the process.

**4.** In New Mexico, every litigant is entitled to one appeal. The great majority of those appeals are heard by the Court of Appeals (COA). As a result, the COA has hundreds of cases on its docket. Each of these cases takes time to review and decide. Thus, the COA is a very busy court. The COA is working hard to resolve these appeals in a timely manner. However, the judges at the COA are acutely aware of the need to get these appeals resolved more quickly. Thus, the COA, myself included, is constantly looking at ways to more efficiently and expeditiously decide these appeals.



# Barbara V Johnson (R) candidate Justice of the Court of Appeals Position 1

**1.** Yes, for a District Court Judgeship. However, I was not appointed by the

Governor.

**2.** I have been a Family Lawyer since 1988. Family law involves everything that touches the lives of our citizens. Some of those kinds of cases are divorces, custody and time sharing, child support, peoples' houses and personal belongings, at times domestic violence, crimes, business matters, estate planning and retirement plans. **3.** Many policies protect judicial independence. The Code of Judicial Conduct requires judges to maintain independence, integrity, and impartiality, whether campaigning or applying the law. District court judges' decisions are subject to one automatic review and the Court of Appeals' decisions may also be further evaluated by the New Mexico Supreme Court. The Judicial Standards Commission reviews a judge's professional conduct and assists the public to decide whether to retain the judge. The judge, though, must recognize her own biases, adhere to the law, and disregard political influences.

**4.** The Court of Appeals is responsible for reviewing almost all cases appealed in New Mexico, involving nearly every area of the law. Because we are a such a busy, the biggest need is to move cases through the system so that appeals are timely heard and parties get the resolution they need. Since joining the Court, I've utilized my appellate, trial, civil, and criminal experience to work with my colleagues to be an active and productive addition to the Court. I have focused on learning quickly, carefully reviewing cases, and keeping in mind the parties who are waiting for decisions.



#### Gertrude Lee (R) candidate Justice of the Court of Appeals Position 2

**2.** My experience as a manager and trial attorney has prepared me to serve on the Court of Appeals. For twelve years I have worked as a trial attorney and prosecutor. In Gallup, I represented the State in numerous jury and bench trials in the Magistrate and District Courts. I also filed several appeals on behalf of the State. I continue my work as a prosecutor in Farmington. I also served as the Chief Prosecutor of the Navajo Nation where I managed ten prosecutor offices and several dozen staff across the reservation in addition to practicing in the tribal courts.

**3.** It is absolutely essential for a judge to be impartial and to maintain the rule of law. This means judges should be open minded, unbiased, remain impartial and non-partisan when rendering decisions.

**4.** I believe bringing balance to the Court would be an improvement. The Court could use an addition who has significant experience practicing in rural New Mexico and tribal courts. My addition to the bench would add a completely different voice to the Court of Appeals. I was born in Shiprock and grew up outside Farmington. I am a member of the Navajo Nation (my clan is Near to Water born for Big Water). I have practiced law in rural New Mexico my entire career and I have experience in tribal court. Because of my work in public safety, I also appreciate the criminal law issues New Mexicans face.

2. The first step is that the state of New Mexico, particularly our leaders must commit to and begin the process of implementing a multigenerational road map to end our dependence on oil and gas and other extractive industries. Under my leadership, and the support of the work of Senate Pro Tem Mimi Stewart, not only was a Sustainable Economy Taskforce created but within it, an advisory council that appoints those on the frontlines, with just transition language, should be prioritized.

3. My top priorities are to address climate by centering on frontline communities, working toward economic justice for oil and gas workers, and making sure that they have a future outside of this industry. Overall, I work towards addressing and supporting workers in the private sector and making sure that they have what they need to not only have a dignified wage but also be provided with the support that they need to live an excellent quality of life.

4. The supreme court of New Mexico has ruled that not only must we provide our students with the funding that they need, but this instruction needs to be done so appropriately and accordingly. Black, Indigenous, and Communities of Color should not be educated nor informed from a colonized perspective, but instead, education that is rooted in where they come from and the languages that they understand. Public schools across the state have worked to prioritize this, and we must too.

**5.** The budget is developed by just a small group of legislators--mostly handpicked by the chair, who historically is too fiscally conservative, with staff at the Legislative

Finance Council setting agendas based on what they think should be prioritized. While I have a lot of respect for the individuals themselves, this process must be modernized to make it not only more accessible but that it reflects individuals that represent those in our communities who are in need of revenue and investment.

**6.** Absolutely yes, but those policies must be led by the marginalized that are directly impacted first and foremost. The US Supreme Court decision is deeply disappointing and already has had devastating consequences for so many across the country. # Robert Lara, Jr (D) District Court Judge Third Judicial District candidate Division 2

1. Since 2009 I have been representing children, families, and businesses in family, probate, and civil matters throughout New Mexico. Currently, I work for the Third Judicial District Court as a staff attorney. I provide the Court with research and recommendations relating to the cases before the judges. Judges do not work alone to help litigants; I have experience working with therapists, agencies, and non-profits that help solve legal and non-legal problems.

**2.** The Court must ensure that its decisions are based on accurate and unbiased information. Making sure that the needs of the protected individual are accurately reported to the Court

is the only way to ensure these cases can be helpful to the families involved. To ensure fair and equitable outcomes the Court must hold guardians, attorneys, and medical professionals accountable for their actions and the information they provide in guardianship and conservatorship cases.

**3.** Backlogs happen because litigants are often not aware of the next step in their cases or ignore their duty to move their case forward. As a judge, I will make sure self-represented litigants are aware of case deadlines and hold them accountable to move their cases forward. I will promote settlement facilitation or mediation whenever possible for attorneys to help resolve cases before trial. This will help avoid backlogs and free up Court time to hear other matters.

**4.** Litigants are self-represented in 80% of family cases. The Court needs to improve by educating families about the court process and the resources available in Doña Ana County. Bilingual outreach is key to ensuring everyone can understand their rights. Further, the Court needs to continue to allow remote appearances for certain hearings as it permits more individuals to participate. Having greater access to the Court and understanding of the law is vital to ensure everyone has access to justice.

half I spent litigating cases for local businesses, Dona Ana County, and the City of Las Cruces. Further expansion of retention ponds, with adequate relief to empty the ponds within the required 48 hours and continue to ensure developers provide neighborhood retention ponds and a long term process to maintain them. Re-evaluate the priorities of our flood risk areas, so that people and property have a higher priority and find a way to provide more assistance to those who suffer from flooding.

**3.** I agree we need more judges and consolidating facilities is a good idea. The plan to expand the current Court facilities to accommodate additional judges and services is like a band-aid.

**4.** Do we need a Crisis Triage Center? Yes! Am I satisfied with the current services? No.

A facility that only has 23 hours to address a mental  $\,$ 

health crisis is insufficient and inadequate. It's always been a matter of the Contracted Services being insufficient and we (the County) overpaying for those services. I am not satisfied that the Doña Ana Community is receiving the services we paid for, nor the needed services. I am dedicated to a Crisis Triage Center that provides full services.



## Patricia Susan Kimble (R) County Commissioner candidate District 3

**1.** The primary focus of my work through the years has been healthcare,

including behavioral health. I have worked in health insurance, healthcare marketing, business development, and management. I believe that I have the experience and understanding that will help Dona Ana County thoughtfully and responsibly oversee the financial decisions regarding funding for healthcare. I listen to both sides of issues to gain knowledge that is relevant; I work well with others to build consensus.

**2.** Dona Ana County has at least ten flood control projects in the works currently. The issue for projects in the County is most often funding. The County has identified the needs, designs, and cost for projects in every sector of the county. The total projected cost to complete these projects is over \$80 million. The County has been making progress. I believe the work will be complete and in place as quickly as possible given the financial situation.

**3.** As our population grows, the need for more judicial services grows as well. Currently, the Judicial Complex is at capacity; no further services or judges can be added. This shortage of services could potentially delay cases and could lead to dismissals due to time restrictions.

**4.** The current services offered by the CTC are evidence-based effective services for the clients that do present there. In speaking with providers and clients, I have heard no complaints about the services or the connection to providers in the County. The Center follows the National best-practice standards for crisis receiving centers. I am not satisfied with the fact that the CTC cannot accept involuntary clients for assessment. I believe the CTC staff/RI staff will work to change that soon.

#### Kim Kristine Stewart (D) Doña Ana County Sheriff

**1.** I have been the Sheriff for 3 years. When I took Office, this was a poorly organized, structurally inadequate agency bereft of a clear vision. Much of

what was operating in DASO was at about a 1980's level of service. As I had been in law enforcement in a very forward

thinking and wealthy state, I was able to quickly assess our basic needs and moved to update systems and operational practices. Those concerns, while greatly improved, will continue to be my focus next term. To adapt is to thrive.

**2.** Recruitment has been a challenge to law enforcement for decades. The issue of attracting a diverse workforce remains as significant today as when I was first hired in 1980. DASO has no shortage of deputies but we work everyday to ensure equity of opportunity and treatment. House Bill 68 will also provide us with funds directly aimed at retention of law enforcement officers in our state. It is especially significant in providing financial incentive to those who are at 20 years of service now.

**3.** We cannot alone reduce the crime rate; those rates rise and fall for various reasons. We do work to strengthen community partnership, which hopefully results in increased reporting and encourages positive interactions. We can deploy our deputies more strategically and flexibly to target hot spots. We can look to non-traditional personnel to fill positions previously held by deputies. The answer is not always more deputies, as some may believe; the research does not support this contention.



## Byron N Hollister (R) Doña Ana County Sheriff

1. I am the only veteran candidate. I am also the only business owner. I have over 24 years of law enforcement experience

most of which was at the executive level. I have the ability to bring agencies together to for task forces to fight problems.

**2.** I was selected as one of the few interviewers for new candidates for the US Marshal Service. I will take recruiting into my own hands. There are an abundance of good local people who would make great deputies. being here for over 35 years I know a lot of people and would start my recruiting locally.

**3.** On day one I would put us back into the program/ grant Stone Garden. I would also utilize HIDTA again. High Intensity Drug Trafficking Area. This is money and resources that are free to the department to help lower the crime rate and boost morale at the same time.

my work with victims and their families gives me the direct experience with grieving families and how to guide them through the Probate process. I hold a BA in Criminal Justice and Associate's degrees in Criminal Justice and General Business from NMSU.

**2.** My plan is to conduct outreach clinics with printed information about the Probate process at the County's Community and Senior Centers. As Probate Judge I'll go on various radio shows and issue public announcements to the medias--all to reach out to people about the Probate process, and the importance of having a Will.

**3.** I will reinstate the free Marriage Ceremony, once a public service from the Probate Judge that was discontinued with the current probate administration. I will be available in the Probate Office week days, as I believe the Probate Judge should be a servant of the public. I want to make the Probate Office and its processes known to the Public through my outreach services.

#### **MAGISTRATE JUDGES**

All seven Magistrate Judge positions are up for election and none is challenged.

Magistrate Courts have limited jurisdiction, hearing cases with claims up to \$10,000 in tort, contract, and landlord/tenant civil cases, plus misdemeanor, DWI/DUI and other traffic violations. Magistrate Judges also conduct preliminary hearings in felony cases. Minimum qualifications: at least 18 years of age, resident of the district, high school graduation or equivalent.

"PROPOSING AN AMENDMENT TO ARTICLE 12, SECTION 7 OF THE CONSTITUTION OF NEW MEXICO TO PROVIDE FOR ADDITIONAL ANNUAL DISTRIBUTIONS OF THE PERMANENT SCHOOL FUND FOR ENHANCED INSTRUCTION FOR STUDENTS AT RISK OF FAILURE, EXTENDING THE SCHOOL YEAR, TEACHER COMPENSATION AND EARLY CHILDHOOD EDUCATION; REQUIRING CONGRESSIONAL APPROVAL FOR DISTRIBUTIONS FOR EARLY CHILDHOOD EDUCATION."

#### **Arguments For**

- 1. Allows the public to evaluate an appointed candidate on the merits prior to election.
- 2. Enables greater access by judicial candidates to public financing.
- 3. Helps with recruitment and diversity for judgeships.

#### **Arguments Against**

- 1. Delaying the election may have unintended consequences.
- 2. Unclear if the new language applies to judges other than appellate judges.
  3. Removes an inherently political decision from the political process for a longer period than the Constitution of New Mexico currently provides.

### **NEW MEXICO GENERAL OBLIGATION BONDS**
