As the past president of the New Mexico Child Care and Education Association and current president of Full Circle Advocacy Group and Community Services, she collaborates regularly with government officials and nationwide programs to create an early childhood education system that allows all children to thrive while focusing on every community's individual needs.

Appointed to serve as one of seven local leaders guiding the newly formed steering committee in the Early Learning Nation Collective funded by the Bezos Family Foundation, Angela has always seen inequalities in her community and the need for change in New Mexico and in the country.

Angela truly believes that if we want change, we must start early. Angela plans to continue utilizing her energy and learned experiences by sharing her story and raising the voice of those with whom she works.
