Hoy Road widening on track

MADISON - Hoy Road is finally taking shape, the mayor says, and the improvements are expected to greatly improve traffic flow by the spring.

"After many years of negotiations it is exciting to see the project take shape and see a change in the flow of traffic," said Madison Mayor Hawkins-Butler. "I believe the residents will be pleased."

The improvement project was originally projected to be completed in the spring of 2022 and is on schedule, officials said..

Stan Wright, Hoy Road project engineer with Neel Schaffer Engineering, said the project is "on schedule," and he expects the work to be completed early next year.

Hemphill Construction, began work on the \$9 million project in September 2020.

The project includes improvements to the intersection of Hoy and Rice/Tisdale Road; curb, gutter and sidewalk improvements; a multiuse path; and the widening of Hoy Road to five lanes from Old Canton Road to Victoria Place.

From there it will remain two lanes to the east. The widening project has left that section of the road westbound only for much of the

Hoy Road remains open for westbound traffic only from Rice Road to Old Canton Road, with Tisdale Road as the detour route.

NEW BEAR CREEK WATER WELLS

Usage exceeds 1.8 billion gallons

Population growth in south Madison County has necessitated the addition of two water wells currently under construction by the Bear Creek Water Association generating some interest on social media.

Bear Creek currently pumps about 1.8 billion gallons of water annually from nine wells each about 1,200 feet deep in what is known as the Sparta aquifer.

Growth in the 105-squaremile service area of Bear Creek that includes Madison, Gluckstadt and nearby unincorporated areas necessitated the first new wells since about

An aerial photograph on the Gluckstadt Facebook page recently showed one of the new wells being drilled on Clarkdell Road that runs east of U.S. 51 between Yandell and N. Old Canton.

"Does anyone know what or why they are drilling on Clarkdell Road? The drilling has been going on for about a month now..." the post stated.

People immediately responded in the comments speculating that workers were drilling for Co2 or natural gas.

One early commenter called on Nolan Williamson, general manager for the Bear Creek Water Association.

"Nolan Williamson? You typically know what's up," the commenter stated.

Williamson did not take long to reply to say it is a "water well. 20-inch casing, about 1,200 feet deep. Going to pull about 1600 GPM from the Sparta aquifer."

"We are pumping about 1.8 billion gallons annually with 9

wells," Williamson said in another comment on the Facebook post. "During peak times it is hard to keep the tanks full. This well is about \$1.6 million. This is a well. This will not be an elevated tank."

Williamson said the well on Clarkdell Road is one of the two wells the association is currently drilling. The other well is on North Livingston Road, which is west of I-55.

The well on North Livingston Road will add about 558 million gallons annually and the one on Clarkdell 470 million gallons annually, according to the permits, to the association's water output, Williamson said.

"(The North Livingston Road well) is a little further along right now, meaning it's drilled and they moved that drilling rig from North Liv-

Retired general served country for 41 years

Retired Maj. Gen. Don Roberts of Ridgeland served in the Air National Guard for more than 40 years.

"Not everyone truly grasps the meaning of Veterans Day and some people take freedom for granted," Roberts said in advance of this year's Veterans Day observances that will be celebrated today (Thursday) to honor all the men and women who have served in

the nation's armed forces.

Canton records 7th homicide of year with Richard Circle shooting

Canton recorded its seventh murder of the year last week after police found a man dead from a gunshot wound behind a

residence on Richard Circle. Police Chief Otha Brown said that officers were called around 6:45 p.m. Wednesday, Nov. 3, reporting an unresponsive male in the backyard of a Richard Circle residence. The man has been identified as Michael Winston, 50, who was declared dead on the scene.

Brown said they believe Winston was trying to get to a neighbor's house to find help after he had been shot in the groin area. Winston lived a street over on Sherwood Drive. Brown said Winston would have been able to walk through his backvard to the residence where he was found.

'We know that something took place at his house though we do not know what happened," Brown said. "We are still looking for the person or persons who may have done this. We are hoping to get some

information from the public."

Winston's death is the seventh murder of the year in Canton one short of last year. Eight murders were recorded inside the city of Canton last year, making it the most violent year for the city in recent memory.

The most recent murder this year, prior to Winston's death, Brown said, was Jaihlen Sims, 17, who was killed by a gunshot wound to the head after someone had shot into his Canal Street apartment Oct. 6 between 1:30 and 1:35 a.m.

The year 2020 was capped by a triple homicide of mem-

bers of a family of immigrants from Guatemala. Officers found Faustino Ramirez, 20, and his pregnant wife, Martina, 19, dead with gunshot wounds to the head around 1:30 a.m. on Dec. 29, Brown said.

In response to ongoing violence in the city, the board of alderman approved an ordinance in September requiring local businesses to have security cameras. Brown said the ordinance will take effect on Dec. 1 and he hopes they can have most of the businesses compliant by the end of this year or the beginning of 2022.

"We want people to feel safe visiting our city and our locals to feel safe," Brown said.

Brown said he has not heard any forceful pushback to the ordinance. He said he had a recent conversation with a merchant who had concerns about the cost of installing cameras.

Brown said the ordinance requires at least two cameras, one to cover the exterior and one to cover the interior of a business. He said business owners did not need to get elaborate security systems and could likely find cost-effective solutions at a big box store.

"I told her that it was an effective crime preventer," Brown said. "If businesses have cameras it helps make sure anyone who wants to commit a crime will think twice about it."

Brown said the cameras will also be an effective way to add eyes and ears on public spaces as his officers "can't be everywhere at once.

Brown said he is currently working with city officials to find a camera or monitoring system that they can install on public property to "meet them

Ridgeland Police Chief John Neal said that during their investigation officers determined that Robinson and Johnson had attempted to hide potential evidence by removing firearms from the vehicle and discarding them along the side of the interstate.



Madison City Hall site of Hero Tree for veterans

Madison City Hall is one of several locations for the third annual Hero Tree veterans project this year hosted by Heart of Hospice of Jackson.

Hero Trees allow people in the community to grant Christmas wishes to 200 veterans and adults living in senior residential care throughout the metro area.

"Madison City Hall is proud to host the Heart of Hospice Hero Tree this season," said Mayor Mary Hawkins-Butler. "This is a wonderful way to spread Christmas joy to our veterans and seniors. I encourage everyone to stop by City Hall to pick a flag off of the tree to fulfill holiday wishes for those who have sacrificed for each of us."

Along with Madison City Hall at 1004 Madison Ave., Club 4 Fitness, 1022 Highway 51 in Madison; and Shucker's, 146 Conestoga Road in Ridgeland are the other Hero Tree locations in Madison County.

Amanda Houck, a senior administrator for Heart of Hospice in Jackson, said the Angel Tree Christmas program put on by the Salvation Army each year inspired the

Hero Tree program.
"We felt there was a need

to serve those who served us,"
Houck said. "Those people
being our homeless veterans.
Like the Angel Tree program,
which collects toys and other
items for children in need, the
Hero Tree collects personal
care items such as shampoo,
conditioner or stamps for
homeless veterans in need."

Houck said each Hero Tree is covered in flags, with each flag serving as a veteran's wish. Someone can take a flag and purchase a personal care item. She said once all of the items are collected, they are then delivered to the locations where each veteran's wish came from, such as the Veteran's Affairs Hospital in Jackson, or nursing homes such as The Woodlands, The Home Place, Plain View Assisted Living, Forest Hill and The Bluffs.

"We served 208 veterans last year, and we're aiming to serve around 220 this year," Houck said. "Anyone can come to get one of the flags from a sponsored location, or they can help out by dropping off cleaning supplies, gloves or any other personal care item at any of our sponsored locations without taking a flag."

Houck said that in addition to the Madison County locations Heart of Hospice has sponsored Hero Tree locations at the Rankin County

Chamber of Commerce in Brandon and the VFW office in Hinds County.


"We had to borrow flags from other trees to bring to them to Shucker's since they kept running out," Houck said. "The feedback on this has been great, and a lot of people have reached out to us on social media. As of right now, Madison City Hall has reported that they've already run out of flags."

Houck said the most important part of the Hero Tree project is thinking of the homeless veteran community and other places that need help, especially in times like these.

"With Veteran's Day being in November, we roll this out in the first week of the month to highlight it around Veteran's Day so the wishes can be delivered to the veterans during the Christmas season," she said.

ingston over there to Clarkdell," Williamson said.

Work left to do on the North Livingston Road site is setting the pump and the generator and building a well house.

"That kind of stuff, so it is a little further along," Williamson said.

Completing a well takes approximately 10 or 11 months, Williamson said,

adding the North Livingston Road well should be complete by March and the one on Clarkdell Road will be completed by July.

"The drilling rig will be gone before then," Williamson said of the Clarkdell Road well. "The drilling rig might be gone by January but the well won't be in service until probably July. Once the drilling rig

is gone there is still a lot of work left to do."

Williamson said the Bear Creek Water Association services a little more than 18,000 meters, mostly residential customers but also some commercial customers, representing some 40,000 to 45,000 people in south Madison County.

Russia collusion hoaxers

Whether a tree falling in the forest makes a sound is open to debate, but there is little question that a Clintonista falling in the Washington swamp makes a massive splash. Another player in the Russia collusion hoax has, indeed, dropped into the muck, thanks to Special Prosecutor John Durham. A key to repairing Americans' years of broken trust in government is rewinding the historical tape and exposing the villains responsible for saddling the Trump presidency with their own treasonous behavior.

The recent arrest of Igor Danchenko, a principal source of allegations against then-candidate Donald Trump, suggests Mr. Durham is also tracking an asset of Democratic candidate Hillary Clinton's 2016 presidential campaign who helped cast Republican rival, Mr. Trump, as a Russian tool.

First came charges against FBI lawyer Kevin Clinesmith, who pleaded guilty last year to falsifying information presented to the secret Foreign Intelligence Surveillance Act (FISA) court to win permission to spy on the Trump campaign. Second indicted was Washington lawyer Michael Sussmann, who hid his Clinton campaign affiliation when plying the FBI with Trump-Russia collusion allegations contained in a dossier compiled by former British spy Christopher Steele and funded by the Clinton campaign.

Third is Mr. Danchenko, a Russian employed in 2016 by the liberal Brookings Institution. The indictment charges him with five counts of lying to the FBI regarding the source of "derogatory information ... concerning Trump's purported ties to Russia (the 'Company Reports')." The information became the basis for the

so-called Steele dossier.

If three's the charm, No. 4 along the investigative trail could prove the lodestone, a perfidious power within the Clinton circle. Mr. Danchenko falsely denied having communicated with an individual who was "a long-time participant in Democratic Party politics and was then an executive at a U.S. public relations firm ('PR Executive-l')," reads the Danchenko indictment. "In truth and in fact, and as Danchenko well knew, Danchenko sourced one or more specific allegations in the Company Reports anonymously to PR Executive-l."

News reports identify "PR Executive-1" as Charles H. Dolan Jr., a long-time Democrat and adviser to Mrs. Clinton's presidential campaigns. From the communication links already exposed, it is clear that investigators believe Mr. Dolan trafficked lies about Trump-Russia collusion. Mr. Danchenko passed the falsehoods to Mr. Steele, who incorporated them in his dossier. Mr. Sussmann echoed the lies with his whispers to the FBI. Then, the anti-Trump material served as the investigative basis for FBI lawyer Clinesmith's deception of the FISA court, which led to the government spying on the Trump campaign and subsequent efforts to destroy a sitting president.

"PR Executive-I" Dolan, as well as Messrs. Sussmann and Danchenko, enjoy the presumption of innocence in a court of law. Sadly, Donald Trump was afforded no such presumption in the court of public opinion. Americans deserve to know the role of each Democratic Clintonista involved in the Trump-Russia collusion hoax.

Enforcement, courts key to moving needle in Jackson

The first order function of government and society is to provide for the security of its people. Specific action items for Jackson: (1) Enforcement. (2) Courts.

(1) Enforcement. This city is under-policed, and it is vastly under-policed. We essentially have large swaths of the city that are not policed, and not because police don't care but because there are not enough police.

There is vast agreement in the fields of criminal justice and criminology that police presence deters crime. Think high school classroom with and without a teacher in the room. We have a lot of classrooms without a teacher and do not have an appreciable

police presence citywide.

We need to axe unnecessary programs, some of them very expensive like the zoo, and invest in policing. Security is *the* first order function of government and society, and we're not doing it. Without security, you have nothing. The city and mayor controls policing directly.

(2) Courts. Courts move too slow, and this jams up the system and enforcement before it. This either does in effect or in fact discourage/prevent enforcement from sending new arrests (i.e., "inputs") into the system.

When one side points to the other, as they so often do, they are in part telling the truth and in part lying.

Speedy trials are important whether you view it as a civil libertarian or law and order type. To the civil libertarian (and hopefully everyone), constitutional rights matter and people have a right to a speedy trial.

To the law and order type, evidence becomes more complicated over time (e.g., witnesses move or die) and cases harder to prosecute. Judges and DAs can work together to move cases faster.

Judges can generally even force it. Sometimes they can't force it, and I'm speaking specifically here about the backlog at the state crime lab which runs reports for homicide cases and others and delays in results of mental health evaluations in cases where that defense is raised.

The state can help with the state crime lab and mental health evaluations. These issues delay prosecutions within the state's county courts. The city and mayor do not directly control courts or state crime lab or mental health evaluations, but they

have a voice in pushing the issue AND NOT JUST pushing blame that direction when they are not handling enforcement.

So these are the two sides (enforcement and courts) where we move the needle. When one side points to the other, as they so often do, they are in part telling the truth and in part lying.

This gets solved by the mayor, judges, DA, police chief, sheriff, etc. all sitting together at a table and solving the problem. Like adults. With this remark — arrogant, dismissive, contemptuous — in his debate with Glenn Youngkin, Terry McAuliffe committed a historic gaffe.

From that debate forward, his poll numbers steadily sank until McAuliffe lost his lead, and with it, the election.

And going down to defeat, McAuliffe dragged with him his fellow Democratic candidates for lieutenant governor and attorney general and watched Virginia's House of Delegates revert to Republican rule.

What was McAuliffe saying, and what were Virginians hearing, in his remark? McAuliffe was saying that, in deciding what should be taught in its public schools, Virginia parents should just sit down and shut up.

God's law vs. human tradition: Part V

Please turn with me in your Bibles to Matthew chapter 5:38-42. This passage has been party to many common misunderstandings. It was in Jesus' day, and it is also in ours. I would like us to attend for a few moments what Jesus is, in fact, saying in this passage. In fact, we find three great truths that Jesus sets down. First, that personal vengeance is not justified in God's moral law. Second, that we must be guided by a spirit of love, not revenge. And third, we must be people of love and kindness even towards our enemies.

I. Personal Vengeance Is **Not Justified in God's Moral**

In verse 38 Jesus is attacking the false teaching, the false interpretation of the Pharisees on the law. And He teaches us in the passage that we must not justify personal vengeance by appealing to God's moral law. In verse 38, we read, "You have heard that it was said, 'An eye for an eye and a tooth and for a tooth." Jesus knows that that passage was being quoted by Pharisees and they were using it to argue that personal vengeance was a command allowed for by Moses. The original intent of the Mosaic legislation in Leviticus 24 of what we call the lex talones, the law of the talon, the law of the claw is not a law promoting personal revenge. It was intended to do several things. It was, first of all, designed to discourage people seeking personal revenge. The law of Moses all along was designed to prevent personal revenge from taking over. The second thing the law is designed to do is to administer justice through the courts. You see, an eye for an eye and a tooth for a tooth is a counsel on giving proportionate punishment. In fact, that is the next thing that this law is designed to do. It is designed to make sure that penalties for crimes are just and proportionate. Notice it says, an eye for an eve and a tooth and a tooth. Not a tooth for an eye and an eye for a tooth. Whether it is a monetary fine, or some sort of other fine. The penalty ought to fit the crime. In other words, the penalty should neither be too lax, nor too severe. That is not a call to vengeance.

it is call to equity, to justice in

the punishments which are verse 40, we see Jesus tell us signed by the judge. And that is designed to promote Israel's safety. Notice also, that this law is designed to put the fear of God into people who work wickedness. Those who work wickedness ought to fear the swiftness and the severity of the punishments that will be meted out under this law.

II. We Must Be Guided by a Spirit of Love, Not Revenge.

Jesus comes to tell us, in contrast to the Pharisees view of this command, what He says the command means. And we learn that in verse 39, and this is the second thing Jesus teaches us in the passage. That we must not be guided by a spirit of revenge. but by a spirit of love and of peace. In verse 39 He says, But I say to you, do not resist an evil person, but whoever slaps you on your right cheek, turn the other to him also." Jesus here gives His interpretation of the law, and He condemns the spirit of lovelessness, of hatred, a spirit that yearns to have revenge. He enjoins us as believers to have in our attitudes, and in our words, and in our deeds a desire to show that we are filled with a spirit of love and not a spirit of animosity and hostility. Christians bear witness to the love of God implanted in them when they respond to wickedness with

III. We Must Be People of Love and Kindness Even

Towards Our Enemies. Jesus teaches in verses 39-42 that we must positively be people of love and kindness even towards our enemies. He says in verses 39-42: "Whoever slaps you on the right cheek, turn the other to him also. If anyone wants to sue you and take your shirt, let him have your coat also. Whoever forces you to go one mile, go with him two. Give to him who asks of you, and do not turn away from him who wants to borrow from you." Jesus applies the real meaning of the law to four different situations in human relationships. In verse 39, for instance, He is talking about how we should respond to those who threaten to injure our bodies. Whoever slaps you nary. He can be reached at on the right cheek, turn the 601-923-1600 or by email at other to him also. Notice in

what our response ought to be to those who would rob us of our belongings, of our estates. How should we respond to them? Jesus says if anyone wants to sue you and take your shirt, let him have your coat also. Christ is not telling you that Christians may not resort to a court of law. That is not His point. His point is to detect an attitude in us. Are we quick to demand our rights, are we quick to press our interests despite the needs of others, are we willing to forebear and to forego our rights for the sake of the kingdom? Notice in verse 41, He speaks there of how we ought to respond to those who want to rob us of our liberty. Those who want to press us into service that we don't want to be in. Whoever forces you to go one mile, go with him two. Notice also in verse 42, he says to us, "Give to him who asks of you, and do not turn away from him who wants to borrow from you." There he speaks of how we ought to respond to those who are in distress, those who are in need of assistance. Do we respond in our giving, in our charity with generosity, or are we grudging? Do we give to charity, grudging every step of the way? Thinking of how much fun we could have had with that money, how much better we would spend it if we had that money to ourselves? Do we lend in time of need for selfish reasons, for the gain of interest, of excessive interest? Or do we lend selflessly, for the benefit of others? You see, the whole thrust of Jesus' teaching here, is us abdicating our rights for the sake of the kingdom and for the good of others. What is your heart like today? Is yours a heart filled with love, or with bitterness? If it is filled with bitterness, you will never be able to extract yourself from that bitterness by your own strength. You need the grace of Christ. May we now trust in him and

JOB DESCRIPTION DETAILS:

The new City of Gluckstadt, incorporated in 2021, is seeking a candidate to fill the position of Building Official. This position will be two-fold, encompassing duties of code enforcement and building inspection, as well as zoning administrator. The Building Official is administrative, technical, and skilled inspectional worker directing the enforcement of the City's building code, zoning ordinance, and other applicable ordinances as adopted by the City of Gluckstadt. Work involves responsibility of directing, supervising, coordinating, and enforcing the inspection of buildings and their appurtenances throughout the City to assure adherence to municipal building, electrical and related codes and ordinances; and for adherence to applicable standards of construction, maintenance, and safety. The employee in this class works independently, managing field inspections and training and instructing inspectors how to apply written and standards codes to everyday building and construction situations. Work is evaluated through conferences, discussions, and reports. Essential functions include supervision, training, enforcement, inspections, communications, clerical duties, and office management.

Examples of code enforcement and inspector work include: directs and coordinates inspections in the enforcement of building and electrical codes, and signs and other ordinances for the safety, health, and welfare of the public; applies various written codes and ordinances to everyday building situations; performs complicated inspections to ensure proper enforcement of codes and ordinances; confers or corresponds with architects, building owners, and contractors concerning questions involved in the enforcement process; makes recommendations for changes in ordinances and regulations governing the municipal building inspection program; reviews complicated plans and/or designs before permits are issued for construction, alteration, and repair; meets with zoning board and serves as advisor on all zoning matters; meets and serves as advisor to Mayor and Board of Aldermen on matters pertaining to City codes and ordinances and cases on appeal; ensuring that reports on all inspections, construction, research materials, etc. are written and maintained; assisting in all administrative activities associated with building inspection and zoning matters; ensuring that all phases of the various permit applications are completed in a reasonable amount of time; advise on ways to improve office efficiency and procedure; coordinate with contractors about various inspections required; maintaining data files and prepares reports, detailing the weekly, monthly and yearly issuance of building permits and inspections; conducting information research and compiles special data on assigned projects; attend a continuing education hours annually in the area of zoning, building permits or emergency management; coordinating with the various utility companies regarding water and sewer connections for new construction; assists in the preparation and control of budget expenditures; does basic bookkeeping and/or statistical record keeping not requiring specific accounting or statistical analysis knowledge; reviews and processes correspondence, reports, requisitions, payment requests, and similar administrative activities; maintaining zoning files and maps; serves as a researcher for general zoning matters; confers with City Officials, and technical advisors on difficult cases; and performing other duties as assigned.

The Building Official receives policy direction from the Mayor and Board of Aldermen, but also provides administrative and technical assistance to the Mayor and Board of Aldermen and provides a positive atmosphere as a public servant to the community. The successful candidate must be able to work effectively with elected officials, officers of the city, other department heads, the city attorney, representatives of other agencies, other city employees, and the general public, and must be able to communicate effectively, orally, written, and electronically. The person in this position may eventually supervise full-time and/or part-time employees and will work regular business hours yearround, with regular overtime and night work, attends and participates in professional group meetings, and has accountability for certain building code and zoning issues related to the work for which this position is responsible; an ability to attend evening meetings and other code-enforcement and zoning obligations is also required.

This is a full-time permanent position with the City of Gluckstadt; the immediate supervisor for this position is the Mayor. The Building Official is expected to develop effective methods & routines for accomplishing job responsi-



God is sovereign over history

Lord willing, we will resume the study in Acts at the first of the year. This week we are looking in Isaiah 41. In this passage, God speaks to the nations and people of the world and then to his people who are called by his

He speaks to the people of the world in verses 1-7. He tells them to listen to him in silence (verse 1). He warns them of their accountability to him. He is beckoning them to his judgement. The "coastlands" is a phrase pointing to the remotest ends of the earth, signifying that no people are excluded from God's judgment. So there is reason to be silent and listen. The opportunity to turn from delusions is being offered by the Lord.

The Lord speaks of a new power out of the East who will come upon the world's scene at some point in the future. This conqueror will easily trample all those in his path (verse 2). The point here is that he is an instrument of judgment in the hands of the

The nations may look upon this conqueror as random or unfortunate, but the Lord says this rampage through the lands originated in heaven. God, who is sovereign over history, has raised this leader up for his purposes. When the Lord tells men what will happen in the future, he is inviting them to consider that their souls are in his hands.

The Lord says his name is I am, the first and the last (verse 4). He is the only noncontingent being in the universe. Everyone else and everything else depends upon him. In this context, with the Sovereign Lord appealing to them, it seems terrible for men to set their wills against his when they can turn and escape the danger before it is too late. But men have strong trust in their own devices.

The nations react in fear when the new conqueror emerges (verse 5). Their collective answer is to encourage each other to "be strong" (verse 6). They do not humble themselves and seek the Lord; rather, they prop up their courage by looking to their own resourcefulness to build better and stronger idols to protect themselves (verse 7).

We are taught a lesson here that is themat-

ic in the Bible. Judgment comes because it is deserved. When it is delayed, it is due to the mercy of God. God's appeal is for men to look to him, to turn from their ways to his ways. It is misery to be tottering on the edge of destruction because of your own folly.

In verse 8, the Lord turns from the unbelief of men in the world to speak to his people. They will face tribulations on earth, and the world of men will oppose them (verses 11-12). They are to "fear not," no matter what comes over the horizon. God gives his people reasons for this command.

One is that they are chosen and beloved of God as Abraham was (verse 8). Abraham faced troubles in the world, but the Lord was with him. He was Abraham's "shield and very great reward" (Genesis 15:1). It is a comforting thought to have the Lord tell you he loves you as he did Abraham. God appears unspeakably glorious and lovely in issuing this assurance.

No matter what happens, he will "not cast you off" (verse 9), but rather he says, "I will be with you" (verse 10). The Lord Jesus told his disciples they would face tribulations in the world, but that he would never leave them nor forsake them. God obliges himself by telling his people to commit their way to him, and he will preserve them and load them with blessings (verse 10).

As God's people we are not to be dismayed with fear when troubles arise (verse 10). The word dismayed has the meaning of gazing in one direction and then another, not knowing where to look for safety. But the believer in Christ is not alone; he is to fix his eyes upon Christ.

The Lord makes promises to the believer in troubles: "I will strengthen you. I will help you. I will uphold you with my righteous right hand" (verse 10). The Lord repeats in verse 13, "For I, the Lord your God, hold your right hand; it is I who say to you, 'Fear not, I am the one who helps you.'

The Christian, in the face of fears, is to let God be his all in all. When subdued by and melted by the pardon of our souls, we can render to God both body and soul and be faithful even unto death.




