





# **County approves initial funding** for Ponte Vedra Beach restoration

For months, supporters of the Save Ponte Vedra Beach initiative have been petitioning St. Johns County for financial assistance toward their mission of local beach restoration. Last Tuesday, July 17 at a meeting of the Board of County Commissioners, their wish was officially granted.

With a 3-2 majority vote, the commissioners approved up to \$200,000 in immediate funding for the project, which will allow the county's preferred engineering firm — Taylor Engineering — to begin the necessary preliminary work.

"We are thrilled that the county will be hiring a coastal engineer to restore the beach and that they are putting in some initial funding for it," said Lori Moffett, spokesperson for Save Ponte Vedra Beach Inc. "It took a massive effort on the part of hundreds of people in St. Johns County that love Mickler's Beach and all points north and south. The county's largest public beach in terms of public access and parking spots is in desperate need of investment, and the people of St. Johns County have strongly voiced their support for it."

The motion was backed by Commis-

sion Chair Henry Dean, who expressed confidence that the funding, which will be drawn from the Beach Renourishment Reserves, would eventually be repaid.

"It appears to me there is an overwhelming majority of homeowners in this specific Ponte Vedra Beach area that will

vote in favor of an MSTU," Dean said. "So, I am fully confident in my own mind that this \$200,000 will be repaid from the first year's funds of that MSTU."

Although Commissioners Jeb Smith and Jimmy Johns were skeptical regarding costs and feasibility, Commissioners Paul Waldron and Jay Morris also voted to approve the initial funding for the project, which the county estimates will ultimately cost about \$634,000.

"Ponte Vedra is as important to St. Johns County as South Ponte Vedra and Vilano Beach," Morris noted, adding, "Of everybody I've talked to in Ponte Vedra, I haven't had one person indicate they were not for some type of MSTU, so that money, in my opinion, will get paid back."

While residents in North Ponte Vedra Beach are still awaiting the county's decision regarding the creation of a special assessment to pay for local beach renourishment, the commissioners signed off on a municipal service taxing unit for a one-time dune restoration project in South Ponte Vedra Beach and Vilano Beach last December. Another agenda item of last week's meeting, the board voted not only to continue that assessment, but to combine the overall project with a federal beach restoration project - which will be conducted in that area by the U.S. Army Corps of Engineers - and reduce the tentative millage rate from 8.25 to 4 mills.

"Combining the two projects, constructability-wise and financially, makes

# Florida DEP reaches agreement with Ponte Vedra Beach landowners over beach scraping violations

The Florida Department of Environmental Protection (DEP) recently reached an agreement with four Ponte Vedra Boulevard residents, including the CEOs of United Airlines and Web.com, to resolve allegations against them for illegally excavating beach sand on their properties.

Following an investigation, DEP official Dee Ann Miller said the department determined the residents violated DEP guidelines regarding sand scraping activity. Miller noted in an email to the Recorder that the department addressed the allegations by negotiating short-form consent orders with the residents. A consent order, Miller said, is a legally enforceable agreement for violations that warrant a formal enforcement action.

According to documents obtained by the Recorder, Catherine Munoz - the wife of United Airlines CEO Oscar Munoz - offered to resolve the situation by offering a \$24,000 voluntary contribution to the Water Quality Assurance Trust Fund, and to reimburse the department's costs. The document

also stated that her offer was not an admission of any liability for the property owner's alleged violations.

"The department takes instances of non-compliance seriously and we will hold offenders accountable if violations are found," Miller said. "DEP has a number of enforcement tools we are able to use to address violations. While fines and penalties are one enforcement tool, enforcement can also be requiring necessary restoration and/ or remediation actions through a compliance assistance offer, consent order or other enforcement mechanism. The nature of the violation and circumstances surrounding the event are used in the determination of which one is best suited."

In addition to Oscar and Catherine Munoz, Web.com CEO David Brown and Margaret Conolly will each pay \$24,000 to resolve the situation. The other property owner, Christopher Aitken, will pay \$33,000. According to the DEP documents, each resident stated that their monetary offer did not constitute an admission by the property owner of liability for the DEP violations.

# Dick Williams pledges not to use 'dark money' political committees in commission race

"I hope my fellow candidates will follow my lead, and we together can tell all St. Johns County voters that we share their values and will not follow the example set by career politicians, special interest lobbyists and lawyers that have corrupted our political system," Williams added.

A Republican candidate for the St Johns County Commission District 4, Williams is committed to promoting policies that maintain quality of life, protect tax dollars and grow the economy. "I am honored to receive the SIA Legislator of the Year Award," Rutherford said. "It is important that we work together to equip our schools with the latest technology and train our students, teachers and administrators on how to identify signs of violence, so that we prevent violent acts before they happen. I am thankful for the hard work of groups like SIA and

# Ponte Vedra family returns from vacation to burglarized home

A burglarized home is the last thing anyone wishes or expects to return to after a relaxing vacation, but for one Ponte Vedra family, that was the case Saturday, July 14.

According to the St. Johns County Sheriff's Office, Irina Pacilio and her family left for vacation Wednesday, July 11, only to return three days later to find their home, located in the Florentine community off U.S. 1, ransacked and their black, 2005 Chevrolet Silverado missing from the driveway.

In addition to the truck, other items reported stolen included three laptops, two Microsoft Xbox consoles, Beats by Dre headphones, five iPhones, two iPads, a cell phone charger, one set of speakers, a Gucci suit case, Gucci sandals, four flat screen TVs, a Monster gaming headset, five pairs of True Religion jeans, two designer purses and assorted jewelry. A spare set of keys to the stolen truck was also reported missing.

According to the incident reports, the burglars appeared to have broken in through a window, leaving behind a few fingerprints and a blood sample, which deputies collected from the scene.

# Bicyclist dies after collision on A1A

A bicyclist died on Saturday, July 21 after she was struck by a vehicle on A1A near Guana River Road, according to Florida Highway Patrol.

Jacksonville resident Jennifer C. Bryant, 41, was traveling north in the bicycle lane at approximately 8:30 a.m. when she made a left turn into the path of a Toyota RAV4 also traveling north. Linda Yerrill, the 75-year-old driver of the vehicle and a St. Augustine resident, could not avoid the collision.

The front of the Toyota struck Bryant, who was separated from the bicycle before coming to a rest in the southbound shoulder. According to Florida Highway Patrol, she was wearing a helmet. # SJC supervisor of elections addresses safety, security of voting process at Rotary meeting

#### **By Jon Blauvelt**

Amid national concerns over the safety and security of elections in the United States, St. Johns County Supervisor of Elections Vicky Oakes said her office is taking every possible measure to protect the local voting process.

"I have 100 percent confidence in our voting system," Oakes told the Rotary Club of Ponte Vedra Beach Thursday, July 19 at Marsh Landing Country Club. "The highest priority for me as an election administrator is the safety and security of our elections."

Oakes first explained that the county's voting system is not on the internet and is instead hosted on a closed server in her office that programs and tabulates the election. Separately, she said her office uses a communications server for precincts when they close on election night to send the results via a private network. The election administrator also noted that significant testing takes place at her office to ensure voting equipment counts accurately before it is used in an election.

Among other safety and security measures, Oakes said an audit is completed

following elections to ensure every vote has been counted and accounted for. Also after elections, she said her office draws random races and counts the votes to verify that total against the tabulated total.

In addition, Oakes noted the supervisor of elections office keeps ballots for two years following elections should any issues arise. The election administrator also said Florida's paper ballot process is one of the safest systems in the country.

Moving forward, Oakes said her office recently received funds from the state to continue to harden its systems, including upgrading systems and adding a layer of security. She noted that her office now has a 24/7 monitoring system that tracks all traffic.

"Is our system perfect?" Oakes asked. "No. But I'll tell you, over 30 years, it's better than it's ever been."


The St. Johns County supervisor of elections additionally discussed changing trends in elections. She said in the 2016 general election, 72 percent of voters in St. Johns County cast their ballots prior to the election. More specifically, Oakes noted that 52 percent voted early, and 20 percent voted by mail. In addition, she mentioned that voters can now register to vote online, which is a new feature in Florida as of October 2017.

Oakes reminded the Rotarians that the primary election is taking place Aug. 28. The last day to register to vote or make a party change is July 30, and early voting starts Aug. 18.

In a separate communication to media, Oakes also said it's not too late to request a mail ballot for the primary. To do so, residents can visit the elections office website at www.votesjc.com and use the online form to request the ballot. Or residents can call the elections office at (904) 823-2238. The deadline for requesting the ballot for the primary is Aug. 22 at 5 p.m.

Lifelong Republican Erika Alba reminds voters you can still register to vote thru July 30th 2018. Absentee voting begins next week. Early voting begins August 18th and Primary Election day is August 28th.

# A feast of flowers

While visiting Rome with my family this summer, we participated in the Corpus Domini and Flower Festival in Umbria.

This year, the festival was held June 3. During the day and night before the event, almost a thousand people, including my children Maria Vittoria and John Carlo, worked strenuously to create carpets and pictures made of flowers along the narrow town's streets. The floral creations cover streets throughout the historical center in preparation of the passage of the blessed sacrament carried in procession by the bishop on the following Sunday morning. The momentous occasion takes place in Spello, a small village in Umbria where the Infiorata event began in the 1930s. It takes place every year on the day of the Corpus

Domini feast on the ninth Sunday after Easter.

It seems the first flower carpets were made June 29, 1625 in the Vatican Basilica by Benedetto Drei, head florist at the Vatican, and his son Peter, who used flower petals like mosaics to decorate the basilica on the day of Saints Peter and Paul's feast. Today, the Infiorata artists use flowers with various nuances of color and their petals to create both simple and elaborate designs on the streets leading up to their churches and abbeys.

After months of work on the actual design of the painting, they first sketch them on the floor in chalk and mark each line with soil or coffee grounds. Then comes the job of filling in the marvelous creations with flower petals, using individual petals the way painters use the colors on their palette.

It truly is a wonderful experience.



# Review: 'The Geraldo Show' is a must read for all ages

As an 18-year-old, I have missed out on most of Geraldo Rivera's fascinating career. I grew up during the Iraq War and the fighting in Afghanistan, and, at the time, I was too young to understand most of what was going on with these conflicts.

Geraldo Rivera's "The Geraldo Show: A Memoir," however, provided me with a deep and gripping understanding of what I missed and why it happened. The first

"rock & roll" newscaster does a remarkable job at conveying his personal experiences while chasing conflict and exposing horrors.

The memoir covers Rivera's rise to fame, his relationship with his family, his reporting on Willowbrook State School, the War on Terror, his friendships with Roger Ailes and Donald Trump and more.

Rivera's Willowbrook story — also known as "The Last Great Disgrace" catapulted him to celebrity

status overnight and led to the shutdown of the institutions across the country that housed the no-longer forgotten disabled. Rivera's Willowbrook reporting is a testament to his bravery and ambition and just a preview of his daredevil personality that is later displayed in warzones across the globe.

It is clear throughout the book that there are a few people who Rivera holds great admiration of: his wife Erica, his children and Roger Ailes. Ailes changed Rivera's life and career when he allowed him to become a war correspondent for Fox News when NBC wouldn't. After losing 135 friends to the 9/11 attacks, Rivera took a massive pay cut and left his successful "Rivera Live" show to embed with troops in the Middle East, with the hope of capturing the moment of the defeat of

The first the Stars," in which awkw

Osama bin Laden.

It would be 10 years before Bin Laden was killed, but Rivera would have the privilege of announcing the death of America's most wanted man. Without Ailes, Rivera would've never been able to travel to Iraq and Afghanistan 22 times, report on the war and provide the troops with entertainment and a voice.

"The Geraldo Show" also covers Rivera's appearance on "Dancing with the Stars," in which he shares some

> awkward moments with his dancing partner, Edyta Sliwinska, that include a joke about his ability to dance that left his partner's face blank. The book additionally covers his appearance on "The Celebrity Apprentice," in which he faced off with his unlikely rival, ex-boy band member Kevin Jonas. Although Jonas and several others conspired against Rivera, the newsman ultimately

prevailed over his arch nemesis and placed second in the season.

Overall, not many people have sailed up the Amazon River, become close friends with a president, risked their lives in warzones or triumphed over relentless attacks from the media, but Rivera has. I highly recommend "The Geraldo Show" to people of all ages, but especially to younger readers who like me lived through many of the events in the book, but were too young to remember or fully understand them. Rivera's first-hand account reveals a collection of stories that compose the truly incredible life of the first "rock & roll" newsman, making "The Geraldo Show" a must-read.

Cross the bridge over the lagoons in Old Ponte Vedra Beach, and you will enter the popular island community of Lake Road and Lake Terrace.



# Tips on preparing your pool for hurricane season

This is a two-part article on how to prepare your pool for hurricane season. The second part will appear in the next edition of Sand Castles in October.

Many of you are likely busy preparing for your summer vacation, or perhaps you are back from vacation and are consumed with getting your kids ready for school. Before you know it, we will hear weather reports of a storm that is forming in the Atlantic and heading this way. After all, we are already close to two months into the 2018 hurricane season if you can believe it!

The last thing any homeowner wants to think about right now is a potential hurricane, especially after families in Northeast Florida have had a rough past couple of seasons and some are still dealing with damage caused by Irma. Nevertheless, it is better to make your plan and ask the questions now, while things are calm, before the storm is a couple days away from landfall.

For better or worse, many pool owners have become proficient in hurricane preparedness thanks to Irma and Matthew. But for those who need a little advice, we thought it would be beneficial to review a few tips regarding how to prepare your pool for a hurricane. We'll go into a few of these tips in this issue and then review the others in the following edition.

The challenge is each pool, deck space and yard are different. You may have commercial size deck drain or great natural change in elevation that assists with natural drainage, or you may have minimal deck drainage or drains that are clogged with dirt and don't allow for much drainage at all. Each situation is unique and must be viewed as such.

The first question pool builders are asked is, "Should I drain my pool or lower the water level at all?" The Florida Swimming Pool Association (FSPA) does not mince words when it comes to emptying your pool. They strongly advise for homeowners to not empty their pool.

The reason being, if water is removed from the pool, and the heavy rains from the storm raise the water table in your area, you may walk outside after the storm to find your pool floating in your yard. Because you removed the weight of the water, which was holding the pool shell down, the pressure from the water table under the pool becomes forceful enough to push the structure out of the ground causing all sorts of other problems.

The follow up question we get is, "Should I drain the water level inside the pool at all?" The answer varies greatly depending on your particular situation. If your surrounding deck has sufficient drainage and the water from your deck and house gutters properly drains into the yard, lowering the level in the pool may not be needed. If, however, you are concerned with the pool overflowing and the drainage not keeping up, you can lower the level of water in your pool, but you are opening yourself up to other risks.

The FSPA recommends to not lower the pool more than one foot for a typical pool with standard depths as you do not want to drain the pool too much in the chance the pool floats with ground saturation. The other issue with draining the pool below your waterline tile is you need to make



sure to shut off the valve and close off your skimmer. If water does not flow into your skimmer while the pump is running, your pump will run dry and burn up causing potentially serious issues. Other pool owners choose to drain their pool to the bottom of their waterline tile but leave it high enough so that water is still getting inside their skimmer to prevent any potential issues with the pump.

In the next edition of Sand Castles, we'll discuss what to do if you do decide to drain your pool, other preventative measures that should be taken and what should be done after the hurricane passes.


# **STORM READINESS**

While August marks the halfway point of the hurricane season, FEMA is reminding Floridians that the most active months of the season remain, and so does the need for flood insurance.

According to FEMA, a policy does not take effect until 30 days after the date of purchase. But once a named storm approaches, it's too late to buy a flood policy; insurance companies suspend binding coverage until after the storm passes. Buying and maintaining flood insurance now, the agency said, will help protect Floridians financially from storm damage that could occur later.

FEMA is reminding Floridians that standard homeowners insurance policies do not cover flood damage. Flood damage, according to the agency, is most often called an excluded peril, meaning it's not covered. A flood insurance policy protects policyholders financially even when a presidential disaster is not declared or if they live in a county that was not designated for federal assistance.

Per the agency, the National Flood Insurance Program (NFIP) has more policies in Florida than any other state. Only about half of Florida homeowners



in high-risk areas, however, had insurance against flooding before Hurricane Irma made landfall Sept. 10, 2017. In addition, FEMA noted that floods can happen almost anywhere, reporting that almost 30 percent of flood insurance claims come from low-to-moderate risk areas and receive one-third of all federal disaster assistance for flooding.

By July 12, 2018, FEMA said 33,111 NFIP claims for Irma damage had been filed. More than \$1.1 billion had been paid to policyholders, with an average closed claim payment of \$49,740.

Floridians are eligible to purchase an NFIP policy as long as their community participates in NFIP. According to FEMA, the national average annual policy for home and business owners is about \$700 for up to \$250,000 in coverage. Properties



in moderate-to-low risk areas may qualify

for lower-cost Preferred Risk Policy rates.

In addition to coverage for structures, NFIP offers contents coverage as low as \$48 per year in some areas for home and business owners and renters. Policies may help with up to \$100,000 in losses for residences and up to \$500,000 for businesses.

# Be financially prepared for natural disasters

As far as your physical safety is concerned, you're probably already aware of the steps you need to take to shield yourself and your family. And now that many alerts can be sent directly to your smartphone, you've got an even better chance to prepare for an approaching threat. But when it comes to safeguarding your financial situation, you'll need to be ready well in advance — and the following moves can help:

■ Strengthen your home. Your home is probably your biggest asset, so you'll want to do everything you can to keep it safe. In the face of a truly calamitous event, such as hundred-mile-per-hour winds or the advance of uncontrollable fire, there may not be much you can do, but in less dire circumstances, your actions can help. Your insurance professional can offer tips on protecting your residence.

■ Maintain sufficient insurance. It's a good idea to review your existing homeowners or renters insurance periodically to make sure you are sufficiently covered for all possible hazards. Keep in mind that homeowners insurance does not typically cover flooding, so you may need to purchase flood insurance from the National Flood Insurance Program. (Depending on where you live, this coverage may be required when you get your mortgage.) Also, in conjunction with maintaining your insurance, you should document your possessions, so you may want to make a video inventory as well as a written list containing descriptions and values.

■ Create an emergency fund. A natural disaster can lead to a wide array of unanticipated costs: appliance repair or replacement, hotel and restaurant bills, insurance deductibles — the list could go on and on. Consequently, you'll help protect yourself and your family by building an emergency fund. Some of this money should go into a liquid, low-risk account, but you may also want to keep a small amount of cash at home in a safe place, as ATMs and credit cards may not work during or following a disaster, when you must purchase needed supplies.

■ Protect your documents. As you go through life, you'll accumulate a lot of documents — mortgage papers, insurance policies, financial accounts, tax statements and so on. If disaster strikes, you may need these documents. You'll want to store paper copies in a fireproof and waterproof box or safe at home, in a bank safety deposit box or with a relative or close friend. Of course, we're now living in a digital age, so you can store electronic copies of important documents in a password-protected format on a removable flash or external hard drive. Better yet, you might want to use a secure cloudbased service.

With luck, you can avoid being victimized by a natural disaster. But, as the old saying goes: "Hope for the best and prepare for the worst." From a financial perspective, that's good advice.

### GTM Research Reserve and community volunteers plant sea oats to restore dunes at beach

More than 2,000 sea oats were recently planted along the beach of the Department of Environmental Protection's Guana Tolomato Matanzas (GTM) Research Reserve to protect the shoreline during hurricanes and tropical storms.

GTM and Northeast Florida Aquatic Preserves staff, their families and community volunteers joined together for the project.

"Sea oats helps protect the shoreline," said Dr. Michael Shirley, director of the GTM Research Reserve. "The massive root system of the sea oats is able to hold soil and sand in place during extreme weather events such as hurricanes and tropical storms."

According to the GTM Research Reserve, sea oats are valuable as a dune builder and stabilizer

in the Southeastern United States, Eastern Mexico and some Caribbean islands. Their tall leaves trap wind-blown sand and promote sand dune growth, while their deep roots act to stabilize them, helping protect beaches and property from damaging high winds, storm surges and tides.

"We work hard to help make our coastline more resilient, especially so that we are prepared for hurricane season," said Scott Eastman, manager for the Northeast Florida Aquatic Preserves. "Planting sea oats on our beach helps develop natural resiliency to act as a first line of defense against storm surge and other effects from sea level rise."

The reserve plans to continue monitoring this restoration project to gauge success and to guide future DEP dune restoration efforts.

### Florida's First Coast Relief Fund prepared for hurricane season

Partners of Florida's First Coast Relief Fund are prepared to once again activate the Relief Fund if disaster strikes.

Created in 2016 to aid with Hurricane Matthew relief and to establish a permanent disaster relief fund, Florida's First Coast Relief Fund is a strategic collaboration founded by United Way of Northeast Florida, United Way of St. Johns County, The Community Foundation for Northeast Florida, the Jewish Federation of Jacksonville and the Jessie Ball duPont Fund.

Last year, in the wake of Hurricane Irma, Florida's First Coast Relief Fund granted more than \$3.56 million to 33 Northeast Florida nonprofits providing disaster-relief services. Through this, more than 253,231 individuals and households were served.

"The generosity of our community in that time of crisis — neighbors helping neighbors — was incredible," said Michelle Braun, president and CEO of United Way of Northeast Florida, the fiscal agent and grant manager for the Relief Fund. "We are so thankful for the individuals, corporations and partners who came together to heal Northeast Florida."

The Relief Fund supports immediate and intermediate unmet needs. One hundred percent of all donations go to relief efforts. Nearly \$3.8 million was raised for Hurricane Irma relief. The Relief Fund's remaining \$200,000 will be available for immediate response for future disasters.

The fund distributes grants only to organizations helping individuals and households impacted by natural disasters in Baker, Clay, Duval, Nassau, Putnam and St. Johns counties. The Relief Fund provides resources to meet needs not met by insurance, FEMA or other state and federal programs or to fill the gap while other long-term assistance is being put in place.

After Hurricane Irma, the top three relief needs fell into the following categories: rent and mortgage assistance; home/nonprofit stabilization and repair; and food. All distributions from the Relief Fund are overseen by a committee comprised of representatives of the Relief Fund partners, the City of Jacksonville, Mayo Clinic and the Jaguars Foundation.

## All aboard the Jim Clark Express

Local business leader, Rotarian mobilizes community to honor retired Daniel Kids CEO

Every community has its heroes, but often times those heroes go unsung. Thanks to the efforts of one Ponte Vedra Beach business leader, however, local hero Jim Clark will be remembered for years to come.

A member of the Rotary Club of Ponte Vedra Beach, Clark recently retired from his role as CEO of Daniel Kids after 27 years of dedication to improving the lives of local children and families. When fellow Rotarian and Brightway Insurance Ponte Vedra Beach owner Billy Wagner learned of Clark's retirement, he knew he had to do something to memorialize that legacy.

"I became passionate about this, because I've been a 'big brother' in the Big Brothers Big Sisters program for about 10 years," Wagner explained. "My 'little (brother)' went through a really traumatic experience last year, and I called Jim Clark, who was leading Daniel, and the work, the counseling that they did with him ... was so moving for me that I said, 'I'm going to do something to give back to Daniel.""

With the opening of a Therapeutic Group Home this year for kids ages 12 to 17, Clark advised Wagner that Daniel Kids was in need of a van for transportation to and from medical appointments, school and other engagements. Upon hearing the news, Wagner - who was president of the

Rotary Club at that time - sprang into action and mobilized the troops.

"We do a big fundraiser every year," Wagner said. "As president of the Rotary Club, I got to select who the main beneficiary was, so I selected Daniel, which gave them \$15,000 to support this van."

Although the \$15,000 covered a significant portion of the cost of the van, additional funds were still needed to purchase it. Determined to achieve his goal, Wagner set about finding other ways to raise money for his cause.

"We did a push-up contest at Rotary," he said. "I donated \$10 for every push-up, and then we bet on who could do the most push-ups, which was a lot of fun. I donated \$7,000 for that cause, some of the other members donated another \$800 in bets and then people gave their winnings too, so the

Rotary Club really participated in it a lot." Even with the additional donations from

Rotarians, however, the van was still just out of reach, so Wagner personally reached out to some of his professional contacts and was eventually able to raise a grand total of \$25,386.30.

With the check to secure the van signed and delivered this past week, Wagner advised that the vehicle will serve as a memorial to Clark's many years of devoted service.

"He was there for 27 years with Daniel, and he really impacted the community," Wagner said. "He's just a great leader and a hero for kids, so the van will be called the 'Jim Clark Express."

The community features a Caribbean, Key West and West Indies style metal-roof homes, Bermuda grass and every type of palm tree that will grow well in North Florida.

In addition to the lagoon, Beachwalk will feature water slides, a miniature golf course and a 2,500 squarefoot splash park for dogs. A planned clubhouse has been styled after one seen at a multi-billion-dollar Caribbean beach and golf resort. Residents will be able to swim, paddle kayaks or stroll along a boardwalk. Or they can enjoy a 3,000-square-foot swim-up bar at the edge of the lagoon. There will be golf cart paths throughout, allowing residents to access the beach club and other amenities without having to drive their cars.

"The whole community really is walkable," Kinsey said. "You really can walk to the beach."

Construction at Beachwalk includes

single-family homes and twin villas on the lagoon by homebuilders Americrest Luxury Homes, Lennar and Vintage Estate Homes.

### Cole Porter classic coming to the Alhambra

#### 'Kiss Me, Kate' opens Aug. 1

Cole Porter's 1948 musical "Kiss Me, Kate" will open at the Alhambra Theatre & Dining Aug. 1, offering a modern take on a Shakespearean classic.

Exes Fred Graham and Lilli Vanessi, both actors in a musical version of Shakespeare's "The Taming of the Shrew," can't decide if they're enraged, enamored or enormously confused whenever they cross paths out of character. Throw in some mistaken identity, a pair of surprisingly eloquent gangsters and a whole lot of romantic entanglements, and what you get is "Kiss Me, Kate" — a dazzling classic that earned the first-ever Tony Award for Best Musical.

"Kiss Me, Kate" was Cole Porter's response to Rodgers & Hammerstein's "Oklahoma!" and the first show he wrote in which the music and lyrics were firmly integrated into the script. The show proved to be his biggest hit and the only one of his shows to run for more than 1,000 performances on Broadway. In March 2015, it was announced that the 1949 original cast recording would be inducted into the Library of Congress' National Recording Registry for the album's "cultural, artistic and/or historical significance to American society and the nation's audio legacy." This coming February, the show will open its revival on Broadway.

For the duration of the show's run, Alhambra Executive Chef DeJuan Roy will be cooking up a culinary experience fitting of the longest-running dinner theater in America. For the first course, patrons will have their choice between chilled cucumber bisque with shrimp and dill or caprese salad with diced tomatoes, mini mozzarella balls, pesto and balsamic glaze. Josean Gonzalez has been named the new wrestling coach at Ponte Vedra High School (PVHS), and he has big plans for the Sharks in the upcoming seasons.

Gonzalez, a recent graduate from the University of North Florida, took a break from coaching wrestling last season to continue his education, but he's ready to return to the sport he loves.

"It feels great (to be back)," Gonzalez said. "It was the first season in about 12 years that I didn't have wrestling."

Among the things Gonzalez wants to do at PVHS is revamp the wrestling room, and he also aims to lead the Sharks to the state tournament this season.

"Placing top three in the district would be above and beyond expectations," Gonzalez said. "That would be the icing on the cake. If we can do that, then I know we're headed in the right direction."

Gonzalez, who began his coaching career at Orange Park Junior High in 2009

and was the head coach at St. Augustine High School from 2012-2017, also wants to focus on the culture surrounding the program and getting more attention on the wrestling program.

"Wrestling often falls to the wayside to other sports," Gonzalez said. "Having that culture of accountability is definitely something I want to instill at Ponte Vedra."

Gonzalez has volunteered with the St. Johns PAL Youth Wrestling and Beat The Streets: Jacksonville. He has coached numerous FHSAA state champions, state placers and qualifiers, and one thing he really wants to do at Ponte Vedra is create a youth wrestling program. He said he has reached out to the PVHS Alumni Association to pitch the idea of creating a program that would train students from kindergarten through eighth grade.

"We really need to start them young," he said. "Having that extra experience, they'll be very competitive by the time they get to high school. It also teaches good technique, which translates to other sports like football."

### Fred Funk escorts Jacksonville resident Continued from 43 to doctor as part of Stryker campaign

PGA Tour Champions golfer and Ponte Vedra Beach resident Fred Funk recently spent a day with the winner of Stryker's "Get on the Bus" contest in Jacksonville promoting the importance of joint health.

Taking place Tuesday, July 17, Funk picked up Jacksonville resident and contest winner Carol Simpson in a Stryker-branded bus and escorted her on a few stops around town, including her doctor's office to address her joint pain. Simpson has suffered from joint pain for years but avoided visiting an orthopaedic surgeon to discuss her options.

"A lot of people go through a lot of pain and keep putting things off," Funk said. "She's (Simpson) ready. She's been through a lot of alternative stuff, and she's pretty much ready for her knee. She just wants to get a little more information and become more excited about it than scared about it."

Funk has become an ambassador for Stryker — a medical technology company - after he too struggled with joint pain during his playing career, which forced him

to have his knee replaced in 2009.

"You can get your life back," Funk said. "That's the big message. ... You don't need to suffer with what they have out there now."

The "Get on the Bus" contest encouraged Jacksonville residents with joint pain to take the first steps to a healthier lifestyle by sharing why they or their loved ones need extra encouragement to go to the

doctor and learn about joint health. Funk is partnering with Pro Football Hall of Famer Jerome Bettis on the initiative. Bettis hosted a similar contest in Pittsburgh, and both athletes will come together in August to spend a day with the contest winner in New Jersev.

"I think it's a great campaign," Funk said. "It's just trying to convince people to go see the doctor."
