

## Trump, Biden win big in St. Johns County

Despite residents becoming wary of coronavirus, more than 44,000 St. Johns County residents helped give Joe Biden and President Donald Trump resounding victories in Tuesday's Florida Primary.

Biden won his primary by garnering 12,019 of 18,919 votes from county Democrats. Trump earned 24,155 of 25,445 votes from Republicans. Trump's Florida victory clinched the Republican nomination for November's general election. Statewide, Biden beat Democrat challenger Bernie Sanders by 39.1 points, while Trump easily outdistanced his challengers with 93.8% of the votes.

#### **CLOSURES, CANCELLATIONS AND POSTPONEMENTS**

Due to the health and safety of the community, the following closures and cancellations have been made in St. Johns County and surrounding areas.

- In the interest of public safety and in an effort to minimize the impact of COVID-19, the following St. Johns County facilities and programs are closed to the public, or have been cancelled, from March 16 through March 29:
- All St. Johns County libraries and the library bookmobile.
- All recreational facilities, recreational programming, recreational events, and all permitted events, including organized youth and adult sports on St. Johns County property.
- The St. Johns County Ocean and Fishing Pier Gift Shop and all permitted events on associated county property, including the parking lot, volleyball courts and the pier pavilion.
- All events scheduled to occur at the St. Johns County Fairgrounds.
- All events scheduled to occur at the St. Johns County Agriculture Center.
- All events scheduled to occur at the St. Johns Golf Club.
- The St. Johns County Pet Center
- All St. Johns County recycling and community collection events.
- All St. Johns County Fire Rescue community programming.

The St. Johns Golf Club, St. Johns County's beaches, parks, open green spaces and trails remain open.

In addition, veterans' services, the Permit Center, health and human services, utilities services and all other county business services remain open to the public and are

- The Beaches Museum is closed until March 31
- The Cultural Center at Ponte Vedra Beach is closed until March 30.
- The Cummer Museum of Art & Gardens is closed until April 3.
- The Jacksonville Symphony has canceled concerts through April 1, with possible livestream performances to be aired for the public.

- Palms Presbyterian Church has canceled Sunday worship for March 22, but will host a livestream service at 11 a.m.
- The Ponte Vedra Concert Hall events that were to take place from March 19 through April 1 have been postponed.
- The Ponte Vedra Beach Rotary Club has canceled its upcoming events for the next eight weeks. In addition to regular weekly meetings, this will also include the Local Heroes event scheduled for April 2 and the Mineral City Celebration on May 9. The club still intends to honor this year's Local Heroes award recipients and will present their plaques privately.
- Publix has changed its store and pharmacy hours with all stores now closing at 8 p.m.
- The St. Augustine Lighthouse & Maritime Museum is closed until March 30.
- The Times-Union Center for the Performing Arts is closed to the public. Events from March 19-April 1 have been postponed.
- The Guana Tolomato Matanzas National Estuarine Research Reserve has canceled all events between now and April 30. As of now, the Guana dam, beaches and trails remain open and operate under normal business hours until further notice.
- Christ Episcopal Church is holding its services online only. YouTube live links can be found at christepicopalchurch.org for traditional service at 9 a.m.; contemporary worship at 11:15 a.m. and Spanish language service at 12:45 p.m.

## 'An incredible blessing to the community when something terrible is going on'

Azhar Mohammed, executive chef of TPC Sawgrass Clubhouse, along with 60 other chefs under his supervision worked for up to 18 hours a day for nine straight days to prepare for this year's PLAYERS Championship.

Then, when the tournament was cancelled after the first day of play, the question arose as to what to do with all the food. The situation, triggered by a coronavirus sweeping the country and precautions being made to keep the public safe, was unprecedented.

Almost immediately, the PGA TOUR had the answer. Representatives reached out to Feeding Northeast Florida, a community food bank that rescues high-quality food that would normally be wasted and transforms it into meals for those in need.

On Friday, when the championship would have normally been in full swing, Mohammed and many of his chefs and other members of the TPC Sawgrass staff waited with carts and boxes and trays of food as a Feeding Northeast Florida tractor trailer backed up to the clubhouse loading bay.

They were joined by five-time PGA TOUR winner Billy Horschel, his wife Brittany and their two daughters, Skylar, 5, and Colbie, 2, who came to help load the food.

"This is an incredible blessing to the community when something terrible is going on," Susan King, Feeding Northeast Florida executive director said.

"It's an unfortunate situation that THE PLAYERS is cancelled," said Horschel, who would have been one of the golfers out on the course. "But all this food will go a long way. It will help a lot of people in this community."

"We're helping people, that's what matters," Andy Carroll, tournament chairman of this year's PLAYERS said, as he helped load food wearing his signature Red Coat jacket. "It's obviously a difficult situation, but out of a difficult situation good will come."

Billy and Brittany Horschel are Ponte Vedra Beach residents and have been involved with Feeding Northeast Florida since 2014. As an ambassador to the charity, Billy Horschel's Feeding Northeast Florida donation amounts total more than \$250,000 to date.

Two tons of food, worth \$60,000, was donated to

## Food from THE PLAYERS delivered to Sulzbacher Center in Jacksonville

On Saturday, March 14, THE PLAYERS executives, staff and past volunteer chairman, known as the Red Coats, along with PGA TOUR Commissioner Jay Monahan and TPC Sawgrass chefs, led by Executive Chef Azhar Mohammad, distributed boxed lunches of donated food to serve Sulzbacher Center clients and residents.

The donated food was part of the nearly 22 tons of food, valued at nearly \$700,000, that came from the TPC Sawgrass Club-

house, THE PLAYERS caterers — Par Caterers and Proof of the Pudding — and THE PLAYERS vendors, which was given to Feeding Northeast Florida to distribute to its network of over 160 social service agencies and programs.

The Sulzbacher Center empowers homeless and at-risk women, children and men through health, housing and income services, with the goal of restoring hope and self-sufficiency. Brad Talbert is president and CEO of Memorial Hospital. A fellow in the American College of Healthcare Executives, he resides in Nocatee.

#### Tell us about your background.

I received a B.A. in finance from Wofford College, a liberal arts college in Spartanburg, South Carolina. And I have a masters from the Medical University of South Carolina in Charleston.

#### What led you to pursue your career?

When I was in college, I worked part time as a pharmacy technician at a local hospital. Through that experience I gained a deep appreciation for the hospital environment and the healthcare industry. I knew I did not want to be a physician. I took more of a liking to the business and policy-making side of healthcare.

#### Where did you begin your career?

I began in assistant administrator roles and worked my way up through the industry in multiple roles. This is the fourth hospital where I've been CEO. When I took my first CEO job, at a specialty hospital in Memphis, Tennessee, I was 26 years old.

#### What are career opportunities for hospital administrators?

There are so many avenues of healthcare. I chose to pursue the hospital environment. There are also opportunities in the post-acute healthcare arena—skilled nursing facilities, rehab facilities, home healthcare or working for insurance companies. I chose hospitals because I like to connect with people and realized that would be a good way to do that.

#### What is a typical day for you?

The beauty of this role is there is no typical day. Every day presents unique and new opportunities and no two days are the same.

#### Who do you interact with?

Most definitely patients. We serve on average 465 people per day in some capacity. That is the best part of my job. I interact with physicians and community leaders, clinicians. But interacting with patients is one of the best parts of my job, hands down.

#### When did you begin at Memorial?

August 2017. I came here from Piedmont Medical Center in Rock Hill, South Carolina.

#### Have you made changes since you came to Memorial?

There has been a plethora of changes, significant improvements in our quality and our overall patient experience. We have grown, investing \$150 million-plus in capital investments. We've added new services, we've added new rooms. A new bedtower with 36 beds opened early last year, as well as expansion of our emergency room. We are currently expanding operating rooms. We've acquired land for future growth near Nocatee and more news about that will come out later in the year. We also became a Level-2 trauma center under my watch in August 2018.

#### When did you and your family move to Nocatee?

When we moved to town in 2017.

#### Tell us about your family.

My wife, Jennifer, works at Palm Valley Academy as an occupational therapist. She works with kids with special needs. My two boys also go to Palm Valley Academy. Anderson is in sixth grade and McClure is in fourth grade.

#### Any hobbies?

I love the outdoors and college sports, especially college football. I'm an avid Clemson Tiger fan. I love golf too, playing and watching.

#### Tell us about your involvement with the community.

First and foremost, my philosophy is to give back. I serve on a number of boards and committees throughout

the community, including the Jacksonville Chamber Board Executive Committee, the United Way Northeast Florida Resource Development Council, the UNF College of Health Deans Council and the Jacksonville Civil Council. I am also chairman this year of JAXUSA Partnership, the six-county economic development organization for Northeast Florida.

#### Where did you grow up?

In South Carolina. But we love Northeast Florida and being part of this community. What I like best about this area is the people. Jacksonville is a large city, but we all know each other. It's a very welcoming community. It's a very diverse and collaborative community. And I love being part of that.

Feeding Northeast Florida following THE PLAYERS cancellation.

Feeding Northeast Florida works with a network of 160 social service agencies and programs in an eight-county area, including City Rescue Mission, The Sulzbacher Center and The Salvation Army.

"We had a 46,000-square foot warehouse donated to us last year," King

said, "so receiving this food is divine intervention. We can handle this. We are in a unique position because we have the trucks, drivers, routes and storage capacity and we can do it safely."

"I'm not going to cry, but what you've done is so emotional," King said. "I know you guys have been working insane hours, and I feel blessed we can share this. This food—it's life-changing for people."







## Nease JROTC wins top honors at Area-12 Championship


"This group is the hardest working team we've ever put together," said Capt. Scott LaRochelle, senior naval science instructor. "The senior leadership is extraordinary."

Cadet Emellee Neff earned an individual medal for the top female in sit-ups, with 317. Cadets Isabella Rivera, Kaitlyn Boggs, Reef Hamilton and Brogan Donnelly also earned medals for top five in female or male sit-ups. Cadets Yuan Tian, Abigail and Amber Vidler earned medals for top five in pushups. Cadet Ben Prohofsky placed top 10 in academics.

"Winning Area-12 was a milestone for us," said Cadet Ethan Wissel. "Our goal is the Navy National Academic, Athletic and Drill Championships. "We don't simply want to go this year; we intend to do damage."

Nease will travel to the Navy National Academic, Athletic and Drill Championships in Pensacola on April 3.

Lucy Price — the wife of PGA Tour golfer Aron Price — said she and her sister




"I can't think of anyone more passionate about helping others or more deserving of being honored by the community than Tabitha," Lucy Price said.



#### Doga: Namaste with your canine

Adho Mukha Shvanasana, or downward facing dog pose, isn't just for people. It's actually for dogs, too. At least, according to certified yoga instructor Suzi Teitelman it is. Not only is it fun for owners and their pups, but it's called "Doga" and it's a great way to enhance your workout.

Teitelman started Doga Dog 20 years ago in New York City, just after 9/11. She was the director of yoga at Crunch Fitness and started taking her dog to class for mutual comfort. Many of her clients enjoyed her dog's presence and she found that her pup was loving it as well. Soon after, she started Ruff Yoga, a yoga class that allowed clients to bring their pets with them. People loved the opportunity to exercise with their animals while growing closer to them. Today, she not only teaches Doga through a partner-ship with Rover.com, but trains instructors from all over the world in the art of dog-partnered yoga.

Doga, much like yoga, relies on traditional methods of Hindu spiritual and ascetic disciplines—including breath control, simple meditation and the adoption of specific bodily postures aimed at stretching and relaxing the body and mind. In Doga, however, your dog participates too.

"I'm all about the people doing the pose cor-

rectly," Teitelman said. "You just start to add your dog and let them feel you get calm with a meditative breath. You sit on the floor and your dog will come over. As you move from one pose into the next, you add your dog into the pose."

Teitelman says dogs will put their paws on clients' shoulders or lay on their backs next to them, allowing clients to stretch their legs.

"You're just kind of melting together," she said.
"The more you do, the more you have a beautiful flow together."

It's not just the exercise and connecting owners with their pets, however. Teitelman said that the yoga experience is also enhanced by the dogs and their free-loving nature.

"People already people have a hard time turning their minds off," she said. "If you allow yourself to be with your animal you are just going to massage and touch. Eventually, you'll just forget where you are."

Recently, Teitelman has begun to realize not only the positive effects dogs have on their human yoga partners, but the therapeutic nature the practice provides dogs in need of human companionship and Post Traumatic Stress Disorder recovery.



his shoulder. I can't imagine what he has gone through, but he really is the sweetest dog."

Now vibrant and happy, Aloe is filled with life despite how his previous owners labeled him. Together, he helps Teitelman teach her class, showing the power of yoga for therapy, love and even forgiveness.

Dogs "live in this pure, happy world until we ruin it for them," Teitelman said. "We are trying to be like a dog. We are trying to be more like our dogs."



## Local businesses feel crunch of economical toll of pandemic

Some small businesses are trying to adapt to new climate of social distancing

#### By Amber Lake

Many businesses in the Ponte Vedra Beach area have taken a significant hit from coronavirus shutdowns. Social distancing, reduced operation hours and canceled events have come hard and fast.

Most afficted are those in the tourism industry, who felt the effects only hours after officials started using the word, "pandemic."

The Hilton Garden Inn in Ponte Vedra Beach saw an immediate influx of cancellations after THE PLAYERS announced an abrupt ending one day after the tournament started.

According to general manager Chuck Schoonmaker, immediately after official word was released, Hilton honored complete refunds for cancellations on bookings 30 days out. Prior to THE PLAYERS, the hotel's 127 rooms were occupied. Currently, the Hilton is operating on approximately 25-30 rooms, or at 20% occupancy.

For the guests they have, the Hilton has ramped up its cleanliness standards, wiping down all hard surfaces

immediately after use and/or every hour. Every surface in the hotel, including elevator buttons, room service carts, chairs, tables and counters are all disinfected hourly by staff, whether or not they have been used.

"I am going to miss making people happy," he said. "Because that is what it's all about."



V Pizza announced through their Facebook page that they are implementing even stricter cleaning guidelines for employees and are now offering to run take-out orders to customers' cars.

Trasca & Co Eatery offers curbside service as well. Additionally, it is offering free delivery from 11:30 a.m. to 1:30 p.m. with a \$25 purchase and free delivery on their "Grab and Go" meals from 2-4 p.m. Monday through Friday.According to co-owner Karina Coryell, the restaurant is also doing pop-ups in local neighborhoods, so residents don't even have to leave their block. Coryell urged anyone interested in having a Trasca pop-up to contact her with suggestions.

While local businesses are working to adapt to the new economic climate of a pandemic world, they are still seeing a reduction of customers, because many people aren't leaving their homes. What is most distressing is that nobody knows when the pandemic will end.

Area business in the meantime encourage area residents to shop locally.







## THE PLAYERS players react to cancellation

#### **By Kathy Bissell**

For the first time since 9/11, a PGA TOUR event has been canceled. THE PLAYERS Championship was halted at 9:50 p.m. Thursday, March 12.


In addition, for the first time since WWII, several additional PGA TOUR events, the Valspar in Tampa and the Dell Match Play tournament in Austin, Texas, were also canceled.

The PGA TOUR is not alone. The Masters has announced a postponement of this year's tournament, but they have indicated that they will hold it at some time later in the year. The others just will not take place in 2020.

The closing of the theme parks — Disney World and Universal — in Orlando was the tipping point for the PGA TOUR in making their decision.

"When you looked to that moment in time where you have two theme parks that are located between Jacksonville and Tampa cancel, to me that really was the final thing that we had heard that said, you know what, even though we feel like we have a safe environment and we've done all the right things, we can't proceed," PGA TOUR Commissioner Jay Monahan said early Friday morning.

Monahan, who lost a lot of sleep last week, had been on the phone with President Donald Trump, the CDC, Gov. Ron DeSantis, local government officials and others prior to the decision to play Thursday. At that time, it was felt that because the tournament was outside and because it was spread over 400 acres at the TPC Sawgrass facility, it was not a health hazard for the tournament to continue. However, as the days wore on, as other organizations cancelled their events, as more and more

admitted. "As you look into the rest of the season, tournaments in every market are well on their way towards planning their events, to fundraising. You've got charities, just like we have here, that are counting on those events. And we feel like it was our opportunity to potentially play this week."

Monahan also said the PGA TOUR would be working with the tournament Red Coats and Blue Coats to identify some things that could be done for local and regional charities that are affected by the cancellation.

"We take our commitment to this community very, very seriously, and we're going to get to the work at hand to make sure that we continue to help our community as everybody tries to make their way forward here," he said.

Several of the players had comments late Thursday and early Friday morning regarding the situation.

"You keep hearing that word that it's a fluid situation, that things are changing at a fast pace," former PLAYERS champ Webb Simpson said. "When I showed up here on Monday, it (cancellation) wasn't even a thought."

He and the group he was playing with on Thursday found out that no fans were going to be out on Friday when they were on the 4th hole in round one. Then that changed. Now he's headed back to Charlotte, North Carolina to try to stay sharp for whenever golf begins again.

Rory McIlroy didn't receive notice about the cancellation until Friday morning. He was asleep when the announcement was made.

"It's going to get worse before it gets better," McIlroy said about COVID-19.
""It's a hard one because you look at volunteers out here and a lot of volunteers are in their 60s and 70's and retired, and you don't want someone that's got the virus that passes it on to them, and then they're susceptible, and for me, like I,

players had concerns, it became a bigger issue to continue with THE PLAYERS. Then late in the day on Thursday, Disney World and Universal decided to close.


"I think it was expected," Jon Rahm said Friday morning. "I guess all we can do now is try to be as safe as possible and hope it goes through quickly, and you know, get to play as soon as possible or just get through the virus as early as possible."

Rahm has family members who have respiratory issues, and even before play started, he expressed a concern for their safety with regard to the virus.

Several of the players suggested they should be tested, but as Monahan pointed out, it might not be possible to do that.

"Right now, there aren't enough tests out there. And so, the responsible thing to do is to make certain that the tests are being used appropriately," he said. "So, we pulled back off of that. And if anybody in our ecosystem, our players, our employees, anybody is feeling like they're in any way compromised, we'd certainly recommend and help them do anything we can to help them get tested, but right now that's certainly not the case."

Perhaps the best statement by anyone regarding the cancellation of the tournament came from McIlroy, who said, "Today's overreaction could look like tomorrow's underreaction. So just got to take it day by day and see where this thing goes."


