## St. Johns County mandates use of face coverings in all county facilities

In an effort to minimize the spread of COVID-19, a face covering mandate for all St. Johns County-owned facilities went into effect on Monday, July 27. All employees and any person working, doing business or visiting a county facility are required to wear a face covering when social distancing of six feet or more cannot be maintained. For a full list of exemptions and enforcement policies, go to www.sjcfl.us. This emergency order will remain in effect through the duration of the St. Johns County Emergency Proclamation 2020-1, unless otherwise

# Forum in Ponte Vedra features GOP candidates

Voters had an opportunity to hear from several office-seekers Thursday, July 23, during a candidates' night at the Ponte Vedra Concert Hall.

The event had been originally scheduled as a debate between two St. Johns County sheriff candidates, but the focus was changed after it was learned one of the presumed debaters would not be participating. The event was sponsored by the Ponte Vedra and Nocatee Republican clubs.

Much of the forum was devoted to the sheriff race, though only St. Augustine Beach Police Chief Rob Hardwick attended. He will face former Sheriff's Office director Chris Strickland in the Aug. 18 primary.

Hardwick touted his experience as a law enforcement officer and as a 25-year member of the U.S. military, as well as his service on the Criminal Justice Standards and Training Commission. He also recounted how he saw the St. Augustine Beach Police Department through its accreditation process.

Asked how he would recruit and retain quality officers, Hardwick pointed to success he's had in hiring young men and women who grew up locally as well as experienced officers who have "retired" to the county from points north.

He said he holds his officers accountable by demonstrating leadership.

"You start at the top," he said. "You lead by example. I wear a uniform every day. I answer calls for service."

Hardwick scored one of the loudest rounds of applause after being asked what he would do if asked by the governor or a mayor to stand down

He pointed out that the sheriff is an elected official who can't be told to stand down.

"So, when you tell me to go into the houses in St. Johns County and take people's guns ... that's not going to happen," he said.

The closest thing to a debate came later at the event as county commission candidates James Johns and Christian Whitehurst answered questions.

Neither candidate favors imposing a countywide mask ordinance.

Johns agreed that wearing a mask was important and said he wears one when he cannot observe social distancing, but he stopped short of requiring face coverings.

"I don't know what your personal healthcare needs are or whether you are capable of wearing a mask or not," he said, "but you do."

"Your rights start where my rights stop," said Whitehurst. "I'd never mandate masks for the general public."

Asked about managing growth, Johns said he wanted to hear from his constituents find out what's important to them. He called the county's different areas unique and said he wants to maintain their "special

# Hardwick receives endorsement of Brevard County sheriff

Brevard County Sheriff Wayne Ivey has endorsed St. Johns County sheriff candidate Rob Hardwick, citing his support of the Second Amendment.

Ivey joined the St. Augustine Beach Police chief and several supporters Wednesday, July 22, at the Ancient City Shooting Range for the announcement.

"Right now, more than any time before, we need sheriffs that are going to stand strong — stand strong in support of their citizens, stand strong in support of their law enforcement officers and certainly that are going to stand strong in support of the Constitution," said Ivey.

Ivey pointed out that Hardwick has received an "A" rating from the National Rifle Association.

"He is a huge Second Amendment supporter," Ivey said. "He understands the importance. The Second Amendment protects all of the other amendments within the Constitution."

After the presentation, Ivey explained his decision to

back Hardwick.

"For me, I vet the candidates myself," he said. "I look at: What do they stand for, what have they done? His

military service certainly is important, but more importantly is what I believe in my heart he will do when the time comes."

Hardwick expressed gratitude for the endorsement.

"For him to drive all the way up here and then to turn around and drive back down to Brevard — he's got a big fundraiser tonight for his campaign — so, it was humbling when the sheriff said he wanted to come up here today," Hardwick said.

He added that Ivey himself is considered a Second Amendment sheriff in Florida.

"He's been such a big advocate for the NRA," Hardwick said. "And not just an advocate, but making sure the educational piece is out there."

Hardwick's opponent, Chris Strickland, has cited his own membership in the NRA on his campaign website.

Voters will choose between Hardwick and Strickland during the Aug. 18 primary election. Both candidates are running as Republicans. The winner will face a write-in candidate at the general election in November.

# More retailers requiring masks

St. Johns County does not have a mask requirement. It has many.

With several retailers now requiring masks, mandates in St. Augustine and St. Augustine Beach and a face-covering requirement in all county-owned buildings, there are few public places left where mouths and noses may be exposed.

Last week, a slew of national retail chains imposed their own mask policies, drawing praise from some local customers.

"I think it's a marvelous idea," said one woman who declined to give her name. "I'm compromised immune-wise, and I really didn't feel safe until the masks were required."

Standing outside the Publix Super Market at Sawgrass Village, customer Kim Voss said she was glad the stores had taken the initiative.

"I think it's important to wear a mask during this time," she said, adding that the county should mandate masks "at least for indoor use."

Outside the Pet Supermarket in Ponte Vedra, a woman who asked not to be named agreed with that but was not certain that such a mandate could be enforced.

"I just wish everybody would wear a mask," she said. "I don't think the government can do it, but we can do it."

Another customer putting his groceries into the trunk of his car outside Publix held a different view. He said that only a county mandate would ensure that people follow the rule.

"Everybody ought to wear a mask," he said.

The Board of County Commissioners has been resistant to imposing a mask requirement countywide, though it did vote Tuesday, July 21, to mandate face-coverings for all county-owned facilities.

Robert Peek grew up in Orange Park and spent 18 years gathering quotations from Socrates to Virgil to Anne Frank to Yoda with one single purpose: to provide a roadmap for his daughter's life. Now living in St. Augustine, as she approached graduation from Ponte Vedra High, he put those blogs into a book called, "Inside Peek: A loving father shares his wisdom" that he presented to his daughter, Alexandra, two months ago.

# Robert Peek

As told to Don Coble

#### Why did you decide to write this book?

I did not start out with an intent to write a book. This really goes back to when my daughter was born. When my daughter was born and I held her for the first time, I had this overwhelming desire to impart to her whatever wisdom I had learned in the world. I wanted to instantly transfer this knowledge to her. I realized I wanted to protect her. But I knew while I could guide her, she would have to find her own way in the world. I decided to start an online blog of life's lessons that I hoped she would read. That is the genesis of this. Over the years, people started finding my blog. Some of them were my friends. Some were my work friends. It was actually picked up by a couple of newspapers. They would run it as a column – one in Chicago. I was getting visitors to my blog from all over the United States, in fact from all over the world. People were leaving very positive comments. All along, my audience was one person, and that was my daughter. When she was early in high school, I decided then I would bundle the best of the blog posts into a book and present it to her at her high school graduation, which is what I did. The genesis of the book goes all the way back to the day she was born, the content, I should say, goes back to the day she was born. The idea to make it into a book started when she was a freshman in high school.

## Did she have any idea that you were collecting years of blogs for a book?

I never told her about the book. I surprised her the day she graduated.

# One of the chapters in the book is entitled: "Find Your Pelican of Tranquility." You said when the stresses of everyday life threaten to overwhelm you, you find peace by remembering a pelican. Can you explain that post?

I remember that day. I remember needing a mental day and going out to the beach, where there weren't many people around, sitting down, starting to feel a little peaceful. The beach has always been my happy place. I made eye contact with this pelican. I've never done that before. The pelican had little eyes, but I could tell I disappeared in the eye of that pelican. It became the focal point of meditation. My whole body just relaxed. It's almost like that pelican knew what it was doing. Eventually, it flew away. To me, the lesson there was we have it within ourselves to find peace within ourselves and sometimes we find it in some of the simplest things in the world.

# What is the one message you hope your daughter can take from your book?

I think it's to make good decisions, to know herself and to find balance in all things. That goes back to the Greek philosophers talked about know thyself and everything in moderation. I really think it's about her finding her own way in the world and using the lessons within this book as a guide along the way. I realize she'll have to make her own mistakes, and that's OK. That's how we learn. There's no experience like experience. I wanted this book to be a guide for her to help point her in some of the right direction, give her some guidance on key lessons.

# Were there influences that helped shape you before your daughter was born?

My mom taught me to think for myself. I remember I was about 11 years old and I was talking with my mom. I remember

telling her that if I ever had a tough decision in life, I would just as her. I was very close to my mother. She was a wonderful, wonderful mom. She had great common sense. I sensed that at an early age. I remember my mom saying, "What if I'm not here?" She told me she wouldn't always be here. My mom knew, even when I was very young, she would be gone one day. I didn't

fully understand that at that age. Eventually, I got it. I had to make my own decisions because my mom wouldn't be there. My mom passed almost 20 years ago. My mom was right. She wouldn't always be there. I will always be there for my daughter when I can, but there will be a time when I won't be there.

### Why is this book so important?

Hopefully this book is one small part of a legacy of something I can leave her and guide her. Hopefully she can read it now and help her guide her through life. I wrote this for her. When I published it, I thought I'd make it available to more young people. That was my audience. What I found is, people of all ages are reading it and commenting on it — even

people of retirement age are saying there are things they picked up in the book, just reminders, things they probably picked up themselves along the way.

# Local author's book seeks to help readers succeed

Dr. Robert Head wants people — especially young people — to know success is attainable even amidst disadvantage.

A lifetime in the making, Head's new book, "Playing From Behind," imparts insights gained from the local author's life experiences and what he learned along the way.

"I thought that I would, in my retirement years, document those lessons for others who might find themselves with either real or perceived disadvantages and provide for them — let's just call it a bridge," he said — a bridge, he explained, "from the dreams that they might imagine to the dreams that they might fulfill."

Part memoir, part motivational book, part self-help guide, "Playing From Behind" demonstrates how even limitations imposed by either society or self can be turned to advantage and aid the reader in realizing prosperity.

Head knows whereof he speaks. Growing up in Cleveland, Ohio, during the Civil Rights Era, he experienced racism firsthand, just as many still do today. But he didn't let that or difficult financial realities stand in the way of realizing his goal: to become the first in his family to attend college.

He went on to earn his doctorate, secure



a successful career in the banking industry and then serve two universities as president.

"One of the things that is shared in the book is that the American dream is attainable to those who are able to navigate the nuances of our society and work hard and are committed to their own personal success," he said.

The book's title was suggested by a friend after Head described his concept for the work. It reflects the central theme, which is based on a study finding that 60% of college basketball teams trailing at halftime came back to win the game.

"So, what is it about being behind early that motivates you to perform better after that?" Head asked rhetorically. "A part of it is, it does just create some higher-level motivation. Many of us have a complete fear of failure. That kicks into a higher gear for us to perform, as well."

In fact, he titled one of his chapters "Playing From Behind Can be an Advantage."

Head retired in 2016 and began writing his book two years later. It was published in March. From the start, it was clear the book would have a wider appeal than readers seeking a path to success.


Teachers, counselors and ministers are finding it useful in their work. A company in Ohio is using the book to talk about diversity with its management team and seeking ways to motivate the diverse staff. A corporate board is using it to address challenges in serving diverse populations.

That's probably because Head devotes some passages to improving leadership and understanding one another.

He hopes to hold some book signings in areas where he has lived once the CO-VID-19 situation subsides and businesses open up more.

Commissioner Henry Dean has repeatedly made motions to require face coverings throughout the county. But each time, his motion died for lack of a second.

Meanwhile, retailers have not waited for local governments to impose restrictions. Last week, Publix and Pet Supermarket joined other national chains in requiring masks for anyone stepping through their doors.

Stores that required face coverings already included The Fresh Market, Starbucks and Panera Bread. They were joined by Walgreens, Walmart, CVS and Lowe's on Monday, July 20. Home Depot followed suit on Wednesday, July 22. Target announced that it will implement its own mask mandate beginning Saturday, Aug. 1.

On Monday, July 27, Winn-Dixie Stores parent company Southeastern Grocers also began requiring customers to wear masks. In a written statement, the company endorsed action by state and national officials.

"We believe that the enforcement should be placed upon our state and federally elected officials," the statement read, "and we will continue to work with our peers in the retail industry to advocate for this sensible mandate to be passed into law to remove the burden from employers and their heroic frontline associates."

# Lending in a pandemic: A story of how 1 local industry survived

Residential mortgage financing has been impacted during the pandemic. Through no fault of our own, our community, families and careers have been affected as a result of medical concerns. However, local residential lending has overcome this challenge.

We all remember the anxiety of early March. The one-two punch of coronavirus and declining investment markets sent shudders through our lives. In one way or another, everyone was affected.

Early in the pandemic it was possible residential lending would end. Industry players asked themselves whether title attorney offices would remain open? Would appraisers be allowed access to homes? Is the bank or mortgage company operations department able to function with employees working from home? Will banks be open?

Not to mention whether federal, state or local governments would allow essential residential lending businesses to remain open, such as title companies, banks, mortgage brokers, appraisers, title insurance companies, city and county recording offices, notaries, Realtors, Northeast Florida Association of Realtors, home inspectors, builders, sub-contractors and surveyors. A long list of small, medium and large local businesses contributing to the housing market were at stake.

If one cog in the lending process stalls, it can potentially bring the entire process to a halt, further contributing to a downward spiral of the local housing market. This applies to new and existing home purchases and refinances.

Close partnership between local, state and federal leaders helped maintain the local lending industry. This approach benefitted the Ponte Vedra housing market along

with Northeast Florida and the overall state. Compared to other local and state governments that took a heavier-handed real estate shutdown approach, our market was able to sustain the early stages of the pandemic with a free market approach.

I am relieved to report the mortgage lending industry has worked through the issues it confronted early in the pandemic. It did not fold under the pressure. Subsequently, thousands of local homeowners have been able to take advantage of historically low interest rates by refinancing, lowering monthly principal and interest payments and saving money at a time when it is especially appreciated. Families relocating for work purposes to Ponte Vedra Beach have been able to purchase a home for their family, moving on with their lives and careers. Sellers have been

able to sell their homes.

How has this been possible in a safe way? Lending institutions have supported employees working from home. Loan processors, underwriters and closing coordinators are working efficiently from home. Bank branches are making appointments instead of allowing walk-ins. Drive-through banking and ATM usage has increased. Video conferencing between management, board members, customers and departments has increased. Email continues to thrive, along with texting and phone calls. The latter three forms of communication were available before the pandemic, but now are especially appreciated.

Title companies responsible for insuring mortgages have provided clear title restricted access to their offices. Only buyers, sellers and homeowners were allowed to attend the closing, reducing the possibility of exposing others to the coronavirus, while protecting their staffs.

In certain instances, drive-by appraisals are allowed instead of in-home inspections. Homeowners with special health concerns were allowed to sign waivers removing the appraisal requirement. Property inspection waivers are being granted in certain mortgage situations, saving homeowners hundreds of dollars and exposure that otherwise would be spent on the appraisal.

Back in March, the residential lending industry was in the corner, struggling to see a way forward. Resiliency, economic interests and courage won the day. Today, the Ponte Vedra Beach housing market thrives after bouncing back from fear. Mortgage lending continues with historically low interest rates. Loans are still closing. 

# SpaceX launches America's, Florida's greatness once more

On May 30, America witnessed history as we launched two astronauts beyond our atmosphere and into the stars. The excitement of new launches faded in 2010, when then-President Barack Obama retired NASA's space shuttle fleet, effectively dismantling our human space-

flight program. America leading in space would become a blip in our history. We would instead focus on a destination further off — Mars — and we would wait until 2030, nearly 40 years later, to get there.

When the decision to cut human spaceflight was announced, Neil Armstrong and many other American astronauts were quick to condemn it, urging President Obama not to leave NASA's low orbit plans and investments behind.

Without investment in rockets to send our astronauts to space, many astronauts like Armstrong feared the onceleading United States would lag in space development, ultimately resulting in an extreme delay in the mission to Mars and perhaps more concerningly, the U.S. falling

second or third to countries like Russia and China.

Despite the promise of investing millions of dollars to offset the economic impact of the Space Shuttle program's retirement, Obama's decision devastated Florida's Space Coast. Thousands of engineers, technicians and others were laid off, as their work was no longer necessary.

When President Trump took office, he pledged to revitalize the space industry and put America first, not only on this earth but in space as well. For Floridians, this is another opportunity to show our country and the world what we're capable of. Once again, we can help skyrocket our country to the leaderboard of the 21st-century space race.

May 30 marked the official launch of this great period of exploration and innovation with human spaceflight. For Floridians, this not only means a return to seeing rocket launches from our coast but also means new jobs at aerospace companies, investments in our area and economic development, which couldn't come at a more critical time.

When speaking with space program workers before the launch, Trump noted America is always in the process of transcending great challenges. We're seeing that today as our country faces challenging times, with a global pandemic and civil unrest.

"The same spirit of American determination that sends our people into space will conquer this disease on earth," Trump said. "Nothing, not even gravity itself, can hold Americans down or keep America back."

These words ring true today, now more than ever.

These launches remind us of the greatness of our country.

America — and Florida — are more than ready to meet the challenge ahead and embrace it with open arms.

# The remarkable life of Dr. Frances Bartlett Kinne

#### **By Janet Westling**

(Note: This article originally ran in Sand Castles on April 24, 2014 as Part 2 of a three-part series. Frances Kinne passed away on May 10, 2020 at 102 years old.)

"Two roads diverged in a wood, and I — I took the one less traveled by, And that has made all the difference." — Robert Frost

#### THE LONG ROAD TO CHINA

Col. Harry Kinne received his next assignment as advisor to Chiang Kai Sheik's Chinese Nationalist Army in Hankow, China. Frances left on her first transatlantic voyage from San Francisco on the General Blackford to join her new husband. The seas were rough at times, yet Frances never became sick and was able to entertain the soldiers on board with the ship's piano.

The General Blackford's first stop was Yokohama, Japan. The ship was met by a friend of Col. Kinne who gave Frances a condensed tour of Tokyo. Occupied Japan was in the throes of re-building and Frances was an eyewitness to the destruction of a former war zone.

After 22 days at sea and a brief stop in Korea, the General Blackford reached its final destination Shanghai, China.

#### **REUNITED IN SHANGHAI**

"What an amazing paradox in China," Frances said. "It is such an incongruous combination of charm and culture as well as filth and poverty."

For nine days, Harry and Frances toured Shanghai, were entertained by Maj. Gen. Sinju Pu Hsiao and, upon leaving, had no idea they would be back so soon.

Assigned to Hankow, Col. Kinne, as the senior officer, was housed in a temporary apartment located in the Norwegian consulate building with four servants and no furniture. A strike in San Francisco delayed the delivery of all their household goods including Frances' beloved piano.

China was in turmoil, challenged by communist rebels fighting to overthrow the government. Wherever Frances went she was accompanied by her "No. 1 boy," named Ching. He was assigned to protect her. Frances had hoped to lecture and attend the university just across the river, but, given the situation, that was never to

#### **ANOTHER NEVER IN OCCUPIED** COUNTRIES

Frances and Harry were instructed to never eat the local food or, as it was called, "on the economy." This meant never eating at local restaurants or buying ingredients at local shops, due to the quality of the water and threat of poisoning. American rations were scarce because Hankow was at the end of the line to receive authorized food.

Frances became sick. Because Hankow had no American doctors, Frances left for Nanking to see an American doctor who diagnosed her as anemic, gave her vitamin shots and instructed her to eat more.

#### **SHOCKING NEWS IN NANKING**

After her visit to the doctor, Frances received shocking news that all Americans were ordered to leave China. With Harry in Hankow, Frances took matters into her own hands, called a friend, a pilot stationed in Nanking, and made plans to get back to Harry instead of following orders to evacuate.

#### THE LAST BOAT FROM CHINA

The C-47 arrived in Hankow safely. With turmoil all around them, Harry and Frances packed quickly for their departure for Shanghai, at dawn the next day. Shanghai was the last bastion of defense and two weeks later Frances left on the last boat from China to Japan.

#### **GEN. MACARTHUR'S HEADQUARTERS**

Col. Kinne followed Frances to Japan and was reassigned to the G2 (intelligence) in Gen. Douglas MacArthur's staff. Frances was thrilled to be able to have the freedom once again that she did not have in China. They settled into the Imperial hotel, Harry commanded the Allied Translator Service and Frances returned to teaching at the public girls' school and Tsuda college in Tokyo.

## **BRINGING DEMOCRACY TO JAPAN**

The Japanese Ministry of Education distributed a pamphlet on the subject of democratic government and non-democratic government specifically for the returning POWs who were held for many years as laborers in the forest of Siberia.

Frances experienced her own educational journey, touching on the subject of democracy with her students. Whether Frances was talking about equality, or our republic's respect for the individual and our belief that all men are created equal, she began to develop a deep understanding of two very different cultures.

#### **RETURN TO STORY CITY**

When word reached Frances that her father was dying, she wished to return home. At first the request was denied due to military policy but Gen. MacArthur interceded with these assuring words: "Get Fran whatever she needs to get back to her father's side." She arrived in time to be at his side and see her dad's smile one last

#### THE KOREAN WAR ALMOST SIDETRACKS **FRANCES**

The return trip to Tokyo almost did not happen. When Francis arrived in San Francisco to board the ship she was told the ship was not accepting any dependents.

War was declared in Korea and the ship was filled to capacity with soldiers on their way to the Far East.

Undaunted. Frances requested to see the port commander who listened as Frances gave her pitch for troop morale and the need to entertain the troops at sea. The piano again opened the door for Frances, this time to secure a spot on a president liner where she entertained 2,000 troops for 21 days.

Upon her return, Harry was sent to Formosa to be a part of Gen. MacArthur's mission. Back in Tokyo, Frances entertained the wounded men in the Tokyo hospitals. Frances returned to her war-time field in special services as director of music and assistant entertainment director for the Far East command that included Japan, Korea, Guam, the Philippines and Okinawa.

#### **HOME AGAIN IN THE USA**

After three years in the Far East, the colonel and his lady returned to the United States as Harry had contracted a fever and was treated for a month at Walter Reed Hospital, released and assigned to the Armed Forces Staff College in Norfolk. From there they went to Fort Bragg, where Col. Kinne was a member of the Joint Tactical Air Support Board. Three years later, they left for their last assignment overseas.

#### A SECOND OCCUPATION: ASSIGNMENT **GERMANY**

The year was 1955, and the Allies had divided Germany into sectors that were occupied for the purpose of restoration. Col. Kinne commanded the 4th Armor group and one of their concerns was our ally Russia.

Located at strategic locations throughout Germany, the 4th Armor Division presented a strong military defense during the peak of the Cold War. The time spent in Germany fulfilled not only Harry's ambitions and accomplishments but Frances' as well. She continued to work on her doctorate. As the first American student in Germany following the war, she was sometimes met with

Never giving up, Frances resolved to work hard and see it through. She graduated with honors and became the first American woman since World War II to receive a doctorate in a German university. It created a lot of interest and was covered by newspapers in Frankfurt, The Army-Air Force Journal and the New York Times.

This quote appeared in a local German paper, "The Frau Doktor brings us all together in peace."

Before their return home to the states, the German American Society honored Frances with a day-long celebration. Maj. Gen. Robert Porter and his 3rd Armored Division had a review in her honor bestowing upon Frances the first honorary member of the 3rd Armored Division.

#### **MORE TO COME**

In the next Sand Castles: Harry's last assignment before retiring — as senior regular Army advisor to the Florida National Guard, and Frances heads to Jacksonville University.

# Tacos and margaritas? Yes, please!

I don't know what it is about summertime that makes me crave tacos and margaritas — it just seems like the RIGHT thing to do! Seriously, who doesn't love tacos? I'll be sharing one of my favorite shrimp taco recipes and my latest new favorite margarita — muddled blueberry-lime!

You heard me

Why are these spicy shrimp tacos so good? Aside from being absolutely delicious, they are quick! These tacos take about 25 minutes from start to finish. The shrimp is fast-cooking and the slaw is super easy to make. It's the perfect quick-and-easy weeknight meal. The shrimp is coated in a spicy seasoning before being sauteed on the stovetop. They are topped with a fresh

homemade slaw. The end result is the perfect balance of spice and zesty freshness. Lastly, these are so easy to customize. You can take this taco seasoning and literally use it to season everything from shrimp, fish, chicken, ground beef or even jackfruit for a vegan/ vegetarian spin. If you've never heard of jackfruit, don't fret as it's pretty new on the scene and I won't be using it in my recipe, but you totally could. You can make these tacos more or less spicy, depending on your tastes. You can make them gluten-free by using corn tortillas instead of flour, or grain-free by using a lettuce cup. We all know tacos are about toppings, so it's easy to add all your favorites. Think sliced avocados, pico de gallo ... whatever angle you love. Trust me, tacos are your friend!

And let's not forget about those margaritas — they are so delicious and refreshing! You can take advantage of the fresh berries in season now, or you can totally use frozen as well. Blackberries are also a perfect substitute if you prefer. I particularly love the little frozen, wild Maine blueberries in this recipe. If you happen to have some fresh basil or mint on hand, go for it. They make a delicious add-in to your muddle as well for the perfect summertime sip.

So, let's get on with it!

# BLACKENED SHRIMP TACOS WITH GARLIC CILANTRO LIME SLAW

Serves 4 (2 small tacos each)

#### **Garlic cilantro lime sauce:**

- ¼ cup avocado or olive oil
- ¼ cup water
- ½ cup chopped green onions
- ½ cup cilantro leaves
- 2 cloves garlic
- ½ tsp salt
- Juice of 3 limes
- $\blacksquare$  ½ cup sour cream or full fat Greek yogurt

#### Shrimp taco spice mix:

- 1 Tbsp. Chili powder
- 2 tsp. cumin
- 1 tsp. onion powder
- 1 tsp. garlic powder
- 1 tsp. sea salt



#### Shrimp tacos:

■ 1 lb. fresh Mayport shrimp (preferably), peeled and deveined; tails removed

■ 2-3 cups bagged or handshredded coleslaw/ cabbage

- 8 small tortillas (corn or flour)
- Avocado slices, Cotija or Mexican cheese blend, and lime wedges for serving

#### Instructions:

- For sauce: Pulse all ingredients in a food processor or blender until mostly smooth.
- Slaw: Toss some of the sauce (not all) with the cabbage. Reserve leftover sauce to drizzle on top.
- Shrimp: Pat shrimp dry with paper towels. Toss shrimp in a bowl with the spice mix to

get it coated. Heat a drizzle of oil in a large skillet over med-high heat. Add shrimp to hot pan and sauté 2-3 minutes per side until shrimp are cooked through. These are also excellent grilled 1-2 minutes per side; preferably on skewers to make cooking/flipping easier.

■ Assembly: For the prettiest and easiest-toeat assembly, go in this order: smashed avocado, slaw and shrimp. Finish with a drizzle of Garlic Cilantro lime sauce, and sprinkle with Cotija cheese.



## MUDDLED BLUEBERRY-LIME MARGARITAS

#### (Serves 2)


- ¼ cup fresh or frozen blueberries (reserve another ¼ cup for garnish)
- 1 ounce (2 tbsp.) fresh squeezed lime juice (about 3-4 limes, plus one more for garnish)
- 4 oz. Reposado or Anejo tequila
- $\blacksquare$  1½ oz. (3 tbsp.) simple syrup, or 1 tbsp. agave nectar

#### Instructions:

Rub the rim of two margarita blades with a lime wedge. Dip rims of glasses in a small pile of kosher or sea salt. Add ice cubes to classes.

In a cocktail shaker, muddle the blueberries, lime juice and a few torn mint or basil leaves if using until blueberries are crushed and infused with lime juice. Add the tequila, simple syrup or agave nectar and a handful of ice cubes. Shake vigorously for 15-20 seconds, then strain into glasses. Garnish with a lime wedge and a small cocktail skewer of reserved blueberries for a "stirrer."

however, Erin was horrified by the amount of garbage and plastic waste that regularly washed ashore in Kenya.

"As a newcomer, I became keenly aware that each country and each person needed to do something to stop not only the pollution but also the dwindling numbers of endangered species," Erin said. "I wanted to help, so I invested in my friend's company that made jewelry and small articles from used flip flops."

Eventually, she bought Ocean Sole and expanded its product line to include lifesized animals. To establish a charitable arm of the business, Erin enlisted the help and support of her family in Ponte Vedra. Sister-in-law Michelle Smith runs the Ponte Vedra Beach fulfillment studio and oversees the retail sales at Coastal Elements in Sawgrass Village as well as website sales. Erin's brother, David Smith serves as the charity's treasurer while her mother, Jackie Smith, serves as secretary.

"One million species are threatened with extinction and we are keen to raise aware-

ness to the plight of our planet," said Erin. The purpose is to raise awareness of the global ocean pollution problem by bringing beautiful colorful art and environmental cognizance to my hometown.

"For every \$20 spent with the charity," she noted, "146 pounds of trash are pulled from the ocean."

From giraffes and dragons to elephants, lions, rhinos and more, the artists employed by Ocean Sole produce bright and colorful works of art with a purpose.

"You really need to see the art pieces to appreciate what the artists in Kenya have created," Jackie Smith said. "Each piece is hand carved out of a block made of stacked flip flops, so no two pieces are the same."

Specially designed and commissioned pieces are also made.

"We have all built sandcastles on our beautiful beaches," Erin noted. "Part of their beauty is that they wash away with the tide and leave the beach untouched for the next child to build his or her dream sandcastle. Marine pollution will kill those dreams. It is up to us to protect our marine life and habitats."

# What should you do with an inheritance?

If you were to inherit a large sum of money, what would you do with it?

The question may not be hypothetical, especially if you are in the millennial, Gen X or Gen Z demographic groups. That's because the baby boomers — often referred to as the richest generation in history — are poised to

transfer some \$30 trillion in assets over the next few decades, according to the consulting firm

Of course, this is a "macro" figure, and everyone's situation is different. Furthermore, since baby boomers are living longer, more active lives, the total amount passed on may end up being considerably less than the estimate. Nonetheless, you may well receive a medium-to-large inheritance someday, and when that day arrives, you'll need to decide how best to use your newfound wealth.

Your first move may be to do nothing at all. Generally speaking, you have enough time to decide how to handle the various elements of an inheritance, although if you are inheriting an investment vehicle such as an IRA or a 401(k) plan, you will eventually have to make some decisions about liquidation or withdrawals. (And since these accounts may carry tax obligations, it's a good idea to consult with your tax advisor fairly soon after you receive your inheritance.) But if a big part of your inheritance simply consists of cash parked in a bank account, there's nothing wrong with moving the money into a cash management account at a financial services company until you decide what to do with it.

However, after some time has passed, you may want to put your inheritance to good use. If you're already working with a financial advisor, you might want to get some guidance on how to use your new assets to strengthen your existing investment strategy. Do you have any gaps in certain areas? Can you use the money to help diversify your holdings? Diversification can't guarantee profits or protect against all losses, but it can help reduce the impact of volatility on your portfolio.

# **COVID-19 impacts** hurricane preparations

Every year, county officials remind the public of the need to prepare for possible hurricanes. This year, in the midst of the COVID-19 pandemic, some new elements have been added.

Kelly Wilson, the county's interim deputy director of emergency management, spoke on storm preparation Wednesday, July 15, during a virtual meeting of the Ponte Vedra Beach Division of the St. Johns County Chamber of Commerce. She led members on a tour of the go-to website for information vital to residents and businesses.

Perhaps the biggest changes this year have been brought about by the ongoing need to remain safe from the coronavirus.

In addition to having an adequate supply of food and water for three to seven days, Wilson recommended residents have lots of soap, hand sanitizer and disposable masks.

Evacuation shelters, too, will be taking extra precautions. They will have additional hand-sanitizing and cleaning and may ask people seeking shelter to wear a facial covering.

"We are taking steps regarding our sheltering to ensure social distancing," Wilson said. "In the past, we may have opened five or six shelters. Now, we have to cut capacity in half. We're going to have to open additional shelters so we have less people in each shelter."

She pointed out that businesses can apply what they learned during the recent shut-down, when many employees had to work from home. Those same lessons can be adapted to help businesses function should a hurricane strike.

The greater portion of Wilson's presentation, however, was devoted to explaining features found on the county emergency management site.

Residents can find out if they are in an evacuation zone by clicking on the My Evacuation Zone tool. They can get information on the county's 15 shelters, including which ones are for people with special needs and which ones are pet-friendly.

The WeatherSTEM tool provides weather information in real time.

"There is actually a WeatherSTEM unit that will give you a live broadcast and feed from the South Ponte Vedra fire station, Station 9," Wilson said.

The site also allows residents to download the information-packed hurricane guide. It's also the place to go to sign up for Alert St. Johns, which replaced the Code Red system last year.

"The Alert St. Johns notification system is how we will get in touch with you," Wilson said.

Residents who sign up will receive notifications either on their phones or by text or email.

Wilson recommended residents and businesses take action now to prepare. Businesses should formulate a plan that will include such considerations as preserving documents, plans for working remotely, alternative means for access to digital data, plans to contact employees, reviewing insurance policies and protecting company vehicles.

Now is also the time to register at special-needs shelters for those who might have to go there. Residents and businesses should also consider purchasing flood insurance.



# How to plan for changing weather

The allure of the great outdoors compels many people to hike, kayak, fish and engage in myriad other activities in the fresh air. The call of nature can be difficult to ignore, but inclement weather can quickly turn a fun day under the sun into a race to escape the elements.

Regardless of which activity is beckoning you to answer the call of the wild, a few simple safety measures should be taken to ensure your day is not derailed by sudden changes in the weather.

- Do your homework prior to traveling. The Department of Homeland Security advises travelers and outdoor recreation enthusiasts to learn about potentially severe weather in areas they plan to visit prior to beginning their trip. Without a backup set of keys, outdoor enthusiasts may find themselves stranded even if their vehicles can still run.
- Create a communication plan with your family prior to leaving. A predetermined communication plan can help family members keep in touch should the weather suddenly take a turn for the worse. Before embarking on a getaway, let loved ones who won't be joining you know exactly where you will be staying and how to reach you. This can make it

easier for them to get you help should you need it.

- Monitor local forecasts. Changes in the weather can be sudden, so anyone planning to spend significant time outdoors should monitor local forecasts before and during their trips. This is especially important for travelers who will be visiting areas during certain times of year when inclement weather is normal. For example, travelers should be ready to postpone their plans if they will be visiting areas vulnerable to hurricanes during hurricane season.
- Purchase travel insurance. Insuring a trip with travel insurance can serve as a financial safety net if a trip is not possible due to inclement weather. With such a policy in hand, vacationers may not feel compelled to travel if the forecast is less than ideal.

Inclement weather can threaten outdoor excursions. But outdoor enthusiasts can take various measures to protect themselves in the face of sudden or unforeseen changes in the weather.



or FEMA, notes that it's important for parents of school-aged youngsters to familiarize themselves with the emergency response plans established by their children's schools. Such plans typically include how the school will respond if school is in session during snowstorms or natural disasters, as well as the protocol surrounding lockdown situations where children may be in danger. In such situations, knowledgeable parents who are familiar with emergency response plans and how to communicate with school officials and how those officials will disseminate information to concerned parents can help first responders and educators focus on their responses, which may involve protecting children. Knowledge of these plans also can calm parents' nerves and reduce the likelihood that school campuses will become chaotic in the wake of potentially dangerous situations, including storms or natural disasters. In addition to learning about schools' emergency response plans, parents can discuss these plans with their children. Such discussions should emphasize the importance of following educators' instructions during both practice drills and when the plans are implemented in response to disasters or other threats.







# Future of high school football season uncertain

PVHS players to report next week; conditioning to resume at Nease Aug. 3

Football players are still going to report to Ponte Vedra High on Monday through Thursday to get ready for the new season, though it isn't known when, or if, it will start.

For now, sessions include weightlifting, conditioning and basic drills.

Helmets and pads aren't allowed. Neither is close contact. Masks are required in the weight room, and each piece of equipment is sanitized on an hourly basis.

The Florida High School Athletic Association decided earlier last week to push

back the start of the fall sports season to July 27, only to change the first day of practice to Aug. 24 three days later.

The start of sports remains unsettled. Moreover, other than continued delays, there doesn't seem to be a plan for the future, Ponte Vedra High coach Jeff DiSandro said

"It is frustrating," DiSandro said. "There doesn't seem to be a plan. It's probably the right thing to do to delay the season. But there are a lot of questions."

DiSandro said there has been little discussion on how many games will be played in what's certain to be a shortened season. Will there be a new playoff format? And, most importantly, what is the protocol if a player tests positive for COVID-19?

"Right now, we can only control what we can control," DiSandro said.

Conditioning will resume at Nease High on Aug. 3, according to a post by coach Collin Drafts on the school's athletic page.

"I'm just really pleased with how hard the boys have been working, first and foremost, but how well we've been able to adapt and adjust as a football program through these trying times we're all dealing with," Drafts said.

"We've been anxiously waiting around for the Florida High School league to make the call on when the heck can we start real football. I know I'm ready for that. I know the players are, and I'm sure you guys are, too.

"Unfortunately, it's not going to be anytime soon."

Football isn't the only high school sport that's been put on hold by the coronavirus. Volleyball, swimming and diving, cross

country and boys and girls golf seasons also have been delayed.

Football teams face the most uncertainty, especially since spring practices were canceled because of the pandemic. Along with the Aug. 24 restart date came the suggestion games could start as quickly as Sept. 11.

Both coaches have used social media to keep players and parents informed of the continually changing situation. They also vowed to take every possible measure to keep the children safe.

Parents, guardians, siblings and other visitors aren't allowed on campus during practice times, and parents aren't allowed to get out of their cars when they pick up their children.

The next FHSAA board meeting is scheduled for the week of Aug. 10-17.

# Cody Carroll storms to Jacksonville Amateur golf title

University of North Florida player Cody Carroll added yet another impressive title with a birdie on the final hole to win the 59th Jacksonville Amateur Golf Championship last weekend.

Carroll closed with a 5-under 67 to finish the 54-hole tournament at 7-under 206.

Second-place Pierre Viallaneix (6-under 207) and St. Johns' Toby Ragland (1-under 212) were the only players who were under par.

The event was hosted by the Jackson-ville Amateur Golf Association at the Jacksonville Beach Golf Club. The final round of the three-day tournament was on Saturday.

"There is nothing more satisfying than finishing off a tournament with the win, especially like that," said Carroll. "I bogeyed the first hole, a sloppy bogey on 4, then I made three pars, until I rattled off four birdies in a row from [Nos.] 5 to 8 to go from four down to two up for the final couple of holes. I birdied five which I think is the toughest hole on the course."

Carroll got stronger toward the finish with a birdie on the 13th to stay one up on Viallaneix.

"I had a really nice wedge shot on 13," said Carroll. "My strategy for each hole is to execute the best shot for my ability and not let what is going on around me affect that. In four holes, I made up six shots."

Viallaneix made the finish more dramatic with two birdies before the walk to the



18th tee box. In the final hole's dramatic finish, Viallaneix took a stab at rattling Carroll with an eagle score that forced Carroll to re-strategize his approach.

"He played for the green on his drive and wound up about 30 yards short of the green on his drive then made his pitch for the eagle," said Carroll. "I had another incredibly good wedge shot to set up the putt for the win."

The tournament included three women invitees. Defending U.S. Amateur champion Gabriela Ruffels, Ponte Vedra's Hannah Stevens and Tori Mouton all failed to make the cut.

Other local players who finished among the Top 40 included: Grant Sutliff (2-over 205) in seventh, Rob Webster III (5-over 218) in 11th, Stewart Slayden (7-over 220) in 18th, Kip Webber and Michael Smith (9-over 222) in 22nd, Chris Solomon (10-over 223) in 31st and Jake Newman (20-over 233) in 40th.

Carroll has challenged himself with a series of tournaments around the country before returning to University of North Florida. With college nationwide responding to the COVID-19 situation, Carroll plans to continue his off-course fitness regimen while preparing for his junior

season at UNF.

"I've played in two pretty big amateur tournaments in Dallas and in South Carolina and the pressure of the moment was not as much as you might think," said Carroll. "The finish at the Unbridled Tour was a good confidence builder, but the Texas event was one of the biggest amateur events in the world."

Viallaneix kept pace with Carroll torrid weekend with a 71 in the first round, followed by a 66 in the second to set up the final round theatrics. Viallaneix closed with a 1-under 70 in with a traumatic double-bogie on the eighth hole that gave Carroll the opening he needed.

"He hit his drive out of bounds and had to re-hit his drive," said Carroll. "Even though it was an opportunity, I stay more aware of just adjusting my strategy to what is playing out in front of me. It's an everchanging strategy."

Carroll's third round drama seemed to make the crafty late-round veteran even more energized with a three putt on this very first hole causing some trepidation. Carroll remained four shots off Villaneix's pace after five holes before Carroll buckled up and hit the throttle with four straight putts for birdie (12-footer), par (18-footer) with two short putts making the dramatic scoreboard shift.

Carroll is the ninth UNF player to win the prestigious award since 2002. Defending champion Jordan Batchelor, also a UNF Osprey and now the UNF assistant golf coach gave Carroll his trophy.
