



Newlywed dies weeks after being struck in head by softball

Palm Harbor resident Greg Fusco died Dec. 17 after suffering from a skull fracture during a Dec. 2 softball tournament in Ponte Vedra Beach, according to a GoFundMe page created by friend Cortney Hinkle.

Fusco was on the pitcher's mound at the Davis Park baseball diamond when a batted ball struck him in the temple, knocking him unconscious. He was subsequently flown to a Jacksonville hospital, where surgery was performed. Following surgery, he was placed in the Intensive Care Unit for recovery.

Fusco and his wife had recently returned from their honeymoon, and the GoFundMe page – which has raised more than \$22,000 to date – was set up to help them with medical costs. After posting several updates that suggested Fusco might be making a recovery, Hinkle posted a notification on Dec. 17,

however, that Fusco had died early that morning.

"Today is an unfortunate day," she wrote. "There are no words to put together to even begin to start the healing process. ... Thank you to everyone for all your love, support and donations."

A funeral service was held for Fusco Dec. 28 at Curlew Hills Memory Gardens Funeral Home in Palm Harbor, and a Celebration of Life followed Dec. 30

Ponte Vedra Beach woman found guilty of DWI manslaughter, could face 15 years in prison

A Ponte Vedra Beach woman was found guilty of DWI manslaughter, reckless driving and DUI with property damage after a three-day criminal trial that ended Dec. 20. Bryan Shorstein of the State Attorney's Office of the 7th Circuit said she could face up to 15 years in prison.

Jennifer Mae Levin, who has a prior DWI on her record, was reportedly driving northbound in the southbound lane of Interstate 95 on Dec. 19, where

she crashed headon with an elderly woman traveling the opposite way in her vehicle. Levin turned off County Road 210 and started driving in the northbound lane

going under the overpass leading to southbound I-95, Shorstein said.

Shorstein noted that the 91-yearold victim, Octavie Morand, was in "excellent health" prior to the incident. Levin's blood alcohol level was a .153

According to the State Attorney's Office, the criminal scoresheet suggests a minimum sentence of 10 years and a statutory maximum sentence of 15 years. Levin will be sentenced Jan. 18 at 9 a.m. She is currently being held in St. Johns County Jail with no bond.

Jail records state she is also facing possession of marijuana and drug equipment charges. Shorstein said the state anticipates these charges will be worked out after the sentencing.

Florida man dies on New Year's Day in I-95 crash near International Golf Parkway

A 58-year-old man from North Port, Florida (Sarasota County), died on New Year's Day after losing control of his car on I-95 near International Golf

According to a report from Florida Highway Patrol (FHP), James Wayne

Clark was traveling northbound in the inside lane of 95 in his 1995 Saab 900 when he attempted to change lanes.

Clark consequently lost control, traveled off the roadway and collided with a tree located near the roadway. The crash took place at approximately 6.25 n m

He was pronounced deceased on the scene. According to the FHP report, Clark was wearing a seatbelt.

The report also states that results are pending regarding whether or not alcohol played a role in the crash.

Ponte Vedra Plastic Surgery mourns death of founding partner

Scioscia elected to extend his training to sub-specialize in cosmetic surgery by completing a one-year fellowship in aesthetic surgery at New York University's prestigious Manhattan Eye, Ear and Throat Hospital. There he trained with many of the world's most prominent plastic surgeons. He started his career 20 years ago in Jacksonville, ultimately joining Ponte Vedra Plastic Surgery as one of its founding partners.

Scioscia loved his family, traveling, golfing, cooking, spending time with his friends and caring for others. His goal was to provide his patients with the highest-quality care, in a respectful and discreet manner. Ponte Vedra Plastic Surgery – specifically, Dr. Robert Burk, Dr. Cayce Rumsey, Dr. Brett Snyder, Dr. Erez Sternberg and Dr. Hollie Hickman – has expressed a commitment to providing the same level of care to all of Scioscia's patients going forward.

CTTF reveals Ponte Vedra Beach-Palm Valley traffic study results

Support of intersection improvements and disapproval of the widening of A1A from four to six lanes are among the results of traffic surveys the Citizens Traffic Task Force (CTTF) Board revealed to residents in a recent email.

The CTTF circulated the first of its two online traffic surveys in October, collecting input on short-term improvements that can be made to various intersections in Ponte Vedra Beach and Palm Valley that would improve traffic flow and safety. A second survey was circu-

lated in mid-November asking for input on the widening of A1A and Mickler Road. Both surveys were developed by the CTTF Board to solicit feedback from area residents and businesses as a result of recommendations proposed in a recent study commissioned by St. Johns County and the North Florida Transportation Planning Organization (TPO).

According to the CTTF email to residents, a clear majority favors the intersection improvement recommenda-

tions and opposes the widening of SR A1A from four to six lanes. A slight majority, however, favors the widening of SR A1A from two to four lanes from Mickler Road to the south gate of Sawgrass Country Club.


In addition, a slight majority opposes the removal of the roundabout at CR 210 and Mickler Road. Meanwhile, a slight majority favors the widening of CR 210 from two to four lanes from the Palm Valley Bridge to SR A1A.

The CTTF Board said the two surveys

received more than 1,500 individual community responses.

The group added that the results have been shared with St. Johns County staff. According to the email, the board is scheduling a meeting in January with the North Florida Transportation Planning Organization (NFTPO) and the Florida Department of Transportation (FDOT) to present the survey results and discuss the steps necessary to achieve funding for the most critically needed improvements.

PV resident's 'Birthday Party for Jesus' reminds all of reason for the season


Each year on Dec. 25, Christians around the world celebrate the birth of Jesus Christ, but while Christmas is beloved by many, some feel that the true reason behind the holiday often gets lost among the traditions that have sprung up around it. For the past 13 years, Ponte Vedra resident Ginamarie Anthony has made it her goal to remind herself and others of the true meaning of Christ's birthday by celebrating it the same way she celebrates every other birthday—with a birthday party.

"It's been so much fun," Anthony said.
"We've had bouncy houses, a cotton candy machine, balloons and it's all about the birth of Jesus. No Santa Claus."

Held this year from Dec. 16 to Dec. 23, Anthony's "Birthday Party for Jesus" has become a Christmas tradition of its own. Each year, she invites locals to stop by her home to celebrate and drop off gifts, which she then donates to charities and families in need.

"The stipulation is that the children bring an unwrapped gift that they would like to receive themselves at their age and place it at the feet of Jesus in the manger," she explained. "They see what it's like to give, and you can see them receiving the message of it all."

While the original birthday parties were more like children's birthday parties, as

Anthony's kids have grown up, the parties have evolved into cocktail receptions where she thanks donors.

"I have five children and two beautiful grandchildren, and it has changed the way that we view Christmas," she said. "And I'm honored that people still give – that they're still doing it 13 years later."

This year, when it came time to distribute the gifts, Anthony had one particular family on her mind – that of recently deceased 13-year-old Paris Byrd.

Byrd, who was a student at Murray Middle School in St. Augustine, died Dec. 5 of an enlarged heart after becoming ill during basketball try-outs in the school's gym. Anthony, having heard the story on the news, decided to surprise Byrd's family Christmas morning with presents that had been donated to her cause.

"Meeting (Byrd's mother) was amazing," Anthony said. "She's a very strong lady, and her other children were just so grateful."

In addition to the Byrd family, Anthony said she was able to donate about \$500 worth of presents and gift cards to the Alpha-Omega Miracle Home, a shelter in St. Augustine that provides housing and support for single mothers, their children and senior women.

"You know people have a hard time, but where we are you don't expect it," Anthony said. "But it's out there right in front of us, so how do you not do something?"

For Anthony, the Christmas message she hopes to convey each year isn't rooted in gifts or traditions, but simply in showing kindness and understanding to everyone.

"There's always someone looking to do some good, and we need help right here in our own town, in our own state, in our own country," she said. "Just be kind, be open and be there for someone. You never know when you might need it in return."

Can you please briefly tell us about your background?

I was born in Jacksonville Beach and have lived in the area my entire life. After college I started working for Dr. Lewis Obi in medical practice management and have never looked back. I have had the pleasure of being the administrator for several beach practices including Dr. John Harris, Ponte Vedra Plastic Surgery and most recently 24/7 Pediatric Care Center, which is owned by my sister and her husband, Anna and Norberto Benitez.

What's the story of your company, ClaimMedic? What makes it different?

After so many years in practice management, which has included overseeing medical billing departments, I knew that medical billing can be confusing and frustrating for so many patients. My husband and I are Mayo Clinic patients, and I have personally experienced medical billing errors from their billing department several times. As a puppy raiser, you get an 8-week-old puppy and keep him/her for 10 months. The job is truly 24/7 because the puppy goes with you everywhere, so it can be socialized and taught obedience. We've taken our pups to football games, to The Masters and THE PLAYERS Championship, truly everywhere we go. When the puppy turns 1, he/she returns to the K9s For Warriors campus for his/her official service dog training, and then he/she is matched with a veteran who suffers from PTSD. Twenty-two veterans are committing suicide every day, so these pups will truly save a veteran's life. To have this amazing organization in our own backyard is such a gift to this community. I would encourage everyone to volunteer in one of the many ways available, including becoming a puppy raiser. There is currently a year-long waiting list for veterans to get a dog. The puppy program allows K9s to funnel more dogs into the program, so we can serve these warriors before it's too late. There is truly nothing better than giving back to the men and women who have given us so much, sometimes at a huge sacrifice.

What do you enjoy most about living in the **Beaches community?**

The small town feel of our area ... I love running into people I've known since elementary school in the grocery store or at the doctor's office. It's one of the many reasons this area will always be my home.



As a lifelong resident of the Beaches, what's been the most noticeable change you've observed in the community?

Traffic! As more and more people discover the beauty of our beaches, the roads have become crazy at times. But the community has been able to hang on to its small-town charm so it's worth the extra effort to get here.

What do you like to do in your free time?

My husband Steve and I are huge college football fans! We

are a house divided: He's a Gator, and I'm a happy Georgia Bulldog! I'm a two-time past president of the Jacksonville Bulldog Club, the largest Bulldog club in the nation, and I serve as president of the club's 501(c)(3) scholarship fund. I'm also a master gardener so I love to spend time in the yard. We love to travel and enjoy taking our dogs on long walks through St. Augustine, the Jacksonville Riverwalk or on one of our many beaches.

Author to discuss 'Seven Myths of the Civil War'at Ponte Vedra Library



Panera Bread files applications with county to open location in Ponte Vedra Beach

Panera Bread has filed applications with St. Johns County to open a location in Ponte Vedra Beach.

Karen Taylor, a St. Augustine land planner representing Panera, said the proposed location of the restaurant is in the Ponte Vedra Point Shopping Center, where PetSmart, Tire Kingdom and Beach Diner currently stand. The proposal and site maps indicate that the Panera will be freestanding and situated along A1A where parking is now available.

Taylor explained that the company has filed a major modification to the Fairfield at Ponte Vedra Planned Unit Development (PUD) to allow for the addition of a 3,100 square-foot "outparcel" restaurant. For the Panera to be added, the overall square footage within the PUD would need to be increased by 2,932 square feet for

a total of 77,754 square feet, or an additional 1,754 square feet beyond original approval.

According to a letter from Taylor to the county, the overall number of parking spaces would decrease from 390 to 342, which she said would still adequately cover the shopping center and the new Panera.

Taylor said Panera has also filed an architectural application concerning colors, design, landscaping, signage and building materials.

The land planner said the major modification will most likely take another six months to complete. She noted that she just recently filed the applications on behalf of Panera Bread and is waiting on the county's comments, which are due Jan. 4.

After the comments section of the process is complete, the applications will first go before the Palm Valley Architectural Review

Committee (ARC) for recommendation of approval or denial. Taylor expects this ARC hearing to take place in January. Teresa Bishop, planning division manager for the Growth Management Department of St. Johns County, said that timeline is probably optimistic. She thinks the ARC hearing will take place in February.

Following the ARC review, the applications will go before the Planning and Zoning Agency (PZA) for recommendation of approval or denial and then the Board of County Commissioners (BCC) for final deliberation. Bishop estimated that these hearings will occur in the spring or early summer of 2018.

If the applications are ultimately approved, Taylor estimates that construction will start in late 2018, with completion targeted for spring of 2019.

The subject of how much we should spend on our military budget has always been a hotly debated topic. In fact, the subject in question has been buffed.

billion for fiscal year 2017 (September). How about this fact? Our military spending is more than the next eight countries combined. Yep, sip on that one for a while, swirl it around, do not spit it out. Savor the taste. Incredible, is it not?

I put forth that there are usually at least two sides to every issue. Moreover, folks on each side believe in the deepest recesses of their souls that they are right. For example, looking at how much we should spend on military defense, if we spend too little, our adversaries may be encouraged to exploit our weaknesses, costing us to lose more soldiers along with potentially giving up our position as the world's best military. To the contrary, if we invest too much in our defense spending, the misallocation of resources will add to our national debt and possibly place us in an adverse financial position.

Yes indeed, it is a difficult balance to accomplish, which is why I suggest we apply The Goldilocks Principle to this remarkable, problematic issue. For those of you not familiar with the well-known children's story, "The Story of the Three Bears," there was a little girl named Goldilocks that tasted three different bowls of porridge, and she finds that she prefers porridge that is neither too hot nor too cold but has just the right temperature.


In other words, let's not spend too much or too little, but just the right amount. Sure, that's easy in theory but incredibly difficult, which is why this topic is often contested. Nevertheless, look at the chart on the right provided by Stockholm International Peace Research Institute (SIPRI).


Vet hospital plans to join Shoppes at Palm Valley

A new veterinary hospital is looking to join the growing list of businesses at the Shoppes at Palm Valley.

The Palm Valley Vet Hospital has applied with St. Johns County for a non-zoning variance to add 6,735 square feet of space to the existing 2,988 square feet of existing space previously occupied by Mercantile Bank.

The application also seeks to demolish portions of the bank and to install new parking and landscaping at the property located at 3783 Palm Valley Road. The request for the non-zoning variance also seeks to "allow for the length of a building parallel, or within 45 degrees parallel, to exceed the 120-foot maximum."

Kim Del Rance, from the St. Johns County Planning and Zoning department, said the vet hospital is awaiting an architectural review, and may also require a zoning variance based on the way the building is situated.

"We actually have someone in the group who isn't currently actively working," Moore said. "She calls herself the 'CEO of her family,' and she just comes to be energized and inspired."



Florida Airbnb hosts earn \$450M, welcome 2.7 million guests in 2017

Company earns \$8.8 million, welcomes 64,800 quests in St. Johns County

Airbnb recently announced that its Florida vacation rental hosts earned a combined \$450 million in supplemental income while welcoming approximately 2.7 million guests to the state in 2017.

St. Johns County comes in at No. 12 on the company's list of top 20 counties in Florida in terms of guest arrivals, earning \$8.8 million and welcoming 64,800 guests

The 2.7 million total guests to Florida represent 75 percent year-over-year growth. There are now nearly 40,000 Floridians who share their homes or vacation rentals through Airbnb, with each host typically earning about \$6,700 annually.

Airbnb said statewide data indicates that the vacation rental community is complementing — rather than competing with – the Florida hotel industry. The company said Florida hotels experienced strong growth in occupancy rates, prices and revenue dur-

ing 2017 — in parallel with vacation rental growth for the year. Airbnb says this suggests that vacation rentals on the company's website and other platforms are opening the state to a new demographic of tourists by catering to travelers who are less able to afford hotels. those who desire to stay in neighborhoods or cities that lack hotels and families who prefer to vacation together under one roof.

In addition to the new personal income going into the pockets of Florida hosts, Airbnb said the vacation rental community is also generating new public revenues that benefit the state and dozens of local communities through tax agreements that allow the company to collect and remit taxes on behalf of its hosts.

Airbnb is currently authorized to collect and pay the state sales tax on all bookings in Florida, in addition to collecting and paying local bed taxes in 39 counties. In 2017 alone, Airbnb said it secured new tax agreements with six counties: Miami-Dade, Broward, Sarasota, Polk, Hillsborough and Leon. The company will release a 2017 county-bycounty tax report once the December taxes are remitted.

St. Augustine Film Festival to kick off new year on First Coast

The 8th annual Saint Augustine Film Festival, which will bring dozens of foreign and independent films to the First Coast, will be held Jan. 18-21.

Film buffs can see over 36 films in advance of wider distribution, or foreign films that may never be seen outside of their country of origin except in a film festival environment.

Jacksonville Symphony to present 'Symphony in 60' and Masterworks concerts Jan. 4-6

The first week of January brings the second "Symphony in 60" of the season, as well as the fifth Masterworks concert for the Jacksonville Symphony after a month-long hiatus for the holidays.

The Symphony in 60 concert will begin at 6:30 p.m. on Jan. 4 at the Times-Union Center for the Performing Arts in Jacoby Symphony Hall in Jacksonville. For the Symphony's two upcoming Masterworks performances, Lewis will be joined on stage by guest pianist Zhang Zuo. Zuo, who will also host a free piano masterclass Jan. 4 from 1:30 to 3:30 p.m. at the Time-Union Center for the Performing Arts, has been hailed as "full of enthusiasm and glamour, radiating the vigor of youth," (Chinese Gramophone) and "a powerful, passionate and compelling representation of pure artistry," (Los Angeles Times).

Nonetheless, the Concert Hall added, Candlebox unwittingly helped usher in the post-grunge era; along with Bush, the band showed how the more challenging aspects of grunge could be ironed out and polished into a sound that mainstream rock radio could embrace without reservation.

Candlebox was formed in Seattle in December 1991 by

singer/guitarist Kevin Martin and drummer Scott Mercado. Initially calling the band Uncle Duke, they added lead guitarist Peter Klett and bassist Bardi Martin (no relation to Kevin) and changed the group's name to Candlebox, after a line in a Midnight Oil song. Their demo tape found its way to Madonna's Maverick label, which quickly resulted in a record deal in 1992.

Candlebox's self-titled debut was released in 1993, and while the first single, "Change," began to build them a following, it wasn't until 1994 when the follow-up, "You," appeared, that Candlebox really started to take off. "You" gave the band a breakthrough hit on mainstream rock radio, which set the stage for the success of "Far Behind." "Far Behind" was a major hit on both mainstream and alternative radio, and also made the pop Top 20; its exposure helped Candlebox climb into the Top Ten on the LP chart and eventually sell over three million copies.

Candlebox returned in 1995

with their second album, "Lucy," and the lead single, "Simple Lessons," which earned some rock radio airplay, and the album itself went gold but barely missed the Top Ten. In 1997, founding member Mercado left the band and was replaced by original Pearl Jam drummer Dave Krusen. Candlebox's third album," Happy Pills," appeared in 1998 and marked a return to the more basic sound of the band's debut. "It's Alright," "10,000 Horses," and the title cut all landed some radio airplay. Krusen departed in 1999, as did Bardi Martin; they were replaced by Shannon Larkin and Rob Redick, respectively, but the group disbanded the following year.

The original lineup of Martin, Klett, and Mercado re-formed for a handful of shows in 2006 to support the release of Rhino's Best of Candlebox compilation. The overall positive reunion stirred rumors of a new studio album, culminating in 2008's "Into the Sun." In 2012, the band inked a deal with AudiNext/Fontana, who released their fifth studio

album, "Love Stories and Other Musings." In 2015, Klett and Mercado announced they were leaving Candlebox to devote more time to their other project, Lotus Crush. A few months later, Kevin Martin and Krusen unveiled a new edition of the band, featuring new guitarists Mike Leslie and Brian Quinn, and bassist Adam Kury. This lineup went into the studio to record a new album, and "Disappearing in Airports" was released in April 2016.

Since releasing its first LP, "No Bounds," in 2014, the Concert Hall said State to State has established itself in Los Angeles as flag bearers of atmospheric rock, a landscape forged by bands like Radiohead and Interpol. The band has played sold out shows at the

Troubadour, as well as residencies at The Hotel Cafe and The Viper Room. July 29, 2017 found the band at the world-famous Roxy Theater in Hollywood with a sold-out crowd for the release of its new single, "The Shifter," from the upcoming EP, "Clearlake Sessions." Since its release, "The Shifter" has received national airplay from major radio stations all over the U.S. and climbed the charts of LA's KROQ's Locals Only Countdown all the way to No. 1.

Doors for the show in Ponte Vedra open at 7 p.m., with the show starting at 8 p.m. Tickets will be available for purchase at the Ponte Vedra Concert Hall and St. Augustine Amphitheatre Box Offices, ticketmaster.com and by phone at (800) 745-3000.






